## COMBINED SYNOPSIS/SOLICITATION

This is a combined synopsis/solicitation for a commercial item prepared in accordance with the format in FAR Subpart 12.6 and 13.106, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; quotes are being requested and a separate written solicitation will not be issued.

This solicitation is issued as a request for quote (RFQ). The RFQ will be submitted through fedbizopps.gov on RFQ reference number VA242-17-Q-0629.

This solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular 2005-89.

This procurement is being issued as a Service Disabled Veteran Owned Small Business set aside requirement. The North American Industry Classification System (NAICS) code is 541620, with a small business size standard of \$15 million. **This solicitation is 100% set-aside for Service Disabled Veteran Owned Small Business.**

The Contractor shall provide all items as described in the attached Statement of Work (SOW).

### **Description of requirement:**

Contractor to provide all parts, labor, tools, materials, transportation supervision to perform quality assurance/project monitoring, air monitoring, and (ACM) testing during ACM removal. The contractor shall provide the items in the Statement of Work (SOW).

Awardee shall be prepared to start within 10 days after award.

(2) Any system that conforms to the X12 electronic data interchange (EDI) formats established by the Accredited Standards Center (ASC) and chartered by the American National Standards Institute (ANSI). The X12 EDI Web site (<http://www.x12.org>) includes additional information on EDI 810 and 811 formats.

(d) Invoice requirements. Invoices shall comply with FAR 32.905.

(e) Exceptions. If, based on one of the circumstances below, the contracting officer directs that payment requests be made by mail, the contractor shall submit payment requests by mail through the United States Postal Service to the designated agency office. Submission of payment requests by mail may be required for:
