B.2 STATEMENT OF OBJECTIVES (SOO)

(a). **PURPOSE:** Provide commercial parking lot services for the St. Louis VA Medical Center, St. Louis, Missouri.

(b). **SCOPE:** The Dept. of Veterans Affairs, St. Louis VA Medical Center, John Cochran Division, 915 Grand Blvd., St Louis MO 63106-1621, has a requirement to contract for non-reserved commercial parking spaces for use by VA Medical Center personnel.

(c). **PERIOD AND PLACE OF PERFORMANCE:**

(1). The government anticipates awarding a firm-fixed-price contract for a base period of one (1) year with four (4) one (1) year option periods.

(2). All parking spaces must be located within a walking distance of 915 Grand Blvd., St Louis MO. The boundaries would be approximately:

North Boundary: Bell Avenue
 East Boundary: North Compton Ave
 South Boundary: Lindell to Olive Streets
 West Boundary: Vandeventer Ave

(3). Parking spaces will be required daily, Monday through Friday, during the work hours of 6:00am through 7:00pm. Weekend and federal holiday access may be required, at no additional cost.

(d). **BACKGROUND:** The Dept. of Veterans Affairs (VA), St. Louis VA Medical Center, John Cochran Division, has a requirement to furnish parking spaces for employees of the facility. Contract VA255-15-C-0054 presently furnishes three-hundred and fifty (350) spaces in the Scottish Rite Parking Garage, 3634 Olive, St. Louis Mo. The garage is located within walking distance of the facility. The contract is presently due to expire 2/28/2017 but at the option of the VA it may be extend for up to an additional five (5) months. The Government Services Administration (GSA) has certified that they do not have parking spaces available in the area of the office and has authorized the facility to contract for the required commercial parking space as a service. The VA therefore desires to enter into a services contract for the furnishing of non-reserved parking spaces to provide parking for VA Medical Center personnel.

(e). **PERFORMANCE OBJECTIVE:** The contractor is to furnish non-reserved commercial parking spaces for use by non-specified VA personnel.

(1). Parking spaces can be located in an open parking lot or in a parking garage or a combination of the two.

(2). Approximately three-hundred and fifty (350) parking spaces will be required. The parking spaces will be required for use by authorized and identified government personnel and non-VA care staff. The contractor should have an entry/exit process that allows entry and exit of the lot for specified individuals at no cost to the individual. The permits providing access to the lot will instead be paid for through this contract with the VA.

(3) It is anticipated that VA will provide the Contractor with written authorization identifying personnel who are authorized to utilize the service. Authorizations will be updated periodically to accommodate new authorized personnel and delete personnel who are no longer authorized. Each authorized individual will personally go to the Contractor's parking garage office, provide identification, and will be issued a parking garage access device. The device will provide access to the parking garage until the VA provides the Contractor with notice that the individual should no longer be provided access or the expiration or termination of the contract.

(4). It is preferable that all spaces be located and grouped in one of the following configurations: in a single lot; as a block unit in a larger lot; as one block unit in each of two lots separated by a street, but not a thoroughfare trunk street, and of no more than four lanes, immediately adjacent to each other across the separating street.

(5). Failure to provide parking space for the 350 permits each day, on a recurring basis, will be considered a default under the terms of this contract.

(5). A covered shelter that can accommodate a minimum of thirty (30) persons should be available on the parking property or adjacent to a shuttle bus pickup point.

(2) Payment. Payment for all parking spaces will be invoiced at the contracted amount monthly in arrears.

The Government may require continued performance of any services within the limits and at the rates specified in the contract. (3) [] Are, [] are not presently indicted for, or otherwise criminally or civilly charged by a Government entity with, commission of any of these offenses enumerated in paragraph (h)(2) of this clause; and

(4) [] Have, [] have not, within a three-year period preceding this offer, been notified of any delinquent Federal taxes in an amount that exceeds \$3,500 for which the liability remains unsatisfied.

(i) Taxes are considered delinquent if both of the following criteria apply:

(A) *The tax liability is finally determined.* The liability is finally determined if it has been assessed. (D) The taxpayer has filed for bankruptcy protection. The taxpayer is not delinquent because enforced collection action is stayed under 11 U.S.C. 362 (the Bankruptcy Code).
