

This is a SOURCES SOUGHT NOTICE for market research purposes only to determine the availability of potential businesses with capabilities to provide maintenance and training on the chiller plant equipment located at C.W. Bill Young VAMC and the Lee County Healthcare Facility as described in the draft performance work statement that is attached below. Responses will be used to determine the appropriate acquisition strategy for a potential future acquisition.
