B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes FAR 52.219-6 Notice of Total Small Business Set-Aside. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Furthermore, if VA determines any services the support contractor(s) will perform in assessing compliance are advisory and assistance services as defined in FAR 2.101, Definitions, the support contractor(s) must also enter into an agreement with the contractor to protect proprietary information as required by FAR 9.505-4, obtaining access to proprietary information, paragraph (b). B.3 Performance Work Statement

PERFORMANCE WORK STATEMENT FOR GUARD SERVICES CONTRACT

1. GENERAL:

The Fayetteville VA Medical Center, is a division of the United States Government's Department of Veterans Affairs (VA), and has a requirement for healthcare resources to be furnished by a Contractor. Police Services required are to provide for security guards at the Fayetteville VA Medical Center, Fayetteville, VA. The Contractor shall provide services to the medical center in accordance with the requirements herein. The services to be performed by the Contractor shall be under the supervision of the VAMC Police Service Chief in conjunction with the Office of the Director.

1.1 SERVICES REQUIRED:

- 1.1.1 Contractor shall furnish all personnel, equipment, supervision, and supplies necessary to provide unarmed security guard services, except Government Furnished Properties at the Department of Veterans Affairs Medical Center, located at 7300 S. Raeford Rd, Fayetteville, NC. The contractor's employees must be present at the VA facilities and must perform the required services to obtain payment under this contract. Services provided under this contract are subject to the Privacy Act.

Contractor shall provide the following services listed below:

Contractor shall provide security guard services as indicated in section 1.11 schedule/duty/tour. Contractor's personnel who are employed under this contract shall have been approved by the Point of Contact. Approval shall be based on meeting the qualification standards in the contract, plus other background information obtained regarding the individual which attests to his/her fitness for the required duty.

1.2 PLACE OF PERFORMANCE:

1.3 CONTRACTOR MANAGEMENT

- 1.3.1 The Contractor shall manage the total work effort associated with the guard services required herein to assure fully adequate and timely completion of these services. Included in this function will be a full range of management duties including, but not limited to, planning, scheduling, report preparation, establishing and maintaining records, and quality control. The Contractor shall provide an adequate, qualified staff of guard personnel with the necessary management expertise to assure the performance of the work in accordance with sound and efficient management practices.
- 1.3.2 Perform unannounced inspections of their contract guard performance for each work shift. The Point of Contact may determine specific inspection times, as required.

1.4 PERSONNEL:

- 1.4.1 **Guard:** Contractor shall provide security guards who work from assigned fixed post and/or conducts roving patrols of facilities, grounds, and out buildings. General duties are specified in this contract. Each security officer shall have a background with a minimum of two (2) years of successful experience in security/ law enforcement, military service law enforcement, or security, commercial or industrial guard service or security.
- 1.4.2 **Guard Duties:**
- A. Conducting identification card checks at entry control points.
 - B. Verify that individuals(s) possess valid authorization or reason for entering facility property per locally established guidelines. Customers may be staff, patients, visitors or VIPs.
 - C. Follows all VA guidelines, Standard Operating Procedures and Medical Center Memorandums.
 - D. Provides directions to visitors
 - E. Reports suspicious activity to the VA Police
 - F. Receives and applies instructions during normal and special awareness operations, to include methods of observing and identifying persons and suspicious activity.
 - G. Conducts routine foot patrols of designated areas on Hampton VAMC property when appropriately assigned.

1.5 Minimum Qualification Standards

Eligibility: To be eligible to perform under the terms of this contract, each contractor employee shall meet, to the satisfaction of the point of contact, the following education, experience, health, and security requirements. Suitable experience may have been gained as a continuous uniformed officer of the contracting agency, other licensed, bonded agencies of like business, federal, state, or municipal police agency, or military service (guard or police series).

Education/Experience: Must possess a high school diploma or equivalency, and have two (2) years of experience demonstrating the ability to meet and deal with the general public; the ability to read, understand and apply printed rules, detailed orders, instructions, and training materials; the ability to identify suspicious activity and persons; and the ability to construct and write clean, concise, accurate and detailed reports.

Age: All contracted employees performing work under this contract shall have a minimum of twenty one (21) years of age as required by local laws.

License: Contractor shall furnish to the Contracting Officer proof that he/she is licensed and bonded as required by the State of Virginia for doing business as a contract security company.

Personal Traits: The Contractor shall ensure that contract staff assigned to duties at Hampton VAMC will be expected to:

- A. Exercise good judgement
- B. Interact with people in a positive manner
- C. Maintain a high level of performance
- D. Maintain poise and self-control under stress
- E. Meet and interact with the general public

1.6 Medications (Prescribed, Non-Prescribed, Intoxicants):

The Contractor shall ensure that while on duty no contract employee will possess, sell, consume, or be under the influence of medications, intoxicants, drugs, or substances which impair the ability to perform their assigned duties. The Government reserves the right to direct the Contractor to remove an employee from the work site for failure to comply.

1.7 Random Drug Testing:

The Government may require a maximum of two (per year) Contractor-conducted random drug tests for all contracted employee under this statement of work. The results will be submitted to the Point of Contact.

1.8 HEALTH AND PHYSICAL FITNESS REQUIRMENTS:

All employees assigned by the Contractor to work under this contract shall be physically able to perform all general duties, functions, and activities; shall be free of any communicable disease; shall be in good general health without physical defects or abnormalities which would interfere with the performance of these duties; shall possess binocular vision correctable to 20/20; shall be free of color blindness, and be capable of hearing ordinary conversation at 15 feet with either ear without benefit of a hearing aid.

Each employee shall be given a physical examination without cost to the Government or employee, and medical certification attesting to the final results of this examination shall be furnished to the Contracting Officer on Optional Form 178, at least five days prior to assignment of the employee to duty.

1.9 CONTRACTOR FURNISHED PROPERTY AND SUPPLIES:

The Contractor shall furnish and maintain in acceptable condition, all items of uniform and equipment necessary to perform work required by this contract, as discussed in this paragraph.

Uniforms:

Appropriately lettered breast badges, indicating the employee is a security guard, shall be worn as part of the uniform. Shoulder patches lettered to indicate the identity of the contractor shall be worn on the left shoulder of the uniform blazer, jacket and shirt. Identification nametags and PIV identification shall be worn over the right breast jacket, blazer and shirt pocket. No other identification of the contractor or employee shall be worn or displayed on the uniform.

Approved uniforms and related accessories, listed below, do not have to be new but must be in good condition:

- A. Shirt, long sleeve
- B. Shirt, short sleeve
- C. Trouser, all season weight
- D. Necktie (to be worn with long sleeve shirt or short sleeve shirt, when worn with blazer)
- E. Jacket, winter, heavyweight artic field coat
- F. Jacket, lightweight
- G. Blazer
- H. Gloves, (pair), (color to match accessories)
- I. Flashlight, 2 "Lithium photocell", size 123, "Surefire"
- J. Flashlight holder, secured to trouser belt.
- K. Radio case
- L. Insignia, shoulder patch (each shirt and jacket)
- M. Nameplate, 3 1/2" x 3/4", black 1/2" lettering on silver metal (brushed or stainless)

The long and short sleeve shirts will be required at the contractor's discretion.

The uniform shall only be worn when the officer is on official duty or when the officer is in transit between his/her place of residence and duty station.

Shoes shall be low quarter or high topped lace type with police or plain toe and standard heel. The color of the shoe shall match the color of leather equipment accessories. Any deviation from the above requirements must be approved by the Point of Contact and the Chief of Police Services.

The color of uniform accessories and equipment shall be standard black and brown, as may be appropriate to match the uniform.

Inclement weather clothing shall be required for all guards required to perform duties while exposed to cold, rain, and other inclement weather conditions. All inclement weather clothing must be identical in style and color for each guard.

NOTE: No guard may enter on duty without wearing the proper uniform (including PIV card/badge).

Each guard on duty shall be equipped with supplementary equipment including, but not limited to, notebooks, pens, pencils, replacement flashlight batteries and bulbs, as appropriate to operations. Guards shall not be permitted to provide themselves with any unauthorized supplemental, personal items, or other non-standard items.

Contractor's guards shall NOT be permitted to provide themselves with any unauthorized supplemental or personals, such as either concealed firearms, knives, or such other non-standard items, considered as illegal or unauthorized on Department of Veterans Affairs property.

Weapons Prohibited: The contractor shall not possess any concealed or unconcealed firearms, mace, knives, "come along" night sticks or any other auxiliary, non-standard items. No person entering or while on property shall carry or possess firearms or other dangerous or deadly weapons. Exception- Personnel from authorized law enforcement agencies.

1.10 GOVERNMENT FURNISHED

- 1.10.1 The VA Medical Center will provide orientation and training on VA policies and procedures. All security contractors will be required to attend a facility orientation program on safety and emergency procedures. This training will be scheduled at the kick off meeting at a mutually agreeable date. VA specific training and orientation must be completed by each employee after award and prior to commencement of any work.
- 1.10.2 All post furniture will be provided by the Department of Veterans Affairs.
- 1.10.3 All communication equipment will be provided to each post.

1.11 SCHEDULE/ DUTY/ HOUR:

Security Services covered by this contract shall be furnished by the Contractor as specified herein. Services are required seven (7) days per week from 0800AM – 0800AM including weekends and National Holidays. The Fayetteville VA Medical Center reserves the right to change this requirement to fit the needs of clinic operations.

The following terms have the following meanings:

National Holiday: All work required under this contract shall be performed as provided in the Security & Patrol Services Schedule. Deviations from the work schedule shall require prior written permission from the COTR. The following is a list of the *Federal holidays:

- New Year's Day
- Washington's Birthday
- Martin Luther King's Birthday
- Memorial Day
- Independence Day
- Labor Day
- Columbus Day
- Veterans Day
- Thanksgiving Day
- Christmas

Entrance Control Post. Operate and enforce a system of personnel identification. Direct patients/visitors to sign in with reception. Perform package inspection when directed to do so.

Building Rules and Regulations. Observe building occupants and visitors for compliance with posted rules and regulations.

Unauthorized Access. Report any persons attempting to gain unauthorized access to the property.

Hazardous Conditions. Immediately report potentially hazardous conditions and items in need of repair, including inoperative lights, leaky faucets, toilet stoppages, broken or slippery floor surfaces, etc., to Central Dispatch. Take immediate action to prevent injury of patients or staff (use safety cones to block area and direct activity around the hazard, etc).

Injury or Illness. Obtain professional assistance in the event of injury or illness to Government employees, Veterans, or others while in the building or on the grounds. Render First Aid and/or CPR in emergency situations and assist medical and law enforcement personnel as appropriate.

Additional Duties. Turn off unnecessary lights, check safes (if applicable), lock type repositories, and cabinets, close windows, open and secure doors and gates, etc.

Reports and Records. Prepare reports as required/directed by the Point of Contact including but not limited to incident and daily monitoring checklists (to be provided to contractor upon award). Maintain necessary records. As necessary, turn reports and records in to designated official.

Civil Disturbances. Perform such other functions as may be necessary in the event of situations or occurrences such as civil disturbances, attempts to commit espionage, sabotage, or other criminal acts adversely affecting the security and/or safety of the Government, its employees, property, and the general public, lawfully in buildings or on the grounds under the control of the Government.

Contractor will facilitate the majority of the meal and rest breaks. VA Police will provide additional breaks as they arise.

Meals will not be consumed on post.

Once the individual is on duty, the individual may not be permitted to leave their post until properly relieved by another contractor or VA Police Officer.

A record keeping system of Contractor's hours worked.

1.12 CONTRACTOR PERSONNEL AND SUB-CONTRACTOR PERSONNEL SECURITY COMPLIANCE REQUIREMENTS:

All contractor employees who require access to perform services the Department of Veterans Affairs Medical Center, 7300 S. Raeford Rd, Fayetteville, NC shall be the subject of finger printing by Police Service for the purpose of badging suitability. This requirement is applicable to all subcontractor personnel requiring the same access. **Finger printing will be conducted upon award of the contract. Depending on the results of the fingerprinting, a background investigation may be necessary.**

Contractor Responsibilities:

The CONTRACTOR shall ensure that continuous coverage is maintained during shift changes. Under no circumstances, will there be a total absence of service personnel during the hours covered by this CONTRACT.

Post Orders:

Within fifteen (15) Days of the Effective Date, Contractor shall deliver to the Point of Contact drafted comprehensive Post Orders for **all designated Sites** for review and approval. The Point of Contact shall review and return same to Contractor with instructions for revisions.

Post Orders shall include, but are not limited to:

- A. General Safety Procedures
- B. Emergency Procedures (including contact lists)
- C. Incident and Emergency Report Procedures and Forms
- D. Shift Patrol Procedures
- E. Communication Procedures
- F. Dress and Grooming Standards
- G. Training Procedures including harassment training
- H. Photographs and diagrams of each Site.
- I. Human Resources Policies and Hiring and Disciplinary Procedures

Key Control:

The contractor shall receive, secure, issue and account for all keys/access cards issued for access to buildings, offices, equipment, gates, etc. for the purposes of this contract. Prior to starting work, the Contractor shall sign a receipt for all keys issued by the Government. The Contractor

shall maintain records which show how many keys are in existence and who had access to the keys. These records shall be made available to the Point of Contact or any other Government Investigative Authority upon request. Keys shall not be duplicated or leave the facility.

The contractor shall prescreen all personnel requiring access to the VA Medical Center.

In order for all Contractors to engage in work at the VA, Contractors are required to complete a mandatory training program titled VA Privacy and Information Security Awareness Training, Rules of Behavior and sign VA Handbook 6500-Appendix G- Department of Veterans Affairs (VA) National Rules of Behavior before computer access is granted.

Reserve Personnel (Back-up Staff): Prior to commencement of work on this Contract, the Contractor is required to submit to the Point of Contact, the names and all necessary documentation of at least (four) fully trained and qualified personnel who will be used in a reserve capacity (e.g. to replace guards on scheduled or non-scheduled sick leave or vacation, to respond to emergency service, or similar situations), for approval via email or fax to the Point of Contact.

Recall System: The Contractor shall provide an employee recall system with the capability of contracting and recalling off duty personnel up to two per shift. Personnel shall be on-site within (1) hour of the Contractor's receipt of the Point of Contact recall authorization. Situations which may result in recalls include riots, civil disturbances, or other large gatherings of people where, in the opinion of the Government, a threat exists to life and property, and active shooter. The Point of Contact will notify the contractor for additional personnel as required.

SECTION C - CONTRACT CLAUSES

ADDENDUM to FAR 52.212-4 CONTRACT TERMS AND CONDITIONS—COMMERCIAL ITEMS

C.1 52.252-2 CLAUSES INCORPORATED BY REFERENCE (FEB 1998)

(C) In SAM, such additional information as the Offeror deems necessary to demonstrate its responsibility, including mitigating factors and remedial measures such as offeror actions taken to address the violations, labor compliance agreements, and other steps taken to achieve compliance with labor laws. Offerors may provide explanatory text and upload documents. This information will not be made public unless the contractor determines that it wants the information to be made public; and

(D) The information in paragraphs (s)(3)(i)(A) and (s)(3)(i)(C) of this provision to the Contracting Officer, if the Offeror meets an exception to SAM registration (see FAR 4.1102(a)).

(ii)(A) The Contracting Officer will consider all information provided under (s)(3)(i) of this provision as part of making a responsibility determination.

(B) A representation that any labor law decision(s) were rendered against the Offeror will not necessarily result in withholding of an award under this solicitation. Failure of the Offeror to furnish a representation or provide such additional information as requested by the Contracting Officer may render the Offeror nonresponsible.

(C) The representation in paragraph (s)(2) of this provision is a material representation of fact upon which reliance was placed when making award. If it is later determined that the Offeror knowingly rendered an erroneous representation, in addition to other remedies available to the Government, the Contracting Officer may terminate the contract resulting from this solicitation in accordance with the procedures set forth in FAR 12.403.

(4) The Offeror shall provide immediate written notice to the Contracting Officer if at any time prior to contract award the Offeror learns that its representation at paragraph (s)(2) of this provision is no longer accurate.

(5) The representation in paragraph (s)(2) of this provision will be public information in the Federal Awardee Performance and Integrity Information System (FAPIIS).

Note to paragraph (s): By a court order issued on October 24, 2016, this paragraph (s) is enjoined indefinitely as of the date of the order. The enjoined paragraph will become effective immediately if the court terminates the injunction. At that time, DoD, GSA, and NASA will publish a document in the **Federal Register** advising the public of the termination of the injunction.

(t) *Public Disclosure of Greenhouse Gas Emissions and Reduction Goals.* Applies in all solicitations that require offerors to register in SAM (52.212-1(k)).

(1) This representation shall be completed if the Offeror received \$7.5 million or more in contract awards in the prior Federal fiscal year. The representation is optional if the Offeror received less than \$7.5 million in Federal contract awards in the prior Federal fiscal year.

(2) Representation. [Offeror to check applicable block(s) in paragraph (t)(2)(i) and (ii)]. (i) The Offeror (itself or through its immediate owner or highest-level owner) [] does, [] does not publicly disclose greenhouse gas emissions, i.e., makes available on a publicly accessible Web site the results of a greenhouse gas inventory, performed in accordance with an accounting standard with publicly available and consistently applied criteria, such as the Greenhouse Gas Protocol Corporate Standard.

(ii) The Offeror (itself or through its immediate owner or highest-level owner) [] does, [] does not publicly disclose a quantitative greenhouse gas emissions reduction goal, i.e., make available on a

publicly accessible Web site a target to reduce absolute emissions or emissions intensity by a specific quantity or percentage.

(iii) A publicly accessible Web site includes the Offeror's own Web site or a recognized, third-party greenhouse gas emissions reporting program.

(3) If the Offeror checked "does" in paragraphs (t)(2)(i) or (t)(2)(ii) of this provision, respectively, the Offeror shall provide the publicly accessible Web site(s) where greenhouse gas emissions and/or reduction goals are reported:_____.

(u)(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235) and its successor provisions in subsequent appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(2) The prohibition in paragraph (u)(1) of this provision does not contravene requirements applicable to Standard Form 312 (Classified Information Nondisclosure Agreement), Form 4414 (Sensitive Compartmented Information Nondisclosure Agreement), or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(3) Representation. By submission of its offer, the Offeror represents that it will not require its employees or subcontractors to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting waste, fraud, or abuse related to the performance of a Government contract to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information (e.g., agency Office of the Inspector General).
