

**Justification and Approval

1. Contracting Activity: Department of Veterans Affairs, VISN 23, VA BHHCS, Facilities Management service. Justification for Other Than Full and Open Competition for Project 568-12-117, Site Prep for Robotic Pharmacy. Estimated Cost: \$60,000.00.

2. Nature and/or Description of the Action Being Processed: The proposed action would provide a turn-key installation of purchased robotic pharmacy tug system equipment from the vendor, Aethon.

3. Description of Supplies/Services Required to Meet the Agency's Needs: The proposed supplies /services include installation of necessary equipment and systems (i.e. mounting cabinets, wireless nodes to support communications, providing all elevator interfaces, door interfaces, door operators) to have a complete and functional pharmacy tug system on the Fort Meade campus.

Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority): The designated vendor, Aethon, as the equipment supplier has the knowledge of its robotic control needs in terms equipment locations, connectivity and protocols, required interfaces with elevators, door openers, and other system installation needs. Using alternative vendors will require coordination with Aethon, project management and design by the VA for an unfamiliar system, and also would create warranty issues in terms of any installation and commissioning issues with multiple vendors.

6. Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:

The subject vendor is the only source of the pharmacy tug system equipment being installed however Aethon will be obtaining competitive quotes from SDVO's for any work supervised but not being self-performed.

7. Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable: The estimated cost is based on previous costs for similar work thus is deemed fair and reasonable.

8. Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:


