**Request For Information (RFI) Set #1**

1. Is a specific manufacture for your UPS system along with any other upgrades on cabling/fiber or security that may be involved or is it an open spec platform?

**Open Spec Platform that is in accordance with the SOW and Specifications/Drawings**

2. Factor 2, Sub-factor 2(a) states: “Describe specialized experience, technical competence, and design expertise in electrical and data center infrastructure work performed by the Prime and Subcontractor.” Factor 3, Item 1 states, “A minimum of three (3) and a maximum of five (5) past performance projects completed by the Prime Contractor ---.” Please clarify whether Subcontractor experience will also be considered under Factor 3 since it is considered under Factor 2.

**Factor 3 must be project completed by offeror as prime contractor only.**

3. Page 9 – 11 of the Solicitation, for the Phase I portion of this proposal, requires a description of our proposed methods and procedures, a scheduling plan, anticipated technical difficulties and a phasing plan. The project Scope of Work also requires expansion of the existing Data Center layout into an adjacent room. In order to respond to these questions we will need as-built plans of the existing Data Center and adjacent room to be able to develop a thorough understanding of what will be involved to accomplish this project, or a site visit to allow examination of existing conditions. Can The VA provide as-built drawings of the Data Center and/or a site visit?

**Site Visit is scheduled for 6/7/2017 at 9:00 AM in the Lakemont cafeteria.**

4. Page 9 of the solicitation, the items required for Factor 1: Technical Approach (Tab B) are numbered “1,2,3,5”. Is this a typo or is number “4” missing?

**That is a typo. There is NO number 4 missing.**
