The Hill Rom Versa Care Therapy Surface (Mattress) as indicated above is available only from the manufacturer Hill Rom. This surface (mattress) is an integrated component of the Hill Rom Versa Care beds presently in use throughout the facility. The manifold on this surface (mattress) attaches directly to the Hill Rom bed to enable the air powered function which is critical for wound care provided to Veteran patients. This provides for safe patient positive outcomes. There are no other mattresses that are compatible with the Hill Rom beds presently in use at this facility. Due to the deteriorating condition of existing Versa Care Therapy Surface mattresses, additional replacements are needed.
