**3. Description of Supplies or Services:**

The estimated value of the proposed action is \$147,238.30

\*\*\*BRAND NAME\*\*\* The Northeast Consolidated Patient Account Center (NECPAC) has a requirement for five (5) office spaces to be constructed out of modular furniture. The offices will provide private work space for supervisors. The DIRTT Modular System allows for construction of offices within the existing footprint of the building. The Contractor shall be responsible for all materials, labor, equipment, supervision, and necessary quality assurance to meet this requirement. This particular brand of furniture is essential to the Government's requirement thereby precluding consideration of a product manufactured by another company.

The modular furniture being requested is manufactured by DIRTT ENVIRONMENTAL SOLUTIONS, INC. The modular furniture meets the requirement of the International Building Code and is consistent with the current Northeast Consolidated Patient Account Center (NECPAC) furniture; the modular furniture must correspond and function with the current products and fixtures to provide a uniform appearance and function. An alternative manufacturer, line of modular furniture would be unsuccessful and would cause incompatible items. The DIRTT Modular System allows for construction of offices within the existing footprint of the NECPAC building. This will allow for minimal lead time when compared to traditional construction. For continuity purposes to fit and meet specifications of the existing modular furniture, match style, ability to integrate, reconfigure with pre-existing modular furniture and the ability to be disassembled and moved without losing any performance characteristics such as sight, sound and air barrier due to the DIRTT ENVIRONMENTAL SOLUTIONS, INC. unique Arch beam system. For this reason we are requesting name brand as it represents the best value to the Government.
