B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes FAR 52.219-4 Notice of Price Evaluation Preference for HubZone Small Business Concerns. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. B.4 FUNCTIONAL PERFORMANCE SPECIFICATION

A. SCOPE OF PROCUREMENT

VISN 23 Pathology & Laboratory Medicine Service Line (PLMS) has a requirement for Bio-Rad blood, urine, and CSF multianalyte liquid and/or lyophilized quality control and interlaboratory

program that covers a large number of analytes and are commutable across instrumentation utilized in VISN 23. Blood, urine and CSF controls provided must meet the performance characteristics for accuracy and precision as defined by the Clinical Laboratory Improvement Act (CLIA) and the Clinical and Laboratory Standards Institute (CLSI – formerly NCCLS). Drugs of abuse testing controls must meet the Health and Human Services Workplace Drug Testing guidelines.

Blood, urine, and CSF multianalyte liquid and/or lyophilized controls will be required for each of the clinical laboratories located at the following VA facilities:

B. DEFINITIONS

Lot number - Reagents are dispensed from a common reservoir. I.e. the material is of the same lot only if they were poured from the same reservoir after all ingredients were added

C. GENERAL REQUIREMENTS

1. Required Features

- a. Contractor shall provide blood, urine and CSF liquid and/or lyophilized quality controls on an “on demand/as needed” basis.
- b. The drugs of abuse testing quality controls must meet the Health and Human Services Workplace Drug Testing guidelines and have cutoff concentrations which meet the Workplace Drug Testing cutoff levels. A Certificate of Analysis/Analytical Standard Certificates of Quality /Chemical Data Sheets provided by the suppliers of the Substance Abuse and Mental Health Administration (SAMHSA) regulated controlled substances are required for the Health and Human Services (HHS)-certified laboratory at the Minneapolis VA.

- c. Liquid and/or lyophilized controls shipped or sequestered for one delivery order will have the same lot number per line item. Multiple lot numbers per delivery order will not be accepted. VISN 23 PLMS reserves the right to return all products delivered in multiple lot numbers.
- d. No product substitutions will be accepted without the prior approval of VA Medical Center Laboratory Service and Contracting Officer.
- e. Contractor shall offer maximized expiration dates for control lots to reduce frequency of new lot validations and/or parallel cross over studies.
- f. Interlaboratory Data Management System with capability of bidirectional connection with Data Innovations.

2. Highly Desirable Options (The below items/features are highly desired by the VA but not required)

- a. Human based controls are preferred over bovine based controls.
- b. Long open vial stability.
- c. Reagent sequesters good through lot expiration is highly desirable.
- d. Data management training modules.
- e. On-site or webinar QC seminars.

3. Product Quality and Quality Control

All products offered must be of the same consistent high quality as would be offered to the commercial public in the United States.

- a. All products purchased are subject to acceptance by the PLMS. Products that fail to meet quality control criteria will not be accepted. Products will be rejected and discarded or returned at the Contractor's expense if found unsatisfactory when they are received or later if deterioration of the product occurs prior to outdate. PLMS will not be financially liable for unacceptable materials.
- b. All products must be tested for quality control by the manufacturer. Only products that pass will be sent to VISN 23 PLMS. The contractor will demonstrate documentation of quality control performance on any item upon request including Certificate of Analysis/Analytical Standard Certificates of Quality /Chemical Data Sheets.
- c. Substitution of product may not be made without the approval of the VA Medical Center Laboratory Service and Contracting Officer.
- d. All defective or inferior products must be replaced within 48 hours at no cost to the VA Medical Center Laboratory Service.
- e. The Contractor will immediately notify the Contracting Officer and VA Medical Center Laboratory Services of any recalls of products or other important product safety issues. As appropriate, the Contractor will replace and/or reimburse recalled/defective products at no cost to the Government. The Contractor will be liable for costs of processing recalls, i.e. administrative and clinical services replace recalled/defective products.

4. Green Environmental Management System (GEMS) Compliance

The vendor must be in compliance with Executive Order 13423 and 13514, Federal Leadership in Environmental, Energy and Economic Performance. The goal is to establish an

integrated strategy towards sustainability in the Federal Government and to make reduction of greenhouse gas emission (GHG) a priority for federal agencies. Products and services should be energy efficient, water efficient, bio-based, environmentally preferable, non-ozone depleting, contain recycled content, non-toxic and less-toxic alternatives.

The offeror is required to provide a list identifying any “hazardous materials” including Material Safety Data Sheet (MSDS).

Contractor will provide a complete chemical analysis of waste, to include mercury, NA azides, carcinogens, reproductive toxins and all other waste that may be considered ignitable, corrosive, reactive or toxic. Contractor will be required to provide additional subsequent waste analysis studies in the case of any new test or new test formation introductions. Documentation will be reviewed by the VISN 23 Green Environmental Management Systems (GEMS) Coordinator prior to award or introduction to any new product after award.

D. VA STANDARDIZATION PROGRAM

The Department of Veterans Affairs has implemented a Department-wide standardization program. As a result, VA is issuing National Consolidated Contract(s), BPAs, and BOAs for standardized items. A direct response and supporting documentation, if available, are required for each evaluation criteria. Specific evaluation criteria will include the following, all sub factors are of equal importance.

Test Menu – Consideration will be given to the breadth of testing available for the quality control materials provided. Commercial literature or other information describing analytes tested for each control is required.

-VAAR 815.304 – In an effort to assist SDVOSBs and VOSBs, contracting officers shall include evaluation factors providing additional consideration to such offerors in competitively negotiated solicitations that are not set aside for SDVOSBs or VOSBs. Arbitral award or decision means an arbitrator or arbitral panel determination that a labor law violation occurred, or that enjoined or restrained a violation of labor law. It includes an award or decision that is not final or is subject to being confirmed, modified, or vacated by a court, and includes an award or decision resulting from private or confidential proceedings. To determine whether a particular award or decision is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

Civil judgment means—

(1) In paragraph (h) of this provision: A judgment or finding of a civil offense by any court of competent jurisdiction.

- (ii) OSHA-approved State Plans;

(3) Department of Labor Office of Federal Contract Compliance Programs (OFCCP) for—

- (i) Section 503 of the Rehabilitation Act of 1973;
- (ii) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974; and

- (iii) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity);

(4) National Labor Relations Board (NLRB) for the National Labor Relations Act; and

(5) Equal Employment Opportunity Commission (EEOC) for—

- (i) Title VII of the Civil Rights Act of 1964;
- (ii) The Americans with Disabilities Act of 1990;
- (iii) The Age Discrimination in Employment Act of 1967; and
- (iv) Section 6(d) of the Fair Labor Standards Act (Equal Pay Act).

Forced or indentured child labor means all work or service—

- (1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or
- (2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

Highest-level owner means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

Immediate owner means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

- (6) 41 U.S.C. chapter 67, formerly known as the Service Contract Act.
- (7) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity).
- (8) Section 503 of the Rehabilitation Act of 1973.

(9) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974.

(10) The Family and Medical Leave Act.

(11) Title VII of the Civil Rights Act of 1964.

(12) The Americans with Disabilities Act of 1990.

(13) The Age Discrimination in Employment Act of 1967.

(14) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors).

(15) Equivalent State laws as defined in the DOL Guidance. (The only equivalent State laws implemented in the FAR are OSHA-approved State Plans, which can be found at www.osha.gov/dcsp/osp/approved_state_plans.html).

Labor law decision means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of “labor laws”.

Manufactured end product means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

“Sensitive technology”—

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

Service-disabled veteran-owned small business concern—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

Small business concern means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

Small disadvantaged business concern, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

- (1) Is at least 51 percent unconditionally and directly owned (as defined at 13 CFR 124.105) by—
 - (i) One or more socially disadvantaged (as defined at 13 CFR 124.103) and economically disadvantaged (as defined at 13 CFR 124.104) individuals who are citizens of the United States; and

Subsidiary means an entity in which more than 50 percent of the entity is owned—

- (1) Directly by a parent corporation; or
- (2) Through another subsidiary of a parent corporation.

Successor means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

Veteran-owned small business concern means a small business concern—

- (1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and
- (2) The management and daily business operations of which are controlled by one or more veterans.

Women-owned business concern means a concern which is at least 51 percent owned by one or more women; or in the case of any publicly owned business, at least 51 percent of its stock is owned by one or more women; and whose management and daily business operations are controlled by one or more women.

Women-owned small business concern means a small business concern—

- (1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and
