B.2 STATEMENT OF WORK / SPECIFICATIONS

BACKGROUND DESCRIPTION

The Department of Veteran Affairs, National Cemetery Administration, is seeking qualified sources to furnish all necessary labor, material, equipment and supervision to perform Turf Management Services at Bay Pines National Cemetery, 10000 Bay Pines Boulevard, St. Petersburg, FL, 33708.

Work consists of shrub/tree management, broadleaf herbicide application, pre-emergence herbicide application, fertilization, soil testing, and insecticide applications. No pesticide storage on Cemetery grounds will be permitted.

CONTRACT TYPE SPECIFICS

Contract period is for a base period (12 Months) with four (1) one-year options, if exercised. Services are to be in accordance with the Scope of Work, terms and conditions, contained in this solicitation. The offers shall include a price for each Contract Line Item Number (CLIN), a total price for the estimated quantities, and a sub total price for all estimated services in the contract base period and each option year. Unit prices shall be all inclusive containing (unit prices for materials, unit prices for labor, any labor burden or fringes, any associated travel costs, profit, overhead, and of the like).

This is a firm-fixed priced, requirements contract. This requirement provides estimated quantities that are a realistic estimated total quantity for the resulting contract in accordance with FAR 16.503. The Government is not obligated to any specified quantity as the initial contract award will be awarded at a \$0.00 amount and 0 quantities but succeeding executed task orders will obligate funding and exact quantities to the master contract, serving as a funding/quantity allowance for the contract. The contractor shall not exceed quantities listed on the individual task orders as they will not receive payment for additional services rendered outside the executed task order quantity limits. The contractor shall notify the COR when quantities on the CLINs/Task Order are about to be exhausted, and the contractor considers more quantities are needed in order to perform future services on the contract. The COR will make the determination on ordering future services and will coordinate with the Contract Officer for executing new task orders. Once a new task order is executed, the Contracting Officer & COR will provide the order to the contractor for continuing/new services under this contract. Turf shall be treated with Dimension 0.21% 0-0-7M SOP - in March by a licensed commercial applicator. Product label directions are the law and must be followed. Rate of each product shall be the full rate recommended on the product label. The COR may require evidence at the time of application that the full rate is being mixed/applied, such as seeing the amount of product used for treatment.

Weather and field conditions must be favorable for efficacy, as well as for minimal risk of damage such as injury to off-target plants, or of equipment making ruts in the turf. Specific work dates and locations are to be coordinated with the COR in advance of work to accommodate burials or other activities. All cemetery turf areas are to be treated, unless the COR specifies certain sections or parts of sections that are not to be treated.

Any re-treatment needed as a result of the Contractor's failure to follow manufacturer's instructions shall be done at the Contractor's expense.

Mid-May Application (CLIN 0002)

Turf shall be treated with Dimension 0.21% 18-0-10 50% Polplus - in Mid-May by a licensed commercial applicator. Product label directions are the law and must be followed. Rate of each product shall be the full rate recommended on the product label. The COR may require evidence at the time of application that the full rate is being mixed/applied, such as seeing the amount of product used for treatment.

Weather and field conditions must be favorable for efficacy, as well as for minimal risk of damage such as injury to off-target plants, or of equipment making ruts in the turf. Specific work dates and locations are to be coordinated with the COR in advance of work to accommodate burials or other activities. All cemetery turf areas are to be treated, unless the COR specifies certain sections or parts of sections that are not to be treated.

Any re-treatment needed as a result of the Contractor's failure to follow manufacturer's instructions shall be done at the Contractor's expense.

April Application (CLIN 0003)

Turf shall be treated with Allectus .225% 18-0-10 72% Polyplus 3FE 2 Mn Lesco in April by a licensed commercial applicator. Product label directions are the law and must be followed. Rate of each product shall be the full rate recommended on the product label. The COR may require evidence at the time of application that the full rate is being mixed/applied, such as seeing the amount of product used for treatment.

Weather and field conditions must be favorable for efficacy, as well as for minimal risk of damage such as injury to off-target plants, or of equipment making ruts in the turf. Specific work dates and locations are to be coordinated with the COR in advance of work to accommodate burials or other activities. All cemetery turf areas are to be treated, unless the COR specifies certain sections or parts of sections that are not to be treated.

Any re-treatment needed as a result of the Contractor's failure to follow manufacturer's instructions shall be done at the Contractor's expense.

Late June Application (CLIN 0004)

Turf shall be treated with Allectus .225% 0-0-8 4Fe 2Mn in Late June by a licensed commercial applicator. Product label directions are the law and must be followed. Rate of each product shall be the full rate recommended on the product label. The COR may require evidence at the time of application that the full rate is being mixed/applied, such as seeing the amount of product used for treatment.

Weather and field conditions must be favorable for efficacy, as well as for minimal risk of damage such as injury to off-target plants, or of equipment making ruts in the turf. Specific work dates and locations are to be coordinated with the COR in advance of work to accommodate burials or other activities. All cemetery turf areas are to be treated, unless the COR specifies certain sections or parts of sections that are not to be treated.

Any re-treatment needed as a result of the Contractor's failure to follow manufacturer's instructions shall be done at the Contractor's expense.

August Application (CLIN 0005)

Turf shall be treated with K-Mag 0-0-22E in August by a licensed commercial applicator. Product label directions are the law and must be followed. Rate of each product shall be the full rate recommended on the product label. The COR may require evidence at the time of application that the full rate is being mixed/applied, such as seeing the amount of product used for treatment.

Weather and field conditions must be favorable for efficacy, as well as for minimal risk of damage such as injury to off-target plants, or of equipment making ruts in the turf. Specific work dates and locations are to be coordinated with the COR in advance of work to accommodate burials or other activities. All cemetery turf areas are to be treated, unless the COR specifies certain sections or parts of sections that are not to be treated.

Any re-treatment needed as a result of the Contractor's failure to follow manufacturer's instructions shall be done at the Contractor's expense.

October Application (CLIN 0006)

Turf shall be treated with 20-0-10 72% Polyplus As .2Cfe .1Cmn - in October by a licensed commercial applicator. Product label directions are the law and must be followed. Rate of each product shall be the full rate recommended on the product label. The COR may require evidence at the time of application that the full rate is being mixed/applied, such as seeing the amount of product used for treatment.

Weather and field conditions must be favorable for efficacy, as well as for minimal risk of damage such as injury to off-target plants, or of equipment making ruts in the turf. Specific work dates and locations are to be coordinated with the COR in advance of work to accommodate burials or other activities. All

cemetery turf areas are to be treated, unless the COR specifies certain sections or parts of sections that are not to be treated.

Any re-treatment needed as a result of the Contractor's failure to follow manufacturer's instructions shall be done at the Contractor's expense.

January Application (CLIN 0010)

Turf shall be treated with 9-0-24 72% Polplus As 6Fe 2Mg 2Mn - in January by a licensed commercial applicator. Product label directions are the law and must be followed. Rate of each product shall be the full rate recommended on the product label. The COR may require evidence at the time of application that the full rate is being mixed/applied, such as seeing the amount of product used for treatment.

Weather and field conditions must be favorable for efficacy, as well as for minimal risk of damage such as injury to off-target plants, or of equipment making ruts in the turf. Specific work dates and locations are to be coordinated with the COR in advance of work to accommodate burials or other activities. All cemetery turf areas are to be treated, unless the COR specifies certain sections or parts of sections that are not to be treated.

Any re-treatment needed as a result of the Contractor's failure to follow manufacturer's instructions shall be done at the Contractor's expense.

September Application (CLIN 0007)

Turf shall be treated with Lesco Eagle .39% granular - in September by a licensed commercial applicator. Product label directions are the law and must be followed. Rate of each product shall be the full rate recommended on the product label. The COR may require evidence at the time of application that the full rate is being mixed/applied, such as seeing the amount of product used for treatment.

Weather and field conditions must be favorable for efficacy, as well as for minimal risk of damage such as injury to off-target plants, or of equipment making ruts in the turf. Specific work dates and locations are to be coordinated with the COR in advance of work to accommodate burials or other activities. All cemetery turf areas are to be treated, unless the COR specifies certain sections or parts of sections that are not to be treated.

Any re-treatment needed as a result of the Contractor's failure to follow manufacturer's instructions shall be done at the Contractor's expense.

Early April Application (CLIN 008)

Turf shall be treated with Lesco T-Storm 2G Fungicide - in Early April by a licensed commercial applicator. Product label directions are the law and must be followed. Rate of each product shall be the full rate recommended on the product label. The COR may require evidence at the time of application that the full rate is being mixed/applied, such as seeing the amount of product used for treatment.

Weather and field conditions must be favorable for efficacy, as well as for minimal risk of damage such as injury to off-target plants, or of equipment making ruts in the turf. Specific work dates and locations

are to be coordinated with the COR in advance of work to accommodate burials or other activities. All cemetery turf areas are to be treated, unless the COR specifies certain sections or parts of sections that are not to be treated.

Any re-treatment needed as a result of the Contractor's failure to follow manufacturer's instructions shall be done at the Contractor's expense.

The entire turf area of the Cemetery shall be uniformly treated.

Work shall be coordinated and scheduled with COR and will be determined at the COR's discretion.

Since a granular product is used, any deposited on impervious surfaces (walks/pavement) shall be removed or blown onto the turf immediately following application.

Soil Sample (CLIN 0009)

Soil samples shall be taken an estimated one time each year, or as requested by the COR. Four (4) samples, one from each of 4 cemetery sections, shall be taken as determined by COR. Soil samples shall be collected in late July or early August. Samples shall be analyzed by a certified, commercial or university laboratory (e.g., Midwest Laboratories, A&L Great Lakes Laboratories, Michigan State University Soil and Plant Nutrient Laboratory) and shall include at least the basic soil test (organic Matter, phosphorus, potassium, magnesium, calcium, pH, cation exchange capacity).

1.3.11.1 Soil tests shall be performed at Contractor expense. Each sample shall consist of ten or more soil cores or subsamples of the top three inches of soil, following the directions of the laboratory for turf soil sampling. Thatch or other plant materials shall not be included with the soil. Soil test results must be provided to COR and Southeast District agronomist for review, planning, and filing purposes. Should the soil test results necessitate changing the application amount or rate, the contract shall be modified accordingly.

CONVERSION OF SPECIFICATION TO METRIC

DEFINITIONS

The following terms apply throughout this statement of work.

- A. **CORE OF SOIL.** A solid tube of soil - excluding thatch and/or turf - not less than two inches (5.08 cm) in length and approximately one half inch (1.27 cm) in width.
- B. **DETERMINATIONS OF THE CONTRACTING OFFICER'S REPRESENTATIVE (COR).** Judgments and/or decisions from the COR, or his or her representatives - which include the Cemetery staff of OWRNC. These shall be adhered to by the Contractor - unless such judgments and/or directions are not within the scope of work or go beyond the specified requirements. The Contracting Officer will be notified by the COR and or Contractor if such a conflict occurs.
- C. **GROUND AND BOUNDARIES.** All Cemetery land (including turf, walks, beds, planter beds, drainage ditches, roads, and plazas).
- D. **RECORDS.** On not less than a weekly basis, the Contractor shall meet with the COR and provide a report of all services provided under this contract – including written lists identifying all sections and areas cleaned of leaves, trash and debris, and any other services specified as required.
- E. **SAFETY, SAFE, AND/OR SAFE APPLICATION.** Matters related to safety, and any actions of the Contractor, must meet the requirements of Ohio Western Reserve's National Cemetery's Safety Manager - which in turn are the requirements of the Cemetery and/or OSHA, and the State of Ohio. It is incumbent upon the Contractor to be familiar with these requirements. "Safe Application" involves any and all actions initiated and/or completed by the Contractor necessary in the performance of the specified work - in a manner that safeguards all Ohio Western Reserve's National Cemetery's (OWRNC) visitors, employees, and natural resources. It is all actions initiated and/or completed by the Contractor that meet OSHA and State of Ohio's legal requirements, Right-to-Know laws, EPA guidelines, and otherwise follows the OWRNC's pre-cautions stated within this contract. "Safety" shall also include the Contractor having a safety representative who maintains regular and routine contact with the Safety Manager of OWRNC. Contractor accepts all liability for his or her actions, equipment, and/or labor that result in damage to property, injury, or death.
- F. **SITE MANAGER.** An employee provided by the Contractor to be available whenever work is being performed. Site manager will ensure all specifications are being met, ensure contract work does not conflict with ceremonies and committal services, and ensure employees are adequately supervised and proper conduct is maintained. Also whenever on Cemetery premises, site manager will be the primary reporting official to the COR.
- G. **SUPPLIES AND MATERIALS PROVIDED BY CONTRACTOR.** Everything needed in meeting this contract's specifications, except water is available for Contractor use at the Cemetery.
- H. **TOPSOIL.** A clean sandy loam soil with 3 to 5 percent organic content - as verified by the Contractor through analysis by a licensed soil testing laboratory. It shall be free of sticks, stones and other foreign material.
- I. **TRASH AND DEBRIS.** Any item, material, or foreign object not permanently attached to or planted within the grounds and boundaries. Items include - but are not limited to - fallen twigs and branches that are under ten (10) inches (25.40 cm) in diameter, paper products, cigarette butts, gum, glass and metal products, plastic and any other synthetic item, plus loose rock and stone over three (3) inches (7.62 cm) in diameter that are not the apparent result of an interment. Also included is the material found within the trash receptacles located on the grounds.

- J. TURF. All plants - regardless of species - growing on the established grounds and within the boundaries of OWRNC. Exceptions: Trees and shrubs, any species of plant growing within tree basins, flower and shrub beds and planters, and any species of plant growing out of walks, roads, plazas, curbs or other structures.

WORKING CONDITIONS

Work called for under this contract shall be performed primarily out-of-doors and personnel performing such work shall be exposed to wind, sun, cold, dampness, fog, and rain. These conditions, may, at times, be extreme. The Contractor shall take all precautions necessary to protect personnel employed under the contract from the elements to the maximum practicable extent. The Government expects the Contractor to perform throughout all weather conditions and to apply additional labor and equipment as needed to meet deadlines. Due to the sensitive mission of the cemetery, the work could occasionally come in contact with grieving individuals. Contractor personnel must exercise and exhibit absolute decorum, composure and stability at all times.

GENERAL PARAMETERS

Normal Working Hours: Normal working hours are 8:00 am - 4:30 pm, Monday through Friday. Working hours under this The Cemetery's regular hours of operation, as they relate to interment operations and performance of routine work under the contract, are 8:00 a.m. through 4:30 p.m., local time, Monday through Friday, excluding Federal Holidays, unless specified elsewhere in this Work Statement. Weekend and other work occurring outside of the normal hours of operations will only be upon written approval of the COR and without additional cost to the Government.

The Contractor shall perform site preparation for Memorial Day and Veterans Day. During the week of Memorial Day, all operations must be completed Thursday, prior to the holiday, by noon so work can be accomplished in preparation for the Memorial Day Holiday. During the week of Veterans Day, all operations must be completed by noon on the last workday before the holiday.

Equipment Operations: The Contractor shall not operate motorized equipment or other mechanical devices that may make noise within two hundred (200) feet of ongoing interment services or other public ceremonies/services. Coordinate work activities with COR to meet this requirement.

Contractor Key Personnel: The Contractor Foreman is solely responsible for staying abreast of all upcoming events at the Cemetery. A list of scheduled funerals shall be provided the day of the service. A list of scheduled ceremonies shall be provided the week prior to the event. The COR may direct the Contractor to redirect Contractor personnel away from funeral services or events, or may direct Contractor personnel to move from the funeral services or events vicinity in a timely manner.

Site Work Coordination & Clean-Up: The Government may undertake or award other contracts for additional work at or near the site of work under contract. The Contractor shall fully cooperate with any other Contractors and Government personnel and shall carefully adopt and phase scheduling and performance of the, work, heeding any direction that may be provided by the COR(s).

The Contractor is responsible for reporting to the COR(s) any problems or questions that may arise with any other personnel on site during the period of performance of this contract. The Contractor shall not take it upon him or herself to resolve any problems or issues with other on-site Contractors or employees, but rather will leave it to the COR(s) to resolve the issue.

At the end of each workday, unless otherwise specified by the COR(s) the Contractor shall remove all trash and debris resulting from work. At all times rubbish and trash generated by the Contractor shall be picked up and disposed of properly.

During the course of the contract, if the Contractor or his/her employee discovers a badly settled grave, he/she is required to bring it to the notice of the Cemetery Director or his/her representative.

All materials, equipment and debris, accrued from the performance of the contract shall be disposed of by the Contractor on a daily basis at the Contractor's expense.

Contractor Vehicles/Tractors: No heavy-duty vehicles or tractors shall be permitted to drive on turf without prior permission from the COR. The Contractor shall be responsible for repair or replacing any turf damage caused by the Contractor's wheeled or tracked vehicles or equipment as determined by the COR.

Damage to Government Property: The Contractor shall be responsible to repair, replace, or reimburse the Government for property damage as a result of Contractor personnel, vehicle or equipment and materials. Government property includes, besides the standard structures and equipment, headstones, monuments, trees, beds, planters, turf, i.e., wounded trees or scalped turf, which shall be replaced or repaired at no additional cost to the Government.

Schedule Changes and Delays: Changes in schedules, work assignments or delays of daily operation must not occur under any circumstances. Excessive delay or problems may result in actions for termination of the contract.

CONTRACTOR-FURNISHED ITEMS

The Contractor shall provide all supplies, tools, equipment, and materials to include lubricants and fuels to perform select lawn care services at Bay Pines National Cemetery.

Contractor-furnished items necessary to perform work as required under this contract shall be furnished, maintained and operated by the Contractor. Materials and supplies procured and stored by the Contractor shall be at the Contractor's risk.

The Contractor is responsible for the supply, maintenance, and repair of all Contractor furnished equipment.

If any equipment fails or breaks down during the scheduled workday, that equipment must be removed from the area immediately so as not to damage the turf.

The Contractor shall be responsible to ensure that equipment does not block access to any road or gravesite, during the performance of the contract.

The Contractor shall provide and maintain, at their expense, the necessary service lines from the Government outlets to the site of work.

The Contractor shall provide his/her own REFUSE FACILITIES. The Contractor shall be required to dispose of all debris and other waste materials generated by his/her work at a licensed off-site landfill unless otherwise directed by the COR(s).

Safety - Matters related to safety, and any Contractor's actions, must meet all safety requirements of Bay Pines National Cemetery's Safety Officer, Department of Veterans Affairs, OSHA, and the State of Florida. The Contractor is responsible for being familiarized and kept abreast of all safety requirements.

GOVERNMENT-FURNISHED ITEMS

None

PRE-PERFORMANCE MEETING

Prior to commencing work, the Contractor shall meet with the Contracting Officer and COR, at a time to be determined by the Contracting Officer, to discuss and develop mutual understandings relative to scheduling and administering work. The Contractor shall submit a current insurance certificate to the Contracting Officer prior to the pre-performance meeting.

WORK SCHEDULES/REPORTING AND RECORD KEEPING

The Contractor shall arrange his/her work so as not to interfere with cemetery operations. All work schedules shall be submitted to, and approved by, the COR. Whenever nonessential services have been scheduled on the date a holiday occurs, such services shall be performed on the following working day or as directed by the COR.

STANDARDS OF EMPLOYEE CONDUCT:

- (a) Contractor and contractor's personnel, to include all contractors' temporary workers, shall be required to adhere to the following standards of dress and conduct while performing work in the National Cemetery. These standards and regulations are enforceable under Title 38, USC, Part I, Chapter 9, Section 901.
1. Be fully clothed at all times, to include long slacks or pants and shirt, buttoned up from neck to waist. Clothing shall be clean each day. Any soiled clothing should be cemetery work-related that day. T-shirts and/or tank tops as outer garments are prohibited. Shoes/boots shall have no holes or loose soles. Steel-toed shoes shall be required at all times in accordance with OSHA requirements. The contractor's employees shall maintain personal hygiene.
 2. Shall not engage in loud or boisterous behavior or use profane or abusive language and will show proper reverence during committal services.
 3. Shall not use illegal substances or drink alcoholic beverages except water or other non-alcoholic drinks while on Federal property/grounds. Use of any intoxicating beverages and/or illegal drugs is strictly prohibited.
 4. The contractor personnel's shall not lean, sit or stand on or against headstones or monuments. No tools, equipment or other items will be placed or leaned on headstones or monuments.
 5. Smoking is only designated in marked smoking areas for the Bay Pines National Cemetery. All other areas are designated as NO SMOKING. The Contractor personnel shall follow the Cemetery Smoking Policy that is available at the Cemetery's Administration Building.

6. The Cemetery shall provide to the Contractor personnel restroom facilities at areas designated by the COR. Breaks and lunch periods shall be taken at areas designated by the COR, not in the field.

Any misconduct listed above shall be immediate cause for removal from the Cemetery Premises.

PARKING AND VA REGULATIONS:

The contractor's employees shall park in the appropriate designated parking areas. The Cemetery will not invalidate or make reimbursement for parking violations of the contractor's employees under any conditions. Smoking shall be prohibited inside any buildings at the Cemetery. Possession of weapons shall be prohibited. Enclosed containers, including tool kits, shall be subject to search. Violations of VA regulations may result in citation answerable in the United States (Federal) District Court, not a local district, state, or municipal court.

STORAGE

The Contractor shall not store fuel on Cemetery property. The Contractor shall provide to the Government all label information for stored materials and supplies on Cemetery property used in the performance of the contract. The Government will not be responsible for any costs, repairs, or replacement of Contractor(s) property that is damaged, stolen, or lost. No onsite storage areas will be provided for in this contract.

The Government will furnish or make available to the Contractor a location within the Cemetery determined by the COR(s), for the Contractor's employee parking, storing only vehicles. The Government will not furnish a storage building at the Cemetery site for optional use by the Contractor to store supplies and equipment.

The Government will not provide office space or operational facilities to the Contractor. The Contractor shall secure and maintain the necessary office space and other facilities required for the performance of this contract at his/her own expense.

Water is normally available at the Cemetery and will be furnished at no cost to the Contractor for work at the Cemetery (such as for spray applications). Water outlets for Contractor use will be designated by the COR(s). If Cemetery water is unavailable for some reason the Contractor shall provide water as needed for contract work at no additional expense to the Government.

INSPECTION OF PREMISES:

Offerors should inspect the premises prior to submitting a quote in order to be fully aware of the scope of services required. Failure to do so will not relieve the successful offeror from performing in accordance with the strict intent and meaning of the specifications without additional cost to the Government.

CONTRACTOR'S RESPONSIBILITIES AND INSURANCE REQUIREMENTS:

- a) The Contractor shall be aware of the intensive labor and equipment requirements needed to meet contract specifications. Inclement weather will not be considered an excusable delay in meeting

specifications. The government expects the Contractor to work throughout all weather conditions and to apply additional labor and equipment as necessary to meet deadlines.

b) Damage to Government Property:

- (i) Contractors shall be responsible for replacement of any cemetery structure, to include: turf, trees, beds, curb, road pavement, headstones or markers, monuments, valve boxes, control markers, sprinkler heads, flower vases, which is chipped, marred, damaged and/or ruined at the fault of the Contractor. Contractor shall bear all costs associated with replacement and reinstallation. Any such damage shall be brought to the immediate attention of the COR prior to repair/replacement/installation.
 - (ii) At the Government's discretion, the Contractor shall either repair or replace the property, or reimburse the Government the full amount for all property damage(s).
 - (iii) Contractors shall be responsible for, and advise the COR when cleaning any cemetery structures that are soiled or stained as a result of contractor's performance. The Contractor shall wash-down with water all soiled or stained structures at the end of each work day. No chemicals are to be used at any time on Government property.
- c) Cooperation with other Contractors: The Government may undertake or award other contracts for additional work at or near the site of work for this contract. The Contractor shall fully cooperate with other Contractors and with Government employees.
- d) More than one Contractor may have access to storage areas designated by the COR. The government is not responsible for any costs associate with repairing or replacing Contractor(s) property while on cemetery property.
- e) The Contractor shall not operate trucks, tractors, or other heavy equipment on any turf areas except as provided in this contract or as authorized by the COR. The Contractor will be responsible for repairing turf damage caused by the Contractor regardless of weather conditions, and at no additional cost to the government.
- f) The Contractor shall provide adequate safety warning devices, barricades and cover boards, etc., at all work sites to eliminate hazards from public visitors and cemetery employees at no cost to the government.
- g) At the end of each day, the Contractor shall remove all debris from the cemetery site. At all times rubbish and trash generated by the Contractor shall be kept clear of vehicular and pedestrian traffic throughout the site. The government shall not provide receptacles for the disposal of debris related to this contract.
- h) The Contractor shall possess and maintain all necessary insurance, licenses and permits required for contract performance. The contractor shall take all precautions necessary to protect persons and property from injury or damage during the performance of this contract, and is responsible for any injury to himself/herself, his/her employees, as well as for any damage to personal or public property that occurs during the performance of this contract that is caused by his/her employees fault or

negligence, and shall maintain workmen's compensation, personal liability, automobile liability, and property damage insurance, as prescribed by and having coverage limits of the laws of the state of operation, and in accordance with FAR 52.282-5. Further, it is agreed that any negligence of the Government, its officers, agents, servants and employees, shall not be the responsibility of the contractor hereunder with the regard to any claims, loss, damage, injury, and liability resulting there from. Evidence of coverage is required before commencing work under this contract (copy of Certificate of Insurance), and it may not be changed or cancelled without thirty (30) calendar days prior written notice to the CO.

- i) Reporting "on-the-job" Injuries: The Contractor is required to report all "on-the-job" injuries incurred by the Contractor, its agents or employees, resulting from performance of this contract. Contractor will notify the COR (either orally or via telephone) within twenty-four (24) hours of the injury and provide details and exact location of the incident. This will be followed up by a written notice to the COR. Any Contractor (including its agents and employees) that knowingly files a false claim may be criminally prosecuted.
- j) The Contractor shall, under regulations prescribed by the CO or COR, use only established roadways. When materials are transported in prosecuting the work, vehicles shall not be loaded beyond the loading capacity recommended by the manufacturer of the vehicle or prescribed by any Federal, State, or local law or regulation. When it is necessary to cross curbs or sidewalks, the Contractor shall protect them from damage.
- k) The Contractor shall keep roads, walks and entrances to grounds, buildings and parking clear of equipment, materials, debris, and other vehicles at all times. At least one lane must be open to traffic at all times.

INSPECTION OF CEMETERY FACILITIES:

The COR shall perform inspections on this requirement. During this inspection the appearance of the Cemetery will be observed, and any deficiencies noted within the scope of the contract will be documented by the COR on an inspection sheet. Items that need correcting outside the scope of the contract will be handled by cemetery personnel and reported to the contracting officer or applicable up line authority. Any deficiencies ratings of marginal or unsatisfactory noted on the inspection sheet shall be corrected by the contractor within a reasonable timeframe by the COR.

Items that need correcting within the scope of the contract shall be reported by the contractor to the CO or COR.

SUPERVISION AND TRAINING:

- (a) Contractor shall provide an English speaking supervisor on the project with the experience to manage the project, direct personnel, coordinate work actions, provide requested reports/documentations, and administrate sub-contractors. This person shall serve as the prime conduit for the COR and cemetery director to handle contract actions and resolve daily issues.

- (b) The contractor shall maintain satisfactory standards of personnel conduct and work performance and shall administer disciplinary action as required. The contractor shall remove employees for cause, to include, but not limited to, misconduct in performance of duty under these specifications and/or conduct contrary to the best interests of the Government.
- (c) The contractor shall also be responsible for training and safety precautions for the contractor's employees performing work under these specifications. Occupational Safety and Health Administration (OSHA) standards shall be observed by the contractor in all work performed. Appropriate safety equipment shall be furnished by the contractor to the contractor's personnel and shall be used as prescribed by OSHA standards, including hard hats, safety shoes, safety glasses, and hearing protection devices as necessary (Note, this usually applies to construction). The following OSHA and NFPA standards and codes are to be adhered to:
 - 1. National Fire Protection Association (NFPA): 10-1998 Standard for Portable Fire Extinguishers
 - 2. OSHA 29 CFR 1910 Safety and Health Regulations for Personal Protection, Safety Color Codes, Portable Power Tools, Electrical Safety and Portable Electric Equipment.
 - 3. Site and Building Access: Contractor shall maintain free and unobstructed access to facility emergency services and for fire, police and other emergency response forces in accordance with NFPA 241.
- (d) The Contractor shall be responsible for maintaining satisfactory standards of personnel conduct and work performance and shall administer disciplinary action as required.
- (e) The Contractor shall remove employees for cause, to include, but not limited to, misconduct in performance of duty under these specifications and/or conduct contrary to the best interests of the Government.

CONTRACT MANAGEMENT

- a) Representatives of the Contracting Officer: The VA Contracting Officer will designate one (or more) representatives to serve as the Contracting Officer's Representative (COR) to act for him/her in furnishing technical guidance and advice or generally directing the work to be performed under the contract. Such designation will be in writing and will define the scope and limitations of the COR's authority. A copy of the designation(s) shall be furnished to the Contractor at time of award.
- b) The COR may direct and arrange the Contractor's work schedule in specific areas of the cemetery to coordinate with daily cemetery activities and operations.
- c) Duties and responsibilities of the COR include day-to-day monitoring of the contract as follows:
 - (i) Providing contract oversight and technical guidance to the Contractor.
 - (ii) Placing orders for services.
 - (iii) Verification / certification of payments to the Contractor for services rendered.
 - (iv) Assuring that any changes effecting work involved, price, terms and/or conditions under the contract are not implemented before written authorization is issued by the Contracting Officer.

- d) All administrative contract functions are the responsibility of the VA CO. Any modifications to the contract, including those involving no-cost changes, increases and decreases in cost or level of services provided, termination or extension of the contract (in part or in whole) and decisions concerning claims or disputes, must be authorized in writing by the Government Contracting Officer.
- e) Communication & Coordination of Work with COR: Communication with the COR (or designee) is required. Burial activities at NCA shall take precedence over contract work activities. Work activity and noise cannot disturb burial services. Trucks and workmen are prohibited from passing through the service area during this period.

MAINTENANCE DURING CEMETERY FUNCTIONS:

The contractor's personnel shall not operate motorized equipment or conduct other commercial activities during interment services. The COR or his/her representative shall furnish the contractor with a schedule of all interments and/or ceremonies no later than the close of business of the day prior to the scheduled interment, and a minimum of three (3) days before any ceremonial events.

Note: To cause the least possible interference with cemetery activities, contract personnel will stop (cease) all work in areas where burials are taking place. As a general "rule-of-thumb", work should not take place within 1,000 feet of an ongoing committal service or ceremony.

PERFORMANCE EVALUATION MEETING:

- (a) The issuance of a Contract Discrepancy Report (CDR) may be cause for scheduling a meeting with the contractor, CO, COR, and Cemetery Director. A mutual effort will be made to resolve all problems identified. The Government will prepare written minutes of the meeting. All attendees of the meeting will sign minutes of the meeting(s).
- (b) Should the contractor not concur with the minutes, he will state in writing to the CO within ten (10) calendar days any areas he does not concur and explain the reasons for non-concurrence. The CO will review and consider the reasons submitted for the contractor's non-concurrence and make a decision. The CO will notify the contractor of the decision in writing within ten (10) calendar days.

ACTIONS:

- (a) Normally, the COR will verbally advise or give a written inspection report to the contractor of discrepancies the first time they occur and ask the contractor to correct the problem. A notation will be made on the COR's inspection sheet of the date and the time the deficiency was discovered and the date and time the contractor was notified.
- (b) If the Government created any of the discrepancies, these will not be counted against the contractor's performance. When the Government has caused the contractor to perform in an unsatisfactory manner, the COR will forward a written notice to the responsible organizational requesting corrective action be taken.

- (c) When the contractor is not meeting the limits of satisfactory performance, a CDR will be issued to the contractor. The seriousness of the failures should govern whether to issue CDR at the end of the period, or as soon as the limits of satisfactory performance are exceeded.
- (d) If the contractor does not achieve satisfactory performance by the end of the next period or agreed suspense date, another CDR will be issued.
- (e) A second CDR will be cause for a Cure Notice. However, CO may issue a Cure Notice at any time deemed appropriate. Depending on overall performance, an unsatisfactory reply to Cure Notice should require Show Cause letter to be issued, followed by consideration of termination of the contract.

CONTRACTOR'S QUALITY CONTROL PLAN (QCP):

- (a) Contractor shall establish and maintain a complete QCP to assure requirements of this contract are provided as specified. This QCP will be forwarded to the CO along with the requested initial quotation. The CO and COR will review the QCP and list any needed clarifications, and return to contractor for response, if necessary. Contractor's QCP shall include the following or have incorporated into during performance of contract, at a minimum:
- (b) An inspection plan covering all services required by this contract. The inspection plan shall specify the areas to be inspected, how often inspections will be accomplished and documented, and the title of the individual(s) who will perform the inspections.
- (c) On-site records of all inspections conducted by the contractor noting necessary corrective action taken. The Government reserves the right to request copies of any and/or each inspection.
- (d) Incorporation of either active or established internal policy and procedures for updating equipment and procedures that may affect performance of contract.
- (e) The methods for identifying and preventing deficiencies in the quality of service performed, before the level of performance becomes unacceptable, and organizational functions noting intermediate supervisory responsibilities and overall management responsibilities for ensuring total acceptable performance.
- (f) On-site records identifying the character, physical capabilities, certifications and ongoing training of each employee performing services under this contract.
- (g) A log to account for all requests for immediate service. The log shall indicate the date and time of services, and description of results and completion of these services.
- (h) On-site records of any complaints or problems, with procedures taken to allow for corrections and/or elimination before effects caused interruption of performance of contract.

SECTION C - CONTRACT CLAUSES

C.1 52.212-4 CONTRACT TERMS AND CONDITIONS—COMMERCIAL ITEMS (JAN 2017)

(a) *Inspection/Acceptance.* The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

- (1) Within a reasonable time after the defect was discovered or should have been discovered; and
- (2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) *Assignment.* The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) *Changes.* Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) *Disputes.* This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) *Definitions.* The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) *Invoice.*

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—

- (i) Name and address of the Contractor;
- (ii) Invoice date and number;
- (iii) Contract number, line item number and, if applicable, the order number;
- (iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;
- (v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;
- (vi) Terms of any discount for prompt payment offered;

(vii) Name and address of official to whom payment is to be sent;
(viii) Name, title, and phone number of person to notify in event of defective invoice; and
(ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.

(x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer—Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) *Patent indemnity.* The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) *Payment.*—

(1) *Items accepted.* Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) *Prompt payment.* The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) *Electronic Funds Transfer (EFT).* If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) *Discount.* In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) *Overpayments.* If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) *Interest.*

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109,

which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) *Final decisions.* The Contracting Officer will issue a final decision as required by 33.211 if—

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) *Risk of loss.* Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) *Taxes.* The contract price includes all applicable Federal, State, and local taxes and duties.

(l) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and

conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) *Title*. Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) *Warranty*. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) *Limitation of liability*. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) *Other compliances*. The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) *Compliance with laws unique to Government contracts*. The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) *Order of precedence*. Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

- (1) The schedule of supplies/services.
- (2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause;
- (3) The clause at 52.212-5.
- (4) Addenda to this solicitation or contract, including any license agreements for computer software.
- (5) Solicitation provisions if this is a solicitation.
- (6) Other paragraphs of this clause.
- (7) The Standard Form 1449.
- (8) Other documents, exhibits, and attachments
- (9) The specification.

(t) *System for Award Management (SAM)*.

(1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the SAM database; (B)

comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

(3) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the SAM record to reflect an assignee for the purpose of assignment of claims (see Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(4) Offerors and Contractors may obtain information on registration and annual confirmation requirements via SAM accessed through <https://www.acquisition.gov>.

(u) *Unauthorized Obligations.*

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an "I agree" click box or other comparable mechanism (e.g., "click-wrap" or "browse-wrap" agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

(v) *Incorporation by reference.* The Contractor's representations and certifications, including those completed electronically via the System for Award Management (SAM), are incorporated by reference into the contract.

(End of Clause)

C.2 52.203-99 PROHIBITION ON CONTRACTING WITH ENTITIES THAT REQUIRE CERTAIN INTERNAL CONFIDENTIALITY AGREEMENTS (DEVIATION) (FEB 2015)

(a) The Contractor shall not require employees or contractors seeking to report fraud, waste, or abuse to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(b) The contractor shall notify employees that the prohibitions and restrictions of any internal confidentiality agreements covered by this clause are no longer in effect.

(c) The prohibition in paragraph (a) of this clause does not contravene requirements applicable to Standard Form 312, Form 4414, or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(d)(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Resolution Appropriations Act, 2015 (Pub. L. 113-235), use of funds appropriated (or otherwise made available) under that or any other Act may be prohibited, if the Government determines that the Contractor is not in compliance with the provisions of this clause.

(2) The Government may seek any available remedies in the event the contractor fails to comply with the provisions of this clause.

(End of Clause)

C.3 52.211-6 BRAND NAME OR EQUAL (AUG 1999)

(a) If an item in this solicitation is identified as "brand name or equal," the purchase description reflects the characteristics and level of quality that will satisfy the Government's needs. The salient physical, functional, or performance characteristics that "equal" products must meet are specified in the solicitation.

(b) To be considered for award, offers of "equal" products, including "equal" products of the brand name manufacturer, must—

(1) Meet the salient physical, functional, or performance characteristic specified in this solicitation;

(2) Clearly identify the item by—

(i) Brand name, if any; and

(ii) Make or model number;

(3) Include descriptive literature such as illustrations, drawings, or a clear reference to previously furnished descriptive data or information available to the Contracting Officer; and

(4) Clearly describe any modifications the offeror plans to make in a product to make it conform to the solicitation requirements. Mark any descriptive material to clearly show the modifications.

(c) The Contracting Officer will evaluate "equal" products on the basis of information furnished by the offeror or identified in the offer and reasonably available to the Contracting Officer. The Contracting Officer is not responsible for locating or obtaining any information not identified in the offer.

(d) Unless the offeror clearly indicates in its offer that the product being offered is an "equal" product, the offeror shall provide the brand name product referenced in the solicitation.

(End of Provision)

C.4 52.216-18 ORDERING (OCT 1995)

(a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from the effective date of the contract through the end of the effective period.

(b) All delivery orders or task orders are subject to the terms and conditions of this contract. In the event of conflict between a delivery order or task order and this contract, the contract shall control.

(c) If mailed, a delivery order or task order is considered "issued" when the Government deposits the order in the mail. Orders may be issued orally, by facsimile, or by electronic commerce methods only if authorized in the Schedule.

(End of Clause)

C.5 52.216-19 ORDER LIMITATIONS (OCT 1995)

(a) *Minimum order.* When the Government requires supplies or services covered by this contract in an amount of less than 1, the Government is not obligated to purchase, nor is the Contractor obligated to furnish, those supplies or services under the contract.

(b) *Maximum order.* The Contractor is not obligated to honor—

- (1) Any order for a single item in excess of N/A;
- (2) Any order for a combination of items in excess of N/A; or
- (3) A series of orders from the same ordering office within 1 days that together call for quantities exceeding the limitation in paragraph (b)(1) or (2) of this section.

(c) If this is a requirements contract (i.e., includes the Requirements clause at subsection 52.216-21 of the Federal Acquisition Regulation (FAR)), the Government is not required to order a part of any one requirement from the Contractor if that requirement exceeds the maximum-order limitations in paragraph (b) of this section.

(d) Notwithstanding paragraphs (b) and (c) of this section, the Contractor shall honor any order exceeding the maximum order limitations in paragraph (b), unless that order (or orders) is returned to the ordering office within 5 days after issuance, with written notice stating the Contractor's intent not to ship the item (or items) called for and the reasons. Upon receiving this notice, the Government may acquire the supplies or services from another source.

(End of Clause)

C.6 52.216-21 REQUIREMENTS (OCT 1995)

(a) This is a requirements contract for the supplies or services specified, and effective for the period stated, in the Schedule. The quantities of supplies or services specified in the Schedule are estimates only and are not purchased by this contract. Except as this contract may otherwise provide, if the Government's requirements do not result in orders in the quantities described as "estimated" or "maximum" in the Schedule, that fact shall not constitute the basis for an equitable price adjustment.

(b) Delivery or performance shall be made only as authorized by orders issued in accordance with the Ordering clause. Subject to any limitations in the Order Limitations clause or elsewhere in this contract, the Contractor shall furnish to the Government all supplies or services specified in the Schedule and called for by orders issued in accordance with the Ordering clause. The Government may issue orders requiring delivery to multiple destinations or performance at multiple locations.

(c) Except as this contract otherwise provides, the Government shall order from the Contractor all the supplies or services specified in the Schedule that are required to be purchased by the Government activity or activities specified in the Schedule.

(d) The Government is not required to purchase from the Contractor requirements in excess of any limit on total orders under this contract.

(e) If the Government urgently requires delivery of any quantity of an item before the earliest date that delivery may be specified under this contract, and if the Contractor will not accept an order providing for the accelerated delivery, the Government may acquire the urgently required goods or services from another source.

(f) Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were completed during the contract's effective period; provided, that the Contractor shall not be required to make any deliveries under this contract after August 31, 2022, if extended..

(End of Clause)

C.7 52.217-8 OPTION TO EXTEND SERVICES (NOV 1999)

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer may exercise the option by written notice to the Contractor within 30 calendar days.

(End of Clause)

C.8 52.217-9 OPTION TO EXTEND THE TERM OF THE CONTRACT (MAR 2000)

(a) The Government may extend the term of this contract by written notice to the Contractor within 30 calendar days; provided that the Government gives the Contractor a preliminary written notice of its intent to extend at least 60 days before the contract expires. The preliminary notice does not commit the Government to an extension.

(b) If the Government exercises this option, the extended contract shall be considered to include this option clause.

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed 5 years, if all options are exercised..

(End of Clause)

C.9 52.219-14 LIMITATIONS ON SUBCONTRACTING (JAN 2017)

(a) This clause does not apply to the unrestricted portion of a partial set-aside.

(b) *Applicability.* This clause applies only to—

(1) Contracts that have been set aside or reserved for small business concerns or 8(a) participants;

(2) Part or parts of a multiple-award contract that have been set aside for small business concerns or 8(a) participants; and

(3) Orders set aside for small business or 8(a) participants under multiple-award contracts as described in 8.405-5 and 16.505(b)(2)(i)(F).

(c) By submission of an offer and execution of a contract, the Offeror/Contractor agrees that in performance of the contract in the case of a contract for—

(1) *Services (except construction).* At least 50 percent of the cost of contract performance incurred for personnel shall be expended for employees of the concern.

(2) *Supplies (other than procurement from a nonmanufacturer of such supplies).* The concern shall perform work for at least 50 percent of the cost of manufacturing the supplies, not including the cost of materials.

(3) *General construction.* The concern will perform at least 15 percent of the cost of the contract, not including the cost of materials, with its own employees.

(4) *Construction by special trade contractors.* The concern will perform at least 25 percent of the cost of the contract, not including the cost of materials, with its own employees.

(End of Clause)

C.10 52.223-2 AFFIRMATIVE PROCUREMENT OF BIOBASED PRODUCTS UNDER SERVICE AND CONSTRUCTION CONTRACTS (SEP 2013)

(a) In the performance of this contract, the contractor shall make maximum use of biobased products that are United States Department of Agriculture (USDA)-designated items unless—

(1) The product cannot be acquired—

(i) Competitively within a time frame providing for compliance with the contract performance schedule;

(ii) Meeting contract performance requirements; or

(iii) At a reasonable price.

(2) The product is to be used in an application covered by a USDA categorical exemption (see 7 CFR 3201.3(e)). For example, all USDA-designated items are exempt from the preferred procurement requirement for the following:

(i) Spacecraft system and launch support equipment.

(ii) Military equipment, i.e., a product or system designed or procured for combat or combat-related missions.

(b) Information about this requirement and these products is available at <http://www.biopreferred.gov>.

(c) In the performance of this contract, the Contractor shall—

(1) Report to <http://www.sam.gov>, with a copy to the Contracting Officer, on the product types and dollar value of any USDA-designated biobased products purchased by the Contractor during the previous Government fiscal year, between October 1 and September 30; and

(2) Submit this report no later than—

(i) October 31 of each year during contract performance; and

(ii) At the end of contract performance.

(End of Clause)

C.11 52.223-3 HAZARDOUS MATERIAL IDENTIFICATION AND MATERIAL SAFETY DATA (JAN 1997)

(a) "Hazardous material," as used in this clause, includes any material defined as hazardous under the latest version of Federal Standard No. 313 (including revisions adopted during the term of the contract).

(b) The offeror must list any hazardous material, as defined in paragraph (a) of this clause, to be delivered under this contract. The hazardous material shall be properly identified and include any applicable identification number, such as National Stock Number or Special Item Number. This information shall also be included on the Material Safety Data Sheet submitted under this contract.

Material (If none, insert "None")	Identification No.

(c) This list must be updated during performance of the contract whenever the Contractor determines that any other material to be delivered under this contract is hazardous.

(d) The apparently successful offeror agrees to submit, for each item as required prior to award, a Material Safety Data Sheet, meeting the requirements of 29 CFR 1910.1200(g) and the latest version of Federal Standard No. 313, for all hazardous material identified in paragraph (b) of this clause. Data shall be submitted in accordance with Federal Standard No. 313, whether or not the apparently successful offeror is the actual manufacturer of these items. Failure to submit the Material Safety Data Sheet prior to award may result in the apparently successful offeror being considered nonresponsible and ineligible for award.

(e) If, after award, there is a change in the composition of the item(s) or a revision to Federal Standard No. 313, which renders incomplete or inaccurate the data submitted under paragraph (d) of this clause, the Contractor shall promptly notify the Contracting Officer and resubmit the data.

(f) Neither the requirements of this clause nor any act or failure to act by the Government shall relieve the Contractor of any responsibility or liability for the safety of Government, Contractor, or subcontractor personnel or property.

(g) Nothing contained in this clause shall relieve the Contractor from complying with applicable Federal, State, and local laws, codes, ordinances, and regulations (including the obtaining of licenses and permits) in connection with hazardous material.

(h) The Government's rights in data furnished under this contract with respect to hazardous material are as follows:

(1) To use, duplicate and disclose any data to which this clause is applicable. The purposes of this right are to—

(i) Apprise personnel of the hazards to which they may be exposed in using, handling, packaging, transporting, or disposing of hazardous materials;

(ii) Obtain medical treatment for those affected by the material; and

(iii) Have others use, duplicate, and disclose the data for the Government for these purposes.

(2) To use, duplicate, and disclose data furnished under this clause, in accordance with subparagraph (h)(1) of this clause, in precedence over any other clause of this contract providing for rights in data.

(3) The Government is not precluded from using similar or identical data acquired from other sources.

(End of Clause)

C.12 52.228-5 INSURANCE—WORK ON A GOVERNMENT INSTALLATION (JAN 1997)

(a) The Contractor shall, at its own expense, provide and maintain during the entire performance of this contract, at least the kinds and minimum amounts of insurance required in the Schedule or elsewhere in the contract.

(b) Before commencing work under this contract, the Contractor shall notify the Contracting Officer in writing that the required insurance has been obtained. The policies evidencing required insurance shall contain an endorsement to the effect that any cancellation or any material change adversely affecting the Government's interest shall not be effective—

(1) For such period as the laws of the State in which this contract is to be performed prescribe; or

(2) Until 30 days after the insurer or the Contractor gives written notice to the Contracting Officer, whichever period is longer.

(c) The Contractor shall insert the substance of this clause, including this paragraph (c), in subcontracts under this contract that require work on a Government installation and shall require subcontractors to provide and maintain the insurance required in the Schedule or elsewhere in the contract. The Contractor shall maintain a copy of all subcontractors' proofs of required insurance, and shall make copies available to the Contracting Officer upon request.

C.13 SUPPLEMENTAL INSURANCE REQUIREMENTS

In accordance with FAR 28.307-2 and FAR 52.228-5, the following minimum coverage shall apply to this contract:

(a) Workers' compensation and employers liability: Contractors are required to comply with applicable Federal and State workers' compensation and occupational disease statutes. If occupational diseases are not compensable under those statutes, they shall be covered under the employer's liability section of the insurance policy, except when contract operations are so commingled with a Contractor's commercial operations that it would not be practical to require this coverage. Employer's liability coverage of at least \$100,000 is required, except in States with exclusive or monopolistic funds that do not permit workers' compensation to be written by private carriers.

(b) General Liability: \$500,000.00 per occurrences.

(c) Automobile liability: \$200,000.00 per person; \$500,000.00 per occurrence and \$20,000.00 property damage.

(d) The successful bidder must present to the Contracting Officer, prior to award, evidence of general liability insurance without any exclusionary clauses for asbestos that would void the general liability coverage.

Funds are not presently available for this contract. Funds are not presently available for performance under this contract beyond March 31, 2018. The Government's obligation for performance of this contract beyond that date is contingent upon the availability of appropriated funds from which payment for contract purposes can be made. No legal liability on the part of the Government for any payment may arise for performance under this contract beyond March 31, 2018, until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer.

C.16 VAAR 852.219-10 VA NOTICE OF TOTAL SERVICE-DISABLED VETERAN-OWNED SMALL BUSINESS SET-ASIDE (JUL 2016)(DEVIATION)

(a) *Definition.* For the Department of Veterans Affairs, "Service-disabled veteran-owned small business concern or SDVSOB":

(1) Means a small business concern:

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans or eligible surviving spouses (see VAAR 802.201 Surviving Spouse definition);

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans (or eligible surviving spouses) or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran;

(v) The business will comply with subcontracting limitations in 13 CFR 125.6, as applicable

(2) "Service-disabled veteran" means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

(b) *General.*

(1) Offers are solicited only from verified service-disabled veteran-owned small business concerns. Offers received from concerns that are not verified service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified service-disabled veteran-owned small business concern.

(c) *Agreement*. A service-disabled veteran-owned small business concern agrees that in the performance of the contract, the concern will comply with the limitation on subcontracting requirements in 13 CFR §125.6.

(d) A joint venture may be considered a service-disabled veteran owned small business concern if the joint venture complies with the requirements in 13 CFR 125.15, provided that any reference therein to SDVO SBC is to be construed to apply to a VA verified SDVOSB as appropriate.

(e) Any service-disabled veteran-owned small business concern (non-manufacturer) must meet the requirements in FAR 19.102(f) of the Federal Acquisition Regulation to receive a benefit under this program.

(5) *Payment request* means any request for contract financing payment or invoice payment submitted by the contractor under this contract.

(b) *Electronic payment requests*. Except as provided in paragraph (e) of this clause, the contractor shall submit payment requests in electronic form. Purchases paid with a Government-wide commercial purchase card are considered to be an electronic transaction for purposes of this rule, and therefore no additional electronic invoice submission is required.

(c)(1) If the bidder proposes to furnish an "equal" product, the brand name, if any, of the product to be furnished shall be inserted in the space provided in the invitation for bids, or such product shall be otherwise clearly identified in the bid. The evaluation of bids and the determination as to equality of the product offered shall be the responsibility of the Government and will be based on information furnished by the bidder or identified in his/her bid as well as other information reasonably available to the purchasing activity. CAUTION TO BIDDERS. The purchasing activity is not responsible for locating or securing any information that is not identified in the bid and reasonably available to the purchasing activity. Accordingly, to insure that sufficient information is available, the bidder must furnish as a part of his/her bid all descriptive material (such as cuts, illustrations, drawings or other information) necessary for the purchasing activity to:

(i) Determine whether the product offered meets the salient characteristics requirement of the Invitation for Bids, and

(ii) Establish exactly what the bidder proposes to furnish and what the Government would be binding itself to purchase by making an award. The information furnished may include specific references to information previously furnished or to information otherwise available to the purchasing activity.

(2) If the bidder proposes to modify a product so as to make it conform to the requirements of the Invitation for Bids, he/she shall:

(i) Include in his/her bid a clear description of such proposed modifications, and

(ii) Clearly mark any descriptive material to show the proposed modifications.

(3) Modifications proposed after bid opening to make a product conform to a brand name product referenced in the Invitation for Bids will not be considered.

SECTION E - SOLICITATION PROVISIONS

E.1 52.212-1 INSTRUCTIONS TO OFFERORS—COMMERCIAL ITEMS (JAN 2017)

- (9) Acknowledgment of Solicitation Amendments;
- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
- (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) *Period for acceptance of offers.* The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

(d) *Product samples.* When required by the solicitation, product samples shall be submitted at or prior to the time specified for receipt of offers. Unless otherwise specified in this solicitation, these samples shall be submitted at no expense to the Government, and returned at the sender's request and expense, unless they are destroyed during preaward testing.

(e) *Multiple offers.* Offerors are encouraged to submit multiple offers presenting alternative terms and conditions, including alternative line items (provided that the alternative line items are consistent with subpart 4.10 of the Federal Acquisition Regulation), or alternative commercial items for satisfying the requirements of this solicitation. Each offer submitted will be evaluated separately.

(f) *Late submissions, modifications, revisions, and withdrawals of offers.*

(1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If

no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and—

(A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or

Qualifications of Key Personnel: includes information on key personnel, including manager’s résumés with relevant experience, identification of any subcontractors(s) used in performance of the contract, their role, and the resources they intend to use to complete this project, i.e., who is the subcontractor, what service(s) would they perform under this contract, and how do they intend to provide the service(s). - (2) Department of Labor Occupational Safety and Health Administration (OSHA) for—
 - (i) The Occupational Safety and Health Act of 1970; and
 - (ii) OSHA-approved State Plans;
- (3) Department of Labor Office of Federal Contract Compliance Programs (OFCCP) for—
 - (i) Section 503 of the Rehabilitation Act of 1973;
 - (ii) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974; and
 - (iii) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity);
- (4) National Labor Relations Board (NLRB) for the National Labor Relations Act; and
- (5) Equal Employment Opportunity Commission (EEOC) for—

- (9) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974.
- (10) The Family and Medical Leave Act.
- (11) Title VII of the Civil Rights Act of 1964.
- (12) The Americans with Disabilities Act of 1990.
- (13) The Age Discrimination in Employment Act of 1967.
- (14) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors).
- (15) Equivalent State laws as defined in the DOL Guidance. (The only equivalent State laws implemented in the FAR are OSHA-approved State Plans, which can be found at www.osha.gov/dcsp/osp/approved_state_plans.html).

Labor law decision means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of “labor laws”.

Manufactured end product means any end product in product and service codes (PSCs) 1000-9999, except—

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the

Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. [](i) There has been no administrative merits determination, arbitral award or decision, or civil judgment for any labor law violation(s) rendered against the offeror (see definitions in paragraph (a) of this section) during the period beginning on October 25, 2015 to the date of the offer, or for three years preceding the date of the offer, whichever period is shorter; or

[](ii) There has been an administrative merits determination, arbitral award or decision, or civil judgment for any labor law violation(s) rendered against the Offeror during the period beginning on October 25, 2015 to the date of the offer, or for three years preceding the date of the offer, whichever period is shorter.

(3)(i) If the box at paragraph (s)(2)(ii) of this provision is checked and the Contracting Officer has initiated a responsibility determination and has requested additional information, the Offeror shall provide--

(A) The following information for each disclosed labor law decision in the System for Award Management (SAM) at www.sam.gov, unless the information is already current, accurate, and complete in SAM. This information will be publicly available in the Federal Awardee Performance and Integrity Information System (FAPIS):

- (1) The labor law violated.
- (2) The case number, inspection number, charge number, docket number, or other unique identification number.
- (3) The date rendered.
- (4) The name of the court, arbitrator(s), agency, board, or commission that rendered the determination or decision;

(B) The administrative merits determination, arbitral award or decision, or civil judgment document, to the Contracting Officer, if the Contracting Officer requires it;

(C) In SAM, such additional information as the Offeror deems necessary to demonstrate its responsibility, including mitigating factors and remedial measures such as offeror actions taken to address the violations, labor compliance agreements, and other steps taken to achieve compliance with labor laws. Offerors may provide explanatory text and upload documents. This information will not be made public unless the contractor determines that it wants the information to be made public; and

(D) The information in paragraphs (s)(3)(i)(A) and (s)(3)(i)(C) of this provision to the Contracting Officer, if the Offeror meets an exception to SAM registration (see FAR 4.1102(a)).

(ii)(A) The Contracting Officer will consider all information provided under (s)(3)(i) of this provision as part of making a responsibility determination.

(B) A representation that any labor law decision(s) were rendered against the Offeror will not necessarily result in withholding of an award under this solicitation. Failure of the Offeror to furnish a representation or provide such additional information as requested by the Contracting Officer may render the Offeror nonresponsible.

(C) The representation in paragraph (s)(2) of this provision is a material representation of fact upon which reliance was placed when making award. If it is later determined that the Offeror knowingly rendered an erroneous representation, in addition to other remedies available to the Government, the Contracting Officer may terminate the contract resulting from this solicitation in accordance with the procedures set forth in FAR 12.403.

(4) The Offeror shall provide immediate written notice to the Contracting Officer if at any time prior to contract award the Offeror learns that its representation at paragraph (s)(2) of this provision is no longer accurate.

(5) The representation in paragraph (s)(2) of this provision will be public information in the Federal Awardee Performance and Integrity Information System (FAPIS).

Note to paragraph (s): By a court order issued on October 24, 2016, this paragraph (s) is enjoined indefinitely as of the date of the order. The enjoined paragraph will become effective immediately if the court terminates the injunction. At that time, DoD, GSA, and NASA will publish a document in the **Federal Register** advising the public of the termination of the injunction.

(t) *Public Disclosure of Greenhouse Gas Emissions and Reduction Goals.* Applies in all solicitations that require offerors to register in SAM (52.212-1(k)).

(1) This representation shall be completed if the Offeror received \$7.5 million or more in contract awards in the prior Federal fiscal year. The representation is optional if the Offeror received less than \$7.5 million in Federal contract awards in the prior Federal fiscal year.

(2) Representation. [Offeror to check applicable block(s) in paragraph (t)(2)(i) and (ii)]. (i) The Offeror (itself or through its immediate owner or highest-level owner) [] does, [] does not publicly disclose greenhouse gas emissions, i.e., makes available on a publicly accessible Web site the results of a greenhouse gas inventory, performed in accordance with an accounting standard with publicly available and consistently applied criteria, such as the Greenhouse Gas Protocol Corporate Standard.

(ii) The Offeror (itself or through its immediate owner or highest-level owner) [] does, [] does not publicly disclose a quantitative greenhouse gas emissions reduction goal, i.e., make available on a publicly accessible Web site a target to reduce absolute emissions or emissions intensity by a specific quantity or percentage.

(iii) A publicly accessible Web site includes the Offeror's own Web site or a recognized, third-party greenhouse gas emissions reporting program.

(3) If the Offeror checked "does" in paragraphs (t)(2)(i) or (t)(2)(ii) of this provision, respectively, the Offeror shall provide the publicly accessible Web site(s) where greenhouse gas emissions and/or reduction goals are reported:_____.

(u)(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235) and its successor provisions in subsequent appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(2) The prohibition in paragraph (u)(1) of this provision does not contravene requirements applicable to Standard Form 312 (Classified Information Nondisclosure Agreement), Form 4414 (Sensitive Compartmented Information Nondisclosure Agreement), or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(3) Representation. By submission of its offer, the Offeror represents that it will not require its employees or subcontractors to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting waste, fraud, or abuse related to the performance of a Government contract to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information (e.g., agency Office of the Inspector General).
