### 4. REASON THAT SUGGESTED SOURCE IS THE ONLY SOURCE, WHICH CAN PROVIDE THE SUPPLIES OR SERVICES:

MIM software is the sole developer, designer, installer, and licenser for MIM software in the United States. Market research conducted and contact with MIM software reveals that the requested licenses can only be purchased from MIM software. MIM software provided an email statement that only their company provides licensing for their software products.

# 5. DESCRIPTION OF MARKET RESEARCH CONDUCTED AND RESULTS OR STATEMENT WHY IT WAS NOT CONDUCTED:

Market research was conducted through online research and a sources sought notice in an attempt to determine if another company can provide the MIM Encore and Cardiac add on licensing. Online research determined that MIM software is the sole company in the United States that sells licensing for their MIM software products. An FPDS search also revealed that all MIM software products have only been purchased from MIM Software. Additionally, the Houston VAMC also purchased their original Encore licenses from MIM Software.

MIM software was the only company to respond to the sources sought notice stating that they can provide the requested software, install, and conduct training. An FSS search using keywords of MIM software and MIM Encore did not show any companies that sell MIM Encore software or the Cardiac add -ons on FSS contract. A search on GSA eBuy also did not locate any companies that sell MIM Encore software licenses for their base Encore product or for their add-ons.
