B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes FAR 52.219-6 Notice of Total Small Business Set-Aside. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. STATEMENT OF WORK FOR MONTHLY & ANNUAL INSPECTIONS, MAINTENANCE, AND SERVICING OF PORTABLE FIRE EXTINGUISHERS CORPORAL MICHAEL J. CRESCENZ PHILADELPHIA VA MEDICAL CENTER

I. Scope:

The vendor is to provide the Corporal Michael J. Crescenz Philadelphia Veteran's Affairs Medical Center (PVAMC) the scope of work described herein. This scope of work is to include all associated costs for labor, tools, travel, lodging, equipment, components, materials and any other items necessary to inspect approximately 561 fire extinguishers, in accordance with National Fire Protection Association (NFPA), 10 - Portable Fire Extinguisher Maintenance Standard. The fire extinguishers shall be inspected in accordance with the manufacturers' established operating standards. This is a request for a one (1) year contract.

II. Project Specifications:

1. In addition to the general scope of work specifications, each section listed below outlines specific requirements for these sections:
 - a) Monthly inspection of portable fire extinguishers.
 - b) Annual inspection of portable fire extinguishers.

2. The selected vendor must provide a formal written letter with personnel certificates which prove that each employee involved in the performance of the contract is certified to perform inspections on the extinguishers specified in the Statement of Work.
3. The vendor shall possess the licenses required by the State of Pennsylvania and New Jersey to perform all requirements in accordance with the Statement of Work. Evidence of State licenses shall be submitted to the Contracting Officer with the vendor's quote.
4. Each month the vendor will be given a list of all fire extinguishers that require monthly or annual inspecting by the COR or designate. The list will be divided by building and location within the building. Upon completion of the monthly or annual inspections, the vendor shall be responsible for recording all changes made in the field, and return the completed list to the COR at the end of the inspection. In addition, the vendor shall provide the COR with a monthly discrepancy report, listing any fire extinguishers with a discrepancy.
5. Upon completion of all inspections and service work, the vendor's service technician shall provide to the COR a completed service ticket, which includes the following information:
 - a) Purchase order number.
 - b) Number of and type of fire extinguishers inspected.
6. The vendor must complete the NFPA mandated monthly and annual inspections of portable fire extinguishers within the approved NFPA time frame.

III. Security Requirements:

- 1) The vendor's service technician is required to pass screening by Philadelphia Veteran's Affairs Medical Center Police prior to a contractor badge being issued.
- 2) The vendor must supply the same service technicians to the VA and associated Community Based Outpatient Clinics (CBOC) throughout the duration of this contracts performance.

V. Monthly Inspection of Portable Fire Extinguishers:

1. Each individual fire extinguisher shall be inspected each month by the vendor. The inspection shall include entering data into a bar code system.
2. When a deficiency related to the predetermined criteria is identified, the vendor shall note the deficiency on appropriate documentation as determined by the VA.
3. The vendor shall maintain monthly inspection tags on all fire extinguishers that are in service. The inspection tag shall have a legibly notated month and year of the inspection, as well as the inspecting technician's initials.
4. The vendor shall complete a monthly report for all fire extinguishers prior to submitting a service ticket.

VI. Annual Inspection of Portable Fire Extinguishers:

1. Each fire extinguisher shall be subject to an annual inspection in accordance with NFPA 10 standards.
2. As part of the annual inspection and where applicable, the vendor shall perform conductivity testing on carbon dioxide fire extinguisher hoses. Hose assemblies found to be nonconductive shall be replaced with a new assembly via Government purchase card (GPC).
3. At the time of the annual inspection, the vendor shall remove the tamper seal on all rechargeable fire extinguishers by operating the pull pin or locking device. After the applicable maintenance procedures are completed, the vendor shall install a new tamper seal.
4. The vendor shall complete an annual report for all fire extinguishers prior to submitting a service ticket.
5. During the inspection of fire extinguishers, any extinguisher that are identified as having a deficiency other than fire extinguishers requiring testing, the vendor must note the deficiency on appropriate documentation as determined by the VA.

VII. Six-Year Inspection and Hydrostatic Testing of Portable Fire Extinguishers:

1. After the completion of the annual inspection, the vendor shall notify the COR of all fire extinguishers in need of Six-Year Inspections with Hydrostatic Testing.

- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;

“Sensitive technology”—

The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.
