INTRODUCTION

These specifications describe the requirement for procurement, delivery, and installation of twenty-three glassboards for the Leroy Pond Domiciliary, located at the Veterans Health Care System of the Ozarks, Fayetteville, Arkansas. Furniture will be consistent in size and configuration using the description listed below in the salient characteristics.

SCOPE OF WORK

A. OVERVIEW

1. This project shall consist primarily of field verification, receiving, delivery, installation and inspection of all furniture listed.

B. SPECIFICATIONS

1. The suggested manufacturer is Clarus Glassboard or Equivalent.

C. LOCATIONS

1. Items shall be delivered to the Leroy Pond Domiciliary located at 1100 N College Ave, Fayetteville, AR 72703.

D. PRODUCTS / SALIENT CHARACTERISTICS

1. All products must meet all salient characteristics defined in this section.

E. WARRANTY

Material and workmanship to be warranted for a minimum of ten (10) years from date of original invoice, free from defects in material and workmanship.

F. ENVIRONMENTAL INITIATIVES

It is important to the VA that the products provided are manufactured with sustainability and environmental attributes in mind. Aluminum and extruded products for interior and exterior shall feature 75% recycled content. All composite board or hard board products shall be EPP Downstream certified for low formaldehyde content and sustainable practices. All table systems must be manufactured in the United States of America.

G. DELIVERY AND STORAGE

1. COR shall be contacted no less than 2 weeks prior to delivery to schedule installation at the VHSO facility in Fayetteville, AR.
2. Contractor shall conduct delivery and installation between September 18th-29th, 2017, ONLY.
 - a) Attempts to deliver furniture items prior to September 18th will be refused upon arrival.
 - b) The contractor will be responsible for coordinating delivery of items between all involved parties, including the facility COR, the installation contractor and the manufacturer.
3. Delivery and unloading shall be at the Leroy Pond loading docks at 1100 N College Ave, Fayetteville, AR
4. Deliver materials to job in manufacturer's original sealed containers with brand name marked thereon.
5. Package to prevent damage or deterioration during shipment, handling, storage and installation. Maintain protective covering in place and in good repair until removal is necessary.
6. Deliver products only when the site and mounting services are ready for installation work to proceed.
7. Store products in dry condition inside enclosed facilities.
8. Product must ship directly to the Fayetteville, AR Domiciliary. Vendor is prohibited from receiving or storing product on behalf of VA.
9. Vendor installation team shall be present at time of delivery to offload and stage all furniture and equipment in the VA designated location. The facility will not provide staff to assist with this task.

CONTRACTORS RESPONSIBILITIES

I. DESIGN SERVICES, DRAWING & PROCUREMENT REQUIREMENTS

1. The Contractor shall provide Design Services, Procurement and Project Management. The Contractor's Customer Service Representative (CSR) will coordinate layouts and installation as directed by Fayetteville Veterans Health Care System of the Ozarks (VHSO) COR and adhere to the following requirements.

- a) "As Built" Digital Renderings to include measurements and dimensions of glassboards shall be submitted prior to award to ensure items meet technical requirements.
- b) A sample, not less than 3 square inches, of the exposed finish shall be provided, of same thickness and material indicated for the glassboard. Sample(s) shall be submitted within 10 business days of award. If finishes involve normal color and texture variations, include sample sets showing the full range of variations expected.

J. SITE VISITS

1. The Vendor shall coordinate the following site visits with the Fayetteville Veterans Health Care System of the Ozarks (VHSO) COR and the vendor's appointed CSR.

- a) A post-award walkthrough 7 days prior to order placement to field verify all measurements and existing conditions. The contractor shall revise the drawings and quotes to reflect changes due to unforeseen construction conditions or discontinued product.
- b) A post-installation walkthrough upon project completion. The CSR must be present to assess, address, and document any punch-list items.

K. INSTALLATION

1. Installation of glassboards shall be scheduled in one phase.
2. The contractor will be required to install all products solicited under this RFP. The installation team must always have a professional appearance and demeanor. Laborers should display either a company logo or company name badge on his or her attire.
3. All labor is to be furnished by the contractor and must be appropriately estimated.
4. All work is to be completed in the highest level of craftsmanship and in a safe manner and in the allotted time frame.
5. The contractor is to maintain a clean job site during work hours and properly store materials and supplies at the end of each work day. All dust and debris must be cleaned by the contractor- this includes vacuuming and damp mopping when necessary. Cleaning equipment and supplies will be the responsibility of the contractor and will not be provided by the Fayetteville Veterans Health Care System of the Ozarks (VHSO).
6. All packaging and waste is to be recycled and/or legally disposed of by the Contractor.

L. FINAL INSPECTION & ACCEPTANCE

1. The CSR will be required to do a post-installation inspection upon project completion and project sign-off.
2. The CSR will photograph and document all damaged, deficient, defective or mis-ordered/shipped products at the job site and submit them to the manufacturer for repair or replacement.
3. Upon punch-list completion, CSR is to submit to the COR a remediation plan to correct deficiencies within two (2) working days.
4. Contractor will correct deficiencies and punch list items within ten (10) business days after identification, unless deficiency requires fabrication of replacement parts/pieces in which the time allowance will be increased to thirty (30) calendar days for non-readily available or stock items.

M. CLOSE OUT DOCUMENTATION

1. One complete set of documentation, as listed below, shall be provided to the VHSO COR at the completion of installation.

- a) Complete Binder to include product brochures, specified fabric memos samples and technical recommendations for maintenance and service of the Furniture system.

N. PROTECTION OF PROPERTY

1. Contractor shall protect all items from damage. The Contractor shall take precaution against damage to the building(s), grounds and furnishings. The Contractor shall repair or replace any items related to building(s) or grounds damaged accidentally or on purpose due to actions by the Contractor.

O. SECURITY REQUIREMENTS

(4) Clearly describe any modifications the offeror plans to make in a product to make it conform to the solicitation requirements. Mark any descriptive material to clearly show the modifications.

(c) The Contracting Officer will evaluate "equal" products on the basis of information furnished by the offeror or identified in the offer and reasonably available to the Contracting Officer. The Contracting Officer is not responsible for locating or obtaining any information not identified in the offer.

(d) Unless the offeror clearly indicates in its offer that the product being offered is an "equal" product, the offeror shall provide the brand name product referenced in the solicitation.

SECTION E - SOLICITATION PROVISIONS

E.1 52.212-2 EVALUATION—COMMERCIAL ITEMS (OCT 2014)

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

Technical and past performance, when combined, are .

(b) *Options.* The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

E.2 52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS—COMMERCIAL ITEMS (JAN 2017)

The Offeror shall complete only paragraph (b) of this provision if the Offeror has completed the annual representations and certification electronically via the System for Award Management (SAM) Web site located at <https://www.sam.gov/portal>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (u) of this provision.

(a) *Definitions.* As used in this provision—

Administrative merits determination means certain notices or findings of labor law violations issued by an enforcement agency following an investigation. An administrative merits determination may be final or be subject to appeal or further review. To determine whether a particular notice or finding is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

Arbitral award or decision means an arbitrator or arbitral panel determination that a labor law violation occurred, or that enjoined or restrained a violation of labor law. It includes an award or decision that is not final or is subject to being confirmed, modified, or vacated by a court, and includes an award or

decision resulting from private or confidential proceedings. To determine whether a particular award or decision is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

Civil judgment means—

(1) In paragraph (h) of this provision: A judgment or finding of a civil offense by any court of competent jurisdiction.

(2) In paragraph (s) of this provision: Any judgment or order entered by any Federal or State court in which the court determined that a labor law violation occurred, or enjoined or restrained a violation of labor law. It includes a judgment or order that is not final or is subject to appeal. To determine whether a particular judgment or order is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

DOL Guidance means the Department of Labor (DOL) Guidance entitled: “Guidance for Executive Order 13673, ‘Fair Pay and Safe Workplaces’ “. The DOL Guidance, dated August 25, 2016, can be obtained from www.dol.gov/fairpayandsafeworkplaces.

Economically disadvantaged women-owned small business (EDWOSB) concern means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

Enforcement agency means any agency granted authority to enforce the Federal labor laws. It includes the enforcement components of DOL (Wage and Hour Division, Office of Federal Contract Compliance Programs, and Occupational Safety and Health Administration), the Equal Employment Opportunity Commission, the Occupational Safety and Health Review Commission, and the National Labor Relations Board. It also means a State agency designated to administer an OSHA-approved State Plan, but only to the extent that the State agency is acting in its capacity as administrator of such plan. It does not include other Federal agencies which, in their capacity as contracting agencies, conduct investigations of potential labor law violations. The enforcement agencies associated with each labor law under E.O. 13673 are—

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

Highest-level owner means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

Immediate owner means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

Inverted domestic corporation means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

Labor compliance agreement means an agreement entered into between a contractor or subcontractor and an enforcement agency to address appropriate remedial measures, compliance assistance, steps to resolve issues to increase compliance with the labor laws, or other related matters.

Labor laws means the following labor laws and E.O.s:

(2) The Occupational Safety and Health Act (OSHA) of 1970.

(3) The Migrant and Seasonal Agricultural Worker Protection Act.

- (5) 40 U.S.C. chapter 31, subchapter IV, formerly known as the Davis-Bacon Act.
- (6) 41 U.S.C. chapter 67, formerly known as the Service Contract Act.
- (7) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity).
- (8) Section 503 of the Rehabilitation Act of 1973.
- (9) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974.
- (10) The Family and Medical Leave Act.
- (11) Title VII of the Civil Rights Act of 1964.
- (12) The Americans with Disabilities Act of 1990.
- (13) The Age Discrimination in Employment Act of 1967.
- (14) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors).
- (15) Equivalent State laws as defined in the DOL Guidance. (The only equivalent State laws implemented in the FAR are OSHA-approved State Plans, which can be found at www.osha.gov/dcsp/osp/approved_state_plans.html).

Labor law decision means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of “labor laws”.

Manufactured end product means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

“Sensitive technology”—

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

Service-disabled veteran-owned small business concern—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

Small business concern means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

Small disadvantaged business concern, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.
