A.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes VAAR 852.219-11 VA Notice of Total Veteran-Owned Small Business Set-Aside. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Furthermore, if VA determines any services the support contractor(s) will perform in assessing compliance are advisory and assistance services as defined in FAR 2.101, Definitions, the support contractor(s) must also enter into an agreement with the contractor to protect proprietary information as required by FAR 9.505-4, obtaining access to proprietary information, paragraph (b). The contractor is required to cooperate fully and make available any records as may be required to enable the CO to assess the contractor's compliance with the limitations on subcontracting or percentage of work performance requirement.

STATEMENT OF WORK (SOW)

1. Contract Title. Provide emergency all weather call boxes to the Chillicothe VA Medical Center (VAMC) in Chillicothe, OH.

2. Background. These are needed for security and emergency related issues. The increase in the response time from emergency personnel in the event of security risk or emergency situations.

3. Scope. Contractor shall provide eighteen solar-powered emergency call boxes with strobe light stanchions as outlined in this statement of work. They are to be capable of two-way communications with a dispatch center, utilizing the existing medical center Very-High Frequency (VHF) radio system. The contractor shall provide inspection, testing, and optimization services of the Motorola MOTOTRBO XPR 6550 and/or XPR 7550 radios that will be utilized in the call boxes and will be provided by the Chillicothe VAMC. The Chillicothe VAMC will install the call boxes at the locations designated throughout the facility. All items in system must be quoted – no partial quotes, no refurbished equipment.

4. Specific Tasks.

4.1 - Contractor shall provide Call Boxes – Call boxes shall be rugged, vandal resistant, and weatherproof (all weather) enclosure made of tempered aluminum and stainless steel for optimal long-term corrosion resistance and material stability, non-deforming. The call boxes must work seamlessly with the existing Call24 wireless solar callboxes and the customer's Motorola MOTOTRBO DMR system and associated equipment (i.e. MOTOTRBO XPR 4550, MOTOTRBO XPR 7550, and MOTOTRBO MIP 5000 VOIP Dispatch Console. Call boxes shall have the following:

1. A single, large, red push button on the exterior that is fully exposed with 180-degree palm activation access.
2. Louvered audio port openings for voice and speaker volume and clarity. Call box shall have an internal front speaker with low-to-very-loud, clear volume adjustability.
3. Audio ports which are completely-sealed and a perforated, stainless steel protection shield built in to protect the speaker assembly.
4. Self-contained electrical, electronic, and battery components.
5. Secured access to battery, electronic, and electrical components by authorized personnel through a tamper-resistant, stainless steel, hinged front panel which shall be secured by special, security screw fasteners.
6. Tamper resistant antenna built on top of the call box.
7. All major electronic components shall be acrylic plastic coated for added all-weather durability.
8. Visually impaired: Include Grade 2 raised letters and Braille, and an immediate automatic caller greeting, amplified from the front speaker upon push-for-help button activation.
9. Physically impaired: Including complete activation and operation from a single push button. Push button shall have 180-degree palm accessibility. There shall be no door or shield barriers to push button access.
10. Hearing impaired: Include two, large, no less than ½" diameter, front panel, LED call status signal lights. One panel indicator light shall be for signaling to the caller that the call for help has been sent and another light shall be for signaling to the caller that the call for help has been received and help is on the way. At that point, two-way communication shall begin. Large call status wording (like: "call sent" and "call received") shall be placed in respect to the call box's front panel signal lights.

4.2 - Signal Sequence.

Upon the initial push-button activation, the following shall occur:

1. An automatic, programmable voice greeting shall be amplified to the caller. The system shall allow for multiple pre-recorded call types along with custom programmable call box caller greetings.
 2. A light shall illuminate on the call box to indicate that the call-for-help was sent.
 3. A programmable, voice call alert message shall be transmitted, through the radio system, to the security personnel's target base and mobile radio devices. The voice call alert message shall contain the following:
 - a. Programmable prompt identifying the call type (i.e., "assistance needed," "emergency," etc.).
 - b. Physical Location ID.
 - c. Secured Call Box's ID Control Code-Extension Number over the radio channel, embedded in the voice alert announcement.
- 1) Upon receipt of the call-for-help by security, the following shall occur:
- a.) A light shall illuminate on the call box signaling to the caller that their call has been received.
- 2) After security receives the call box call-for-help, the following shall occur:
- a.) Two-way voice communications shall be activated automatically, or:
 - b.) Two-way communications shall be activated once a Secure Access Code is given by Security.
 - c.) Items 1 and 2 shall be field programmable for either mode, based on Owner's needs, without requiring any additional purchases (i.e., firmware or software).
 - d.) Security shall be able to initiate a "hands-free" listen mode while simultaneously maintaining contact with the caller.
- 3) In addition:
- a.) Security shall have the ability to remotely reset/terminate a call at any time without relying solely on an automatic call box reset timer. In addition to the digitally remote controlled call box reset, a programmable call box auto-reset timer shall be enabled to bring the call box to standby mode from all communication and alert modes including talk mode, tamper mode, hands-free listen mode, and test modes.
 - b.) Security shall have the ability to initiate remote control maintenance test, listen, all-call, and select-call features while the call box is in standby and active mode.

4.3 – Pole Stanches. For locations designated as "new pole," provide aluminum, five-inch diameter, round poles that are capped with electrical hand-hole access. Poles shall be a minimum of 12 feet above finished grade and anchor-mounted into concrete. All galvanized anchor J-bolts, nuts, washers, and aluminum bolt-head caps shall be included. Poles shall be powder-coat gloss sandstone finish.

1. Securely mount the call box to the round pole with an aluminum powder-coated
2. Round pole mounting bracket of the same color as call box finish. Do not use banding. Mount per manufacturer's requirements.

4.4 – Locator Lighting and Strobe. Locator Lighting and Strobe shall be in compliance with the following:

1. Provide call box that operates with the True-Blue LED Locator lighting and strobe options from one, solar power source. Lights shall be powered and controlled by the call box.
2. Provide a True-Blue LED Locator Light Array/Beacon and High Intensity Blue Flash Strobe light that is designed into one self-contained, all-weather assembly with matching Lexan Fresnel lens.
3. The True-Blue LED night light beacon shall include a 15 LED True-Blue array, rated for 100,000 hour burn time, and controlled with a built-in call box photoelectric sensor.
4. The High Intensity Blue Strobe shall have a 60 fpm (flash per minute) rate at 250,000 Candle-power and shall be triggered automatically when the push-for-help button is activated. When the tamper alarm mode is activated, the call box shall be field programmable to either activate the Strobe ON or OFF. For example: Strobe ON in Tamper shall immediately start flashing the instant a tamper alarm is activated. The Strobe shall be Turned On (programmable) in the remotely controlled test mode.
5. For any alternative locations being mounted to light poles end up being mounted to an existing light pole, provide the LED True-Blue Night Light and High Intensity Blue Strobe in a self-contained, side-mount, all-weather aluminum fixture. The fixture shall be adaptable to any round light pole or for a flat square pole or wall surface.
6. For stanchions, provide the True-Blue LED Night Light and High Intensity Blue Flash Strobe Light in a self-contained, all-weather, 360-degree fixture for mounting atop a pole for maximum visibility. To conserve battery power, the BlueStar™ light shall operate from dusk to dawn when powered from solar.
7. The strobe light shall be programmable ON or OFF during any of the seven, call boxes call alert activations (i.e., Call Types). Contractor to document each configuration with Owner and provide programming. For example:
 - a. Emergency Call Button – Strobe can be programmed to come ON during activation.
 - b. Information/Escort/Shuttle – Call Button can be programmed OFF so it does not fire during this type of call. The same shall apply for all call-types.

4.5 – Highly Visible Reflective Identification To include the following:

1. Clearly label call boxes with large, easy-to-read reflective identification text. Text instructions shall not be blocked from open view (for example: from an enclosure door or shield). The call box device shall be easily recognized using bold, highly-reflective, all weather grade material. At a minimum, decal markings shall cover call box front and sides.
2. Provide call box stanchions with large, no less than 46 inch long, reflective pole markings to read in bold "EMERGENCY," "ASSISTANCE," or "EMERGENCY CALLBOX" text.
3. Confirm text with Owner prior to ordering.

4.6 – Solar Supply Charge. The Solar Supply Charge shall be provided a SunCharge™ power supply system that maintains battery back-up power to the call box station ongoing. The self-contained SunCharge™ shall support all standard call box functions and standard options. And shall be in compliance with the following:

1. The call box shall directly accommodate clean, 12 VDC supply voltage to power the call box.
2. All call box wiring, power supplies, battery, fuses, and regulator shall be self-contained within the call box enclosure.
3. Provide each call box with one, 12 VDC, rechargeable, Gel-Cell battery with an expected life of approximately two to three years.
4. The call box shall transmit a call-alert voice message notifying a battery maintenance condition over the radio channel .
5. The battery maintenance alert shall indicate that servicing of the power supply, charging circuit, or back-up battery is needed.
6. Batteries
 - a. All power backup batteries shall be self-contained inside the call box enclosure's low voltage compartment - protected by the tamper alarm.
 - b. The call box's control board shall have protective, quick burn fuses and a buzzer that shall instantly and audibly notify the Contractor that they are attempting to reverse the battery cables.
 - c. Call box shall remain operable for a minimum of 18 to 24 hours after sending the first battery maintenance alert. The control board shall enable a load shedding priority to call box components when under low-battery conditions.

4.7 – Programming, Alarming, and Set-Up.

1. All call boxes shall be delivered with all control board data and voice alarming parameters pre-programmed, radio channels pre-programmed, solar power supplies pre-installed, and self-contained in accordance to the Owner's requirements.
2. Tamper Alert shall fire the strobe (programmed ON) in the tamper mode and the tamper sensitivity shall be adjustable. A programmable Auto-Broadcast over the front call box speaker shall activate after a tamper alarm is activate warning the person to step away.
3. An internal call box auxiliary trigger relay is to be installed and activated when the push button is triggered for any local security alarm integration.
4. Recognized Testing Laboratory Certification.

The certificate of compliance is to be supplied from a "recognized and authorized" 3rd party testing laboratory such as Met Lab, ETL, and UL. The certification of compliance must indicate that the call box model number(s) offered are tested and officially listed for use in the United States by the recognized third party testing laboratory.

4.8 – Testing.

1. Test all functions on system for proper functions and operations
2. All initial software programming shall be provided
3. Inspect, test, and repair Owner supplied radios as necessary
4. Install Owner supplied radios and supply with call boxes

5. Place of Performance

The place of performance shall be at the Chillicothe VAMC, 17273 State Route 104, Chillicothe, Ohio 45601.

6. Period of Performance.

The start date for this project shall be 60 calendar days after the award of the contract. The end date shall be no later than 90 calendar days after the start date

7. Submittals.

Complete operating and maintenance manuals including wiring diagrams, technical data sheets and information for ordering replaceable parts:

1. Include complete list indicating all components of the systems.
2. Include complete diagrams of the internal wiring for each item of equipment.
3. Diagrams shall have their terminals identified to facilitate installation, operation and maintenance.

SECTION E - SOLICITATION PROVISIONS

(b) *Options.* The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

(End of Provision)

E.2 52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS—COMMERCIAL ITEMS (JAN 2017)

The Offeror shall complete only paragraph (b) of this provision if the Offeror has completed the annual representations and certification electronically via the System for Award Management (SAM) Web site located at <https://www.sam.gov/portal>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (u) of this provision.

(a) *Definitions.* As used in this provision—

Administrative merits determination means certain notices or findings of labor law violations issued by an enforcement agency following an investigation. An administrative merits determination may be final or be subject to appeal or further review. To determine whether a particular notice or finding is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

Arbitral award or decision means an arbitrator or arbitral panel determination that a labor law violation occurred, or that enjoined or restrained a violation of labor law. It includes an award or decision that is not final or is subject to being confirmed, modified, or vacated by a court, and includes an award or

decision resulting from private or confidential proceedings. To determine whether a particular award or decision is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

Civil judgment means—

(1) In paragraph (h) of this provision: A judgment or finding of a civil offense by any court of competent jurisdiction.

(2) In paragraph (s) of this provision: Any judgment or order entered by any Federal or State court in which the court determined that a labor law violation occurred, or enjoined or restrained a violation of labor law. It includes a judgment or order that is not final or is subject to appeal. To determine whether a particular judgment or order is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

DOL Guidance means the Department of Labor (DOL) Guidance entitled: “Guidance for Executive Order 13673, ‘Fair Pay and Safe Workplaces’ “. The DOL Guidance, dated August 25, 2016, can be obtained from www.dol.gov/fairpayandsafeworkplaces.

Economically disadvantaged women-owned small business (EDWOSB) concern means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

Enforcement agency means any agency granted authority to enforce the Federal labor laws. It includes the enforcement components of DOL (Wage and Hour Division, Office of Federal Contract Compliance Programs, and Occupational Safety and Health Administration), the Equal Employment Opportunity Commission, the Occupational Safety and Health Review Commission, and the National Labor Relations Board. It also means a State agency designated to administer an OSHA-approved State Plan, but only to the extent that the State agency is acting in its capacity as administrator of such plan. It does not include other Federal agencies which, in their capacity as contracting agencies, conduct investigations of potential labor law violations. The enforcement agencies associated with each labor law under E.O. 13673 are—

- (vi) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors);

(2) Department of Labor Occupational Safety and Health Administration (OSHA) for—

- (i) The Occupational Safety and Health Act of 1970; and
- (ii) OSHA-approved State Plans;

(3) Department of Labor Office of Federal Contract Compliance Programs (OFCCP) for—

(i) Section 503 of the Rehabilitation Act of 1973;

(ii) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974; and

(iii) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity);

(4) National Labor Relations Board (NLRB) for the National Labor Relations Act; and

(5) Equal Employment Opportunity Commission (EEOC) for—

(i) Title VII of the Civil Rights Act of 1964;

(ii) The Americans with Disabilities Act of 1990;

(iii) The Age Discrimination in Employment Act of 1967; and

(iv) Section 6(d) of the Fair Labor Standards Act (Equal Pay Act).

Forced or indentured child labor means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

Highest-level owner means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

Immediate owner means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

Inverted domestic corporation means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

Labor compliance agreement means an agreement entered into between a contractor or subcontractor and an enforcement agency to address appropriate remedial measures, compliance assistance, steps to resolve issues to increase compliance with the labor laws, or other related matters.

Labor laws means the following labor laws and E.O.s:

(1) The Fair Labor Standards Act.

(2) The Occupational Safety and Health Act (OSHA) of 1970.

(3) The Migrant and Seasonal Agricultural Worker Protection Act.

- (4) The National Labor Relations Act.
- (5) 40 U.S.C. chapter 31, subchapter IV, formerly known as the Davis-Bacon Act.
- (6) 41 U.S.C. chapter 67, formerly known as the Service Contract Act.
- (7) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity).
- (8) Section 503 of the Rehabilitation Act of 1973.
- (9) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974.
- (10) The Family and Medical Leave Act.
- (11) Title VII of the Civil Rights Act of 1964.
- (12) The Americans with Disabilities Act of 1990.
- (13) The Age Discrimination in Employment Act of 1967.
- (14) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors).
- (15) Equivalent State laws as defined in the DOL Guidance. (The only equivalent State laws implemented in the FAR are OSHA-approved State Plans, which can be found at www.osha.gov/dcsp/osp/approved_state_plans.html).

Labor law decision means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of “labor laws”.

Manufactured end product means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

Service-disabled veteran-owned small business concern—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

Small business concern means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

Small disadvantaged business concern, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

(1) Is at least 51 percent unconditionally and directly owned (as defined at 13 CFR 124.105) by—

(i) One or more socially disadvantaged (as defined at 13 CFR 124.103) and economically disadvantaged (as defined at 13 CFR 124.104) individuals who are citizens of the United States; and

(ii) Each individual claiming economic disadvantage has a net worth not exceeding \$750,000 after taking into account the applicable exclusions set forth at 13 CFR 124.104(c)(2); and

(2) The management and daily business operations of which are controlled (as defined at 13.CFR 124.106) by individuals, who meet the criteria in paragraphs (1)(i) and (ii) of this definition.

Subsidiary means an entity in which more than 50 percent of the entity is owned—

(1) Directly by a parent corporation; or

(2) Through another subsidiary of a parent corporation.

Successor means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

Veteran-owned small business concern means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(2) The management and daily business operations of which are controlled by one or more veterans.

Women-owned small business (WOSB) concern eligible under the WOSB Program (in accordance with 13 CFR part 127), means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.

[](i) There has been no administrative merits determination, arbitral award or decision, or civil judgment for any labor law violation(s) rendered against the offeror (see definitions in paragraph (a) of this section) during the period beginning on October 25, 2015 to the date of the offer, or for three years preceding the date of the offer, whichever period is shorter; or

[](ii) There has been an administrative merits determination, arbitral award or decision, or civil judgment for any labor law violation(s) rendered against the Offeror during the period beginning on October 25, 2015 to the date of the offer, or for three years preceding the date of the offer, whichever period is shorter.

(3)(i) If the box at paragraph (s)(2)(ii) of this provision is checked and the Contracting Officer has initiated a responsibility determination and has requested additional information, the Offeror shall provide--

(A) The following information for each disclosed labor law decision in the System for Award Management (SAM) at www.sam.gov, unless the information is already current, accurate, and complete in SAM. This information will be publicly available in the Federal Awardee Performance and Integrity Information System (FAPIS):

(1) The labor law violated.

(2) The case number, inspection number, charge number, docket number, or other unique identification number.

(3) The date rendered.

(4) The name of the court, arbitrator(s), agency, board, or commission that rendered the determination or decision;

(B) The administrative merits determination, arbitral award or decision, or civil judgment document, to the Contracting Officer, if the Contracting Officer requires it;

(C) In SAM, such additional information as the Offeror deems necessary to demonstrate its responsibility, including mitigating factors and remedial measures such as offeror actions taken to address the violations, labor compliance agreements, and other steps taken to achieve compliance with labor laws. Offerors may provide explanatory text and upload documents. This information will not be made public unless the contractor determines that it wants the information to be made public; and

(D) The information in paragraphs (s)(3)(i)(A) and (s)(3)(i)(C) of this provision to the Contracting Officer, if the Offeror meets an exception to SAM registration (see FAR 4.1102(a)).

(ii)(A) The Contracting Officer will consider all information provided under (s)(3)(i) of this provision as part of making a responsibility determination.

(B) A representation that any labor law decision(s) were rendered against the Offeror will not necessarily result in withholding of an award under this solicitation. Failure of the Offeror to furnish a representation or provide such additional information as requested by the Contracting Officer may render the Offeror nonresponsible.

(C) The representation in paragraph (s)(2) of this provision is a material representation of fact upon which reliance was placed when making award. If it is later determined that the Offeror knowingly rendered an erroneous representation, in addition to other remedies available to the Government, the Contracting Officer may terminate the contract resulting from this solicitation in accordance with the procedures set forth in FAR 12.403.

(4) The Offeror shall provide immediate written notice to the Contracting Officer if at any time prior to contract award the Offeror learns that its representation at paragraph (s)(2) of this provision is no longer accurate.

(5) The representation in paragraph (s)(2) of this provision will be public information in the Federal Awardee Performance and Integrity Information System (FAPIS).

Note to paragraph (s): By a court order issued on October 24, 2016, this paragraph (s) is enjoined indefinitely as of the date of the order. The enjoined paragraph will become effective immediately if the court terminates the injunction. At that time, DoD, GSA, and NASA will publish a document in the **Federal Register** advising the public of the termination of the injunction.

(t) *Public Disclosure of Greenhouse Gas Emissions and Reduction Goals.* Applies in all solicitations that require offerors to register in SAM (52.212-1(k)).

(1) This representation shall be completed if the Offeror received \$7.5 million or more in contract awards in the prior Federal fiscal year. The representation is optional if the Offeror received less than \$7.5 million in Federal contract awards in the prior Federal fiscal year.

(2) Representation. [Offeror to check applicable block(s) in paragraph (t)(2)(i) and (ii)]. (i) The Offeror (itself or through its immediate owner or highest-level owner) [] does, [] does not publicly disclose greenhouse gas emissions, i.e., makes available on a publicly accessible Web site the results of a greenhouse gas inventory, performed in accordance with an accounting standard with publicly available and consistently applied criteria, such as the Greenhouse Gas Protocol Corporate Standard.

(ii) The Offeror (itself or through its immediate owner or highest-level owner) [] does, [] does not publicly disclose a quantitative greenhouse gas emissions reduction goal, i.e., make available on a publicly accessible Web site a target to reduce absolute emissions or emissions intensity by a specific quantity or percentage.

(iii) A publicly accessible Web site includes the Offeror's own Web site or a recognized, third-party greenhouse gas emissions reporting program.

(3) If the Offeror checked "does" in paragraphs (t)(2)(i) or (t)(2)(ii) of this provision, respectively, the Offeror shall provide the publicly accessible Web site(s) where greenhouse gas emissions and/or reduction goals are reported:_____.

(u)(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235) and its successor provisions in subsequent appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(2) The prohibition in paragraph (u)(1) of this provision does not contravene requirements applicable to Standard Form 312 (Classified Information Nondisclosure Agreement), Form 4414 (Sensitive Compartmented Information Nondisclosure Agreement), or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(3) Representation. By submission of its offer, the Offeror represents that it will not require its employees or subcontractors to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting waste, fraud, or abuse related to the performance of a Government contract to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information (e.g., agency Office of the Inspector General).
