### **E.4 52.212-2 EVALUATION- COMMERCIAL ITEMS (OCT 2014) Addendum to 52.212-2, Basis for Award**

Offers will be evaluated on the basis of Lowest Priced Technically Acceptable. The evaluation process shall proceed as follows.

1. Initially, offers shall be rank according to price. An offeror's proposed price will be determined by multiplying the quantities identified in the pricing schedule by the proposed unit price for each contract

line item to confirm the extended amount for each item. The extended amounts will be added together to determine the total evaluated price.

2. Next, the lowest priced offer shall be evaluated for technical acceptability. This is a Brand Name or Equal requirement. Technical acceptability shall be evaluated on a pass/fail basis considering whether the proposed product meets or exceeds the salient characteristics of the manufacturer in Section D.

3. If the lowest priced offer is determined technically acceptable, that offer represents the best value to the government and the evaluation process stops at this point. Award shall be made to that offeror without further consideration of any other offers.

4. If the lowest priced offer is not determined technically acceptable, the next lowest priced offer will be evaluated for technical acceptability and the process will continue in order by price until an offer is judged technically acceptable.
