The department of neurology has utilized two other brands of neuro-diagnostic products in the past. Nichon Kohden (EEG machine) was a good product; however the VISN mandated the switch to Natus because the Nichon Kohden machine could not be connected to the review station via the VA network, citing security concerns. The department also had a Cadwell EMG machine that had performance issues and froze during studies only two years after the purchase. The Natus brand is compatible with our network and has proven to be a reliable product

These are “direct replacements” parts/components for existing equipment.

One (1) EEG machine is unrepairable and the other does not have the required software.

The VISN mandated the switch to Natus because the Nichon Kohden machine could not be connected to the review station via the VA network, citing security concerns

The new work is a logical follow-on to an original Federal Supply Schedule order provided that the original order was placed in accordance with the applicable Federal Supply Schedule ordering procedures. The original order must not have been previously issued under sole source or limited source procedures.

An urgent and compelling need exists, and following the ordering procedures would result in unacceptable delays.

The current EEG and Ambulatory EEG machines operate on Windows XP, which is no longer supported. One (1) of the EEG machines has crashed and is not repairable and the other EEG machine does not have the new required software to run the Ambulatory EEGs.

The department of neurology has utilized two other brands of neuro-diagnostic products in the past. Nichon Kohden (EEG machine) was a good product; however, the VISN mandated the switch to Natus because the Nichon Kohden machine could not be connected to the review station via the VA network, citing security concerns. The department also had a Cadwell EMG machine. The Cadwell was not a good product; it started to freeze during studies only two years after the purchase. The Natus product is compatible with our network and is a reliable product.
