

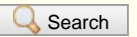

At the University Drive Division, the laboratory is located in Building 1, Second Floor. It is open and appropriately staffed 24 hours a day, 7 days a week. Outpatient phlebotomy service is available in 1N142 Monday through Friday, from 8:00 a.m. to 4:00 p.m. Wednesday 8:00 a.m. – 6:00 p.m. Closed on holidays; inpatient phlebotomy service – AM blood work only.
