VAPAHCS Market research was not conducted because we are using the authority of 38 U.S.C. 8127 and 8128, Sections 502 and 503 of Public Law (PL) 109-461 and VAAR 819.7007, which allows the VA to make a sole source award to a SDVOSB. Additionally, Vocera is the only company that offers the maintenance upgrades and support for its product. Government Marketing and Procurement LLC is the only company Vocera gives rights to allow to work on their system. This is the only hands-free medical device and support service that meets the needs of the government and is not accessible through any other businesses. The addition of 75 Vocera units with warranties and training is an extension of a "major system" of which there would be both a substantial duplication of cost to the government that is not expected to be recovered through competition and there would be unacceptable delays in fulfilling the agency's requirements.
