

JUSTIFICATION FOR SINGLE SOURCE AWARDS IAW FAR 13.106-1
(OVER MICRO-PURCHASE THRESHOLD(\$3K) BUT NOT EXCEEDING THE SAT (\$150K))

IAW [FAR13.104](#), COs must promote competition to the maximum extent practicable to obtain supplies and services from the source whose offer is the most advantageous to the Government, considering the administrative cost of the purchase. When competition is not practicable, IAW [FAR13.106-1\(b\)](#), COs solicit from a single source for purchases not exceeding the simplified acquisition threshold. 2. BRIEF DESCRIPTION OF SUPPLIES OR SERVICES REQUIRED AND THE INTENDED USE:

Request the purchase of brand name Swift Space furniture to maintain the conformity and appearance throughout our main Dublin, GA facility and community clinics. This purchase will fulfill the Carl Vinson VAMC's requirements for standardization of equipment as per the VHA Handbook 1761.1. This will significantly improve the ability to provide a consistent quality of care to our Veterans across the organization and will improve the organizations ability to be able to provide routine changes in space occupancy and movement of organizations.

3. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:

The VA is seeking to purchase brand name Swift Space Unified Work Centers. Complete integrated workstation mobile desks that ship fully assembled and can be delivered by one single individual. Accessories are packed separately and place in the field. Workstations are compact in their unused storage position and require no tools to assemble. These are work centers that are folded up into a 3' x 66" to 72" box shaped footprint. Easily stored and delivered within 10 minutes. No other manufacture has ever been known to be on the market that equal the capability of the brand name Swift Space.

Warranty

Other than casters and hinges which have a minimum warranty of five years, the remainder of the Product shall have a a limited lifetime warranty.

Construction:

Frame is constructed of 40mm lightweight grey recycled content aluminum

Clear Polycarbonate Upper panels are made of 4mm Twin Wall Construction

Lower panels are made from 4mm melamine panels.

Fabric Panels are constructed of 100% recycled PET

Tops are 25mm thick high pressure laminate with a 45lb density particle board core and 2mm edging

Casters are 63.5mm in diameter with grey rubber wheels that swivel and Lock.

Tackable fabric panels are enhanced for acoustics and made from 100% post consumable materials.

Carl Vinson VA Medical Center will standardize on a large percentage of work areas throughout with Swift Space integrated work centers where possible to provide cost effective solutions to support on time needs and demands.
