Description

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in FAR Subpart 12.6 in conjunction with Part 13, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation for this action. Quotes are being requested, and a written solicitation will not be issued.

This solicitation is issued as a Request for Quote (RFQ). This solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2005-95 effective January 19, 2017.

The Network Contracting Office 8-SAO East intends to award a fixed-priced requirements contract. Temporary lodging service is required Sunday through Thursday, consisting of fifteen (15) hotel/motel rooms and three (3) American with Disabilities Act (ADA) compliant single occupancy rooms per day for authorized eligible veterans in accordance with the below Statement of Work and Pricing Schedule.

Set-Aside Requirement: The Government reserves the right to make no award from this solicitation.

Any award resulting from this solicitation will be made using the following cascade set-aside procedures per VHA memorandum #17-09, June 21, 2017

In compliance with 38 U.S.C. 8127

The evaluation of offers received in response to the solicitation will use a tiered or cascading order of precedence. "tiered evaluation of offers," also known as "cascading evaluation of offers," is a procedure used in negotiated acquisitions when market research is inconclusive for justifying limiting competition to small business concerns or sub-categories of small business concerns. The contracting officer-

- (1) Solicits offers from both small and other than small business concerns that will be evaluated in the following tier order:
 - (a) Service-disabled veteran-owned small business (SDVOSB);
 - (b) Veteran-owned small business (VOSB);
 - (c) All other small business concerns;
 - (d) Other than small business.
- (2) If an award or a sufficient number of awards cannot be made at the first tier, evaluation of offers will proceed at the next lower tier until an award or a sufficient number of awards can be made.

Prospective offerors must be a registered hotel and/or conference center in System for Award Management (SAM) at <http://www.sam.gov> to be considered for an award of a federal contract, and registration must be complete and not missing elements such as representations and certifications. For tiered evaluation purposes, to be considered as a Service Disabled Veteran Owned Small Business (SDVOSB) or Veteran Owned Small Business (SDVOSB), prospective offerors must be a verified VOSB concern in the VA Center for Verification and Evaluation (CVE) Veteran Information Pages (VIP) pages <https://www.vip.vetbiz.gov/> at the date and time set for receipt of offers.

Quotes received after this date and time will be considered late in accordance with 52.212-1(f) and will not be evaluated. Quotes shall be sent by e-mail "only" to the Contracting Officer (Annette Whitfield-Johnson) at annette.whitfield@va.gov. The Government will award a requirements contract resulting from this RFQ to the responsible hotel and/or conference center whose quote is the lowest price technically acceptable (LPTA) offer utilizing the above cascade set-aside procedures. ***Vendors are required to follow the Instructions to Quoters on pages 47-51 of this Synopsis/Solicitation RFQ.**

C. Statement of Work

Temporary Lodging Service

1. **Scope of Work:** The Department of Veterans Affairs, Bay Pines Healthcare System requires 24/5, Sunday through Thursday temporary lodging services for authorized eligible veterans. The contractor shall provide fifteen (15) furnished hotel/motel rooms per day and three (3) American with Disabilities Act (ADA) compliant single occupancy rooms. Complimentary non-wheelchair transportation service is requested between the hotel/motel and the C.W. Bill Young VAMC (hereinafter CWBYVAMC) for veterans who may need transportation.
2. **Place of Performance:** Hotel/motel shall be located within 15 miles or 30-minutes radius of CWBYVAMC, located at 10000 Bay Pines Blvd., Bay Pines, FL 33744. The hotel/motel shall be rated at three (3) stars or above on www.tripadvisor.com.
3. **Period of Performance:** The period of performance will begin October 1, 2017 through September 30, 2017, with four (4) one-year option periods.
4. **Type of Contract:** This shall be a Firm Fixed Price (FFP) contract, with quotes being evaluated utilizing the Low Price Technically Acceptable (LPTA) methodology.
5. **Background:** The temporary lodging service is designated for eligible Veterans receiving VA health care services to include Compensation and Pension examinations. Veterans using this benefit shall be medically stable and capable of self-care. The veteran shall be able to stay in an unsupervised setting or be accompanied by a caregiver that can provide the necessary care needed.

The rooms are to accommodate those veterans who may have to travel long distances for evaluation before, during, and after treatment received, (i.e., for less than 24-hour pre-operative/intervention or post-operative follow-up for Ambulatory Surgery, Nuclear Medicine, MRI, GI, ophthalmology, oncology, and other medical specialties as the need arises). Only patients normally discharged to their home will be considered for lodging. Room cost shall be consisted with Federal Travel Regulation (FTR) which can be found at <http://www.gsa.gov/portal/content/104790>.

6. **Room Requirements:**
 - a. Daily room rates shall include all applicable taxes, fees, and any other no-charge services offered to guests of the hotel/motel. Rooms shall provide a minimum of 15 furnished rooms per day and 3 ADA compliant single occupancy rooms for authorized eligible veterans. All ADA rooms shall comply with NFPA 101 and ADA guidelines.
 - b. The fully furnished hotel/motel rooms shall include contractor provided utilities and other specified services (minimum of TV, clock radio, refrigerator and local phone access (no deposits required)).
 - c. The hotel/motel rooms shall comply with all city, county and state building codes and ordinances applicable to the ownership and operation of the building in which the rooms are located.
 - d. All rooms shall be non-smoking rooms. As these rooms are contracted by the CWBYVAMC and are non-smoking rooms, smoking will not be permitted in these rooms. Anyone found doing so would be barred from the Lodgetel Program. The Offeror will provide a “designated smoking area” with proper signage. No liquor, drugs, or disrupted behavior will be tolerated in these rooms at any time, as they are contracted by the CWBYVAMC and

anyone found doing so will be asked to leave and will be barred from The Lodgetel Program. Any damages or cleaning cost will be at the Veterans expense.

- e. Rooms must be neat and clean upon Veterans check-in.
- f. Contractor shall supply all utilities including heat, air conditioning, electricity, water and sewer, and basic television cable service.
- g. Rooms shall allow service animals.

7. **Room Availability:** Contractor shall guarantee the availability of eighteen (18) rooms per night. If all required temporary lodging rooms are not reserved by 4:00pm, the contractor may release all except two (2) rooms. The CWBYVAMC shall not be financially obligated or billed for unoccupied rooms.

8. **Room Reservations:**

- a. The Contractor shall allow contracted rooms to be occupied only by specific individual referred by the Lodgetel Coordinator or designee of the CWBYVAMC. The Lodgetel Coordinator or designee will inform the Contractor of each individual veteran name and the expected arrival time at the Contractor's motel/hotel.
- b. Services shall be performed twenty-four (24) hours per day, five (5) days per week. The Contractor shall use check in and check out times agreed upon by CWBYVAMC and Contractor.
- c. Services shall be provided on all 10 Federal Holidays, observed by the Federal Government, plus any other day specifically declared by the President of the United States:

New Year's Day	Labor Day
Martin Luther King Jr. Day	Columbus Day
Presidents' Day	Veterans Day
Memorial Day	Thanksgiving Day
Independence Day	Christmas Day

- d. The authorized dates and length of stay will be documented on the CWBYVAMC authorization sheets and faxed to the Contractor by the Lodgetel Coordinator or designee. In the event that a VA referred occupant refuses to leave the room, the Contractor shall immediately notify the Lodgetel Coordinator or designee. In addition, if a VA referred occupant checks out of the hotel/motel without prior notice from the VA, the Contractor shall immediately notify the Lodgetel Coordinator or designee at the VA.
- e. Each business day this facility and the contractor will reconcile the number of rooms in use, names of authorized individuals and their assigned room numbers. This will be done via email between the contractor and the Lodgetel Coordinator or designee.
- f. The VA will not be charged for same day cancellations until 4:30 pm eastern time.

9. **Patient Emergencies:** In the event a VA referred occupant is in an emergency situation of any kind, the Contractor shall contact the 911 emergency medical services to respond to the emergency. Once the emergency has ended the Contractor shall notify the Lodgetel Coordinator or designee at the VA of the situation.

10. **General Building Requirements and Specifications:**

a. Telephone Service Requirements:

- (1) Contractor shall provide local area, touch-tone, telephone service (no deposit required) for each room with long distance lockout to prevent additional charges to the room. The telephone service may be capable of long distance telephone service when long distance calls are placed using a telephone calling card or other telephone charge method.
- (2) Telephone service shall be equipped with messaging system or front desk message service.

b. Fire Safety:

- (1) Buildings in which space is offered shall be evaluated in accordance with latest editions of the
 - a. The standards of the Life Safety Code (National Fire Protection Association (NFPA) #101);
 - b. The fire and safety code imposed by the State Law; and
 - c. City, State, and Federal requirements concerning licensing and health codes
- (2) Equipment, services, or utilities furnished and activities of other occupants shall be free of safety, health, and fire hazards. When hazards are detected, the contractor shall promptly correct hazards.
- (3) Maintenance of contractor-owned fire extinguishers shall be provided by the contractor in accordance with NFPA Standard No. 101.
 - a. As required by code, smoke detectors/alarms shall be installed in each room, office, storage area, hallways and other common areas.
- (4) Wheelchair Accessibility: Rooms will be wheelchair accessible. Common areas such as hallways shall provide for accessible path of travel for wheelchairs.
- (5) Elevators: If elevators are a part of the room complex, they shall conform to the latest requirements of the American National Standard A171 and A171a Safety Code for Elevators, except for elevator emergency recall and shall be inspected and maintained in accordance with American National Standard A17.1, Inspector's Manual for Elevators or equivalent local code. The elevators shall also comply with local codes and ordinances.
- (6) Miscellaneous: No activity to the building and/or grounds that would cause an increase in dust, dirt or spores to be airborne (i.e., renovation to the building, movement of earth on the grounds) shall take place without the contractor's written notification to the VA at least seven (7) calendar days in advance of the event.
- (7) Inspection: The Government reserves the right, at any time before and after contract award and during the term of the contract, to inspect the rooms and all other areas of the complex access to which is necessary to ensure a safe and healthy environment for the VA referred occupants.

11. **Quality Assurance:** Contractor shall have an on-going quality assurance program designed to objectively and systematically monitor and evaluate the quality and cleanliness of rooms, accessibility and resolve identified problems. The written plan shall delineate the objective of the quality assurance activities, scope of the activities, activities for monitoring and evaluation, methods for reporting results, mechanisms for taking follow-up action and responsibilities of staff for each activity of the quality assurance program. The objectives, scope, organization, and effectiveness of the quality assurance plan shall be evaluated at least annually and revised as necessary.

a. Reports

(1) Contractor shall provide to the Contracting Officer’s Representative (COR) or contracting office, monthly reports on their customer service surveys to include outline of any specific issues/problems for that month along with their solutions to correct any issues.

(2) Contractor shall provide to the COR quarterly activity reports, with the following information:

- Number of complaints regarding wheelchair (special mode) accessibility noted by veterans, and/or, others who accompany a veteran and provide equivalent of familial support
- Number of complaints regarding rooms not clean upon check-in noted by Veterans, and/or, others who accompany veterans and provide equivalent of familial support
- Number of complaints noting none working available electronic equipment in veterans’ room such as the clock alarm, lighting, television, etc.

12. **Customer Service:** The Contractor shall provide all complaints noted by veterans, and/or, others who accompany the veteran and provide equivalent of familial support. Contractor shall develop a customer service survey form to be completed by the customer. This shall be part of the Contractor’s Quality Assurance Program.

13. Invoices: The Contractor will furnish with invoice, signed documented proof that services have been rendered in accordance with this contract. Room charges are only for actual room use. Invoices shall be submitted monthly in arrears. Invoices shall not exceed the authorized contract rate and shall not include tax, as the Federal Government is tax exempt.

14. Payment: All payments by the Government to the Contractor will be made in accordance with FAR 52.232-34, Payment by Electronic Funds Transfer – Other Than System for Award Management. Payment will be made in arrears upon receipt of a properly prepared invoice. Payment shall be rendered for actual room charges only.

D. Contract Administration

The Contracting Officer is the only person authorized to approve changes or modify any of the requirements under this contract. The Contractor shall communicate with the Contracting Officer on all matters pertaining to contract administration. Only the Contracting Officer is authorized to make commitment or issue changes that will affect price, quantity or quality of performance of this contract. In the event the Contractor effects any such change at the direction of any person other than the Contracting Officer, the change shall be considered to have been made without authority and no adjustment will be made in the contract price to cover any increase in cost incurred thereof.

52.216-18 – Ordering (OCT 1995)

(a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from the date of award through sixty months.

(b) All delivery orders or task orders are subject to the terms and conditions of this contract. In the event of conflict between a delivery order or task order and this contract, the contract shall control.

(c) If mailed, a delivery order or task order is considered “issued” when the Government deposits the order in the mail. Orders may be issued orally, by facsimile, or by electronic commerce methods only if authorized in the Schedule.

(End of Clause)

52.216-19 ORDER LIMITATIONS (OCT 1995)

(a) *Minimum order.* When the Government requires supplies or services covered by this contract in an amount of less than \$2,500.00, the Government is not obligated to purchase, nor is the Contractor obligated to furnish, those supplies or services under the contract.

(b) *Maximum order.* The Contractor is not obligated to honor—

(1) Any order for a single item in excess of (To Be Determined);

(2) Any order for a combination of items in excess of (To Be Determined); or

(3) A series of orders from the same ordering office within 30 days that together call for quantities exceeding the limitation in paragraph (b)(1) or (2) of this section.

(c) If this is a requirements contract (i.e., includes the Requirements clause at subsection 52.216-21 of the Federal Acquisition Regulation (FAR)), the Government is not required to order a part of any one requirement from the Contractor if that requirement exceeds the maximum-order limitations in paragraph (b) of this section.

(d) Notwithstanding paragraphs (b) and (c) of this section, the Contractor shall honor any order exceeding the maximum order limitations in paragraph (b), unless that order (or orders) is returned to the ordering office within 30 days after issuance, with written notice stating the Contractor's intent not to ship the item (or items) called for and the reasons. Upon receiving this notice, the Government may acquire the supplies or services from another source.

52.216-21 -- Requirements (OCT 1995)

(a) This is a requirements contract for the supplies or services specified, and effective for the period stated, in the Schedule. The quantities of supplies or services specified in the Schedule are estimates only and are not purchased by this contract. Except as this contract may otherwise provide, if the Government's requirements do not result in orders in the quantities described as "estimated" or "maximum" in the Schedule, that fact shall not constitute the basis for an equitable price adjustment.

(b) Delivery or performance shall be made only as authorized by orders issued in accordance with the Ordering clause. Subject to any limitations in the Order Limitations clause or elsewhere in this contract, the Contractor shall furnish to the Government all supplies or services specified in the Schedule and called for by orders issued in accordance with the Ordering clause. The Government may issue orders requiring delivery to multiple destinations or performance at multiple locations.

(c) Except as this contract otherwise provides, the Government shall order from the Contractor all the supplies or services specified in the Schedule that are required to be purchased by the Government activity or activities specified in the Schedule.

(d) The Government is not required to purchase from the Contractor requirements in excess of any limit on total orders under this contract.

(e) If the Government urgently requires delivery of any quantity of an item before the earliest date that delivery may be specified under this contract, and if the Contractor will not accept an order providing for the accelerated delivery, the Government may acquire the urgently required goods or services from another source.

(f) Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were completed during the contract's effective period; provided, that the Contractor shall not be required to make any deliveries under this contract after the end of the effective period.

(End of Clause)

52.217-9 Option to Extend the Term of Contract (MAR 2000)

(a) The Government may extend the term of this contract by written notice to the Contractor within 30 days; provided that the Government gives the Contractor a preliminary written notice of its intent to extend at least 60 days before the contract expires. The preliminary notice does not commit the Government to an extension.

(b) If the Government exercises this option, the extended contract shall be considered to include this option clause.

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed five (5) years and six months.

852.203-70 Commercial Advertising (JAN 2008)

The bidder or offeror agrees that if a contract is awarded to him/her, as a result of this solicitation, he/she will not advertise the award of the contract in his/her commercial advertising in such a manner as to state or imply that the Department of Veterans Affairs endorses a product, project or commercial line of endeavor.

(2) *Designated agency office* has the meaning given in 5 CFR 1315.2(m).

(3) *Electronic form* means an automated system transmitting information electronically according to the accepted electronic data transmission methods and formats identified in paragraph (c) of this clause. Facsimile, e-mail, and scanned documents are not acceptable electronic forms for submission of payment requests.

(4) *Invoice payment* has the meaning given in FAR 32.001.

(5) *Payment request* means any request for contract financing payment or invoice payment submitted by the contractor under this contract.

(b) *Electronic payment requests.* Except as provided in paragraph (e) of this clause, the contractor shall submit payment requests in electronic form. Purchases paid with a Government-wide commercial purchase card are considered to be an electronic transaction for purposes of this rule, and therefore no additional electronic invoice submission is required.

(2) Department of Labor Occupational Safety and Health Administration (OSHA) for--

- (i) The Occupational Safety and Health Act of 1970; and
- (ii) OSHA-approved State Plans;

(4) Department of Labor Office of Federal Contract Compliance Programs (OFCCP) for--

(i) Section 503 of the Rehabilitation Act of 1973;

(ii) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974; and

(iii) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity);

(5) National Labor Relations Board (NLRB) for the National Labor Relations Act; and

(6) Equal Employment Opportunity Commission (EEOC) for--

(i) Title VII of the Civil Rights Act of 1964;

(ii) The Americans with Disabilities Act of 1990;

(iii) The Age Discrimination in Employment Act of 1967; and

(iv) Section 6(d) of the Fair Labor Standards Act (Equal Pay Act).

“Forced or indentured child labor” means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

- (9) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974.
- (10) The Family and Medical Leave Act.
- (11) Title VII of the Civil Rights Act of 1964.
- (12) The Americans with Disabilities Act of 1990.
- (13) The Age Discrimination in Employment Act of 1967.
- (14) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors).
- (15) Equivalent State laws as defined in the DOL Guidance. (The only equivalent State laws implemented in the FAR are OSHA-approved State Plans, which can be found at www.osha.gov/dcsp/osp/approved_state_plans.html).

“Labor law decision” means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of “labor laws”.

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Submitting your quote. Submit your company's quote in writing and on paper to the address specified on page 1 of this Request for Quotes (RFQ) or via e-mail utilizing either PDF or Microsoft Word formats (8 Megabyte File Size Limitation). You may not submit more than one quote. If a concern submits more than one quote all quotes will be rejected from that concern. Quotes received that do not contain all of the following information being requested will be considered unacceptable.

Submission deadline. We must receive your quote at the address specified by the deadline specified on page one. We will not consider any quote that we receive after the deadline unless we receive it before we issue a purchase order and considering it will not delay our purchase. In case of an emergency that delays our operations and makes submission or receipt of your quote impossible, we will extend the deadline by one working day.

Terms and content of your quote. Your quote must be based on the terms of this RFQ. We may reject any quote that is not based on these terms in every respect. Your quote must contain all of the information described below.

"The terms and conditions in the RFQ are acceptable to be included in the award document without modification, deletion, or addition."

"The terms and conditions in the RFQ are acceptable to be included in the award document with the exception, deletion, or addition of the following:"

2. Complete and provide the Offeror Representations and Certifications, per 52.212-3, starting on page 13 of this document. *The offeror shall complete "**only**" paragraph (b) of this provision on page 20 if the Offeror has completed the annual representations and certification electronically via the System for Award Management (SAM) Web site accessed through <http://www.sam.gov/portal>.

5. Only one quote shall be submitted by an offeror.
6. **Technical Requirements that the Contractor Shall Provide:**

The Government intends to award a contract resulting from this RFQ to the lowest priced, technically acceptable offeror that is deemed responsible. Quotes shall be evaluated for acceptability or unacceptability. Award will be made to the lowest priced quote meeting the acceptability standards for the non-cost factors. Quotes shall be initially screened for the content listed below. Quotes shall be initially evaluated either acceptable or unacceptable based on whether the specified sections are actually included in the quotes. Quotes must have the following items; those that do not shall receive an unacceptable and will be considered non-responsive.

To be considered for this award the **Contractor must** provide the following:

1. **Price Schedule:** Quotes shall include a completed Pricing Schedule located on page 3 of this RFQ. Quotes shall include pricing for all work identified in the SOW. The Government will utilize a comparison of quoted prices amongst the technically qualified sources following the cascade set-aside procedures identified on pages 1 and 2 of this RFQ.
2. **Technical:** The technical portion of the quote will be used to make an evaluation and arrive at a determination as to whether the quote will meet the requirements established by the Government in the Statement of Work (SOW). Past performance is considered part of the technical portion of the quote.

a. Technical Information

1. Offerors shall provide address to show located within 15 miles or 30 minutes' commute of CWBYVAMC.
2. Offerors shall provide plan for hotel/motel accommodations for a total of up to 18 rooms per day for a total estimate of 4698 rooms per year in accordance with the SOW.
3. Offerors shall provide proof of license and liability insurance.
4. Shall provide a list of key personnel:

 - Assistant Manager(s)

b. Past Performance (Past Performance is Part of Technical)

1. The Contractor shall be regularly established in the business of providing the service identified in SOW.
2. Offerors shall provide three (3) identified references when submitting their quote. Emphasis will be on recent and relevant past performance. Recent is defined as work performed within the last three years. Relevant is defines as work similar in scope of the work described in the SOW.

Past performance will be evaluated on an acceptable or unacceptable basis. Offerors without a record of relevant past performance or for whom information on past performance is not available, will not be evaluated as neither favorable nor favorable. As a result, they will receive a “Neutral/Unknown Confidence” rating for past performance.

3. The Contractor shall be a regularly established Hotel/Motel in the business of providing the services identified in the SOW.
4. The Offeror’s present and past work record will be used to assess the Government’s confidence in the Offeror’s probability of successful performance. The Government will evaluate the Offeror’s reputation for a record of reasonable and cooperative behavior and commitment to customer satisfaction; and generally the Offeror’s business-like concern for the interest of the customer.
5. In investigating relevant past performance, the Government considers information in the offeror’s proposal and information obtained from other sources. Other sources may include past & present customers & their employees, other Government agencies including state and local, consumer protection agencies pre-award surveys, and better business bureaus & others who may have useful information, including the Government’s Contractor Performance Assessment Reporting System (CPARS) & Past Performance Information Retrieval System (PPIRS).

3. **Price:** The Government will review the price schedule for completeness, accuracy and will evaluate the reasonableness of the quoted prices.
