The Department of Veterans Affairs San Diego Healthcare System (VASDHS), has a requirement to establish a contract to provide Annual Preventative Maintenance (PM) to include Quarterly Maintenance for the following:

1. Four (4) Custom Ultrasonics System 83-9;
2. One (1) Custom Ultrasonics Disinfectant Transfer Cart; and
3. Optional PM of up to ten (10) service calls.
