Description

This is a Request for Quotes for commercial items prepared in accordance with the format in FAR Subpart 12.6 in conjunction with Part 13, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation for this action. Quotes are being requested, and a written solicitation will not be issued.

This solicitation is issued as a Request for Quote (RFQ). Submit written quotes on VA248-17-Q-1358. The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2005-94, 2005-95 effective January 19, 2017. This request for quote is issued August 2, 2017 and will end on August 11, 2017 at 4:00 PM EST and is Set-Aside for 100% VOSB.

The Network Contracting Office 8-SAO East intends to award a firm fixed priced contract to the **contractor providing a one-time service with labor, parts, materials, services, specialty services, supervision to perform repairs to two (2) 500,000 Gallon Concrete Water Storage Tanks as described in “Repairs” section of the Performance Work Statement located on the Main Campus, (CWBYVAMC); and will need to provide a one-time inspection, cleaning, and disinfecting Service of Two (2) 500,000 Gallon Concrete Water Storage Tanks, located on the Main Campus, (CWBYVAMC).**

All the work will be in accordance with the Performance Work Statement below.

This procurement is being conducted under Subpart 13.5 Simplified Procedures for Certain Commercial items. The intent is to award a firm fixed price contract.

This procurement is a 100% VOSB set-aside and all eligible offerors are encouraged to submit quotes. To be considered for award prospective offerors must be a verified VOSB concern in the VA Center for Verification and Evaluation (CVE) Veteran Information Pages (VIP) pages <https://www.vip.vetbiz.gov/> at the date and time set for receipt of offers. An Offeror who is not a verified SDVOSB concern at the date and time set for receipt of offers will have their offer rejected as non-responsive, and will not be considered for award. All offerors must be registered in System for Award Management (SAM) at <http://www.sam.gov> to be considered for an award of a federal contract registered in the record must be complete and not missing elements such as representations and certifications.

Quotes are due by 4:00 PM Eastern Standard Time on August 11, 2017. Quotes received after this date and time will be considered late in accordance with 52.212-1(f) and will not be evaluated. Quotes shall be submitted via email to john.hamilton2@va.gov.

QUOTE FORMAT AND EVALUATION CRITERIA

The Government intends to award a fixed priced **One (1) Base Year and 4 (Four) Option Years** resulting from this RFQ to the lowest priced, technically acceptable offeror that is deemed responsible. Quotes shall be evaluated for acceptability or unacceptability. Award will be made to the lowest priced quote meeting the acceptability standards for the non-cost factors as outlined below. Quotes shall be initially screened for the requested content listed below. Quotes shall be initially evaluated either acceptable or unacceptable based on whether the specified content are included in the quotes.

The evaluation of offers received in response to the solicitation will use a tiered or cascading order of precedence. “Tiered evaluation of offers,” also known as “cascading evaluation of offers,” is a procedure used in negotiated acquisitions when market research is inconclusive for justifying limiting competition to small business concerns or sub-categories of small business concerns. The contracting officer—

(1) Solicits offers from both small and other than small business concerns that will be evaluated in the following tier order:

- (a) service-disabled veteran-owned small business (SDVOSB);
- (b) veteran-owned small business (VOSB);
- (c) all other small business concerns;
- (d) other than small business.

(2) If an award or a sufficient number of awards cannot be made at the first tier, evaluation of offers will proceed at the next lower tier until an award or a sufficient number of awards can be made.

Quotes must have the following items; those that do not shall receive an unacceptable and will be considered non-responsive.

To be considered for this award the **Contractor must** provide the following:

1. Quotes shall include a completed Attachment A, Price Schedule found within the RFQ. If the price schedule is not provided the quote shall be determined unacceptable.
2. Only one quote shall be submitted by an offeror. Submitting more than one quote will render all quotes unacceptable.
3. Quotes shall be responded to in GSA e-buy.
4. **Technical:** The technical portion of the quote will be used to make an evaluation and arrive at a determination as to whether the quote will meet the requirements established by the Government

in the Performance Work Statement (PWS). Past performance is considered part of the technical portion of the quote.

C. Performance Work Statement:

PERFORMANCE WORK STATEMENT Disinfection, Cleaning, and Inspection of Water Storage Tanks

Overview: The C. W. Bill Young Veterans Administration Medical Center requires a contractor to:

- I. A One-time Repair Service is required for the two 500,000 Gallon concrete water storage tanks. Contractor shall provide all labor, parts, materials, services, specialty services, supervision to perform repairs to the tanks as described in “Repairs” section of this document. The tanks are both CROM 500,000 gallon pre-stressed concrete reservoirs.

A. Scope of Work of Repairs to Tank 1:

Tank 1:

1. Repair spalling on exterior of tank dome by squaring off and chipping back the concrete to provide a minimum shoulder depth of ¼” and patching with a polymer modified cementitious surface repair material in conjunction with a bonding epoxy to ensure that adequate coverage over the reinforcing steel is maintained
2. Pressure wash exterior dome and recoating the dome with a flexible, breathable coating such as Tnemec Enivorcrete 156, or equal. Contractor shall submit color as closely matching existing tank color as possible to be approved by VA COR.
3. Chip out stained area on tank floor to remove corrosion and prepare and patch by squaring off and chipping back the concrete to provide a minimum depth of ¼” and patching with a polymer modified cementitious repair material. Repair material shall meet the requirements of ANSI/NSF Standard 61.

4. Chip out damaged, loose concrete from interior tank dome, chipping out to a minimum depth of 1/4" and patching the defective areas with a polymer modified cementitious repair material.
5. Route and seal crack on interior tank dome approximately 5 linear feet in length. Area is stained with efflorescence.
6. Remove obsolete parts of liquid level indicator which is no longer in use.
7. Sandblast and coat ductile iron pipes on tank interior with a protective coating suitable for use in potable water tanks such as AquataPoxy A-6, or equal. Repair material shall meet the requirements of ANSI/NSF Standard 61.
8. Install new stainless steel fasteners to interior ladder.
9. Replace screens on center vent with a minimize size 20 mesh.
10. Replace screens on emergency overflow openings with a minimize size 20 mesh.
11. Install aluminum handrail system around hatch and entire circumference of tank to meet OSHA fall protection requirements. Handrail system shall be engineered and shop drawings provided to VAMC staff for approval. Drawings shall be completed and stamped by a Professional Engineer.
12. Extend 6" dome probe piping an additional 3'
13. Provide and replace tank supply water meter.

B. Scope of Work of Repairs to Tank 2:

Tank 2:

1. Sandblast and resurface the areas of exposed wire mesh and reinforcing steel with a corrosion-inhibiting cementitious repair mortar to provide adequate cover over the steel.
2. Replace the screen on the emergency overflow openings with a minimize size 20 mesh.
3. Seal stainless steel center vent at dome
4. Replace handrail system and install aluminum handrail system around hatch and entire circumference of tank to meet OSHA fall protection requirements. Handrail system shall be engineered and shop drawings provided to VAMC staff for approval. Drawings shall be completed and stamped by a Professional Engineer.
5. Extend 6" dome probe piping an additional 3'
6. Provide and replace tank supply water meter.

C. Contractor shall also provide submittals of all coating materials, fasteners, screening, parts, and materials to complete repairs on the tanks as stated above.

- II. A One-Time Inspection, Cleaning, and Disinfecting Service the contractor to provide all parts, materials, services, specialty services, supervision, and testing to pressure wash, disinfect, clean, and inspect (2) 500,000 gallon concrete water storage tanks located at the Bay Pines VA Health Care System located at 10000 Bay Pines Blvd, Bay Pines, FL 33744. Contractor shall follow all state, local, and federal guidelines, in addition to American Water Works Association (AWWA) Standard C652-11.

- III. Bi-Annual (November and May), Cleaning, and Disinfecting Service the contractor to provide all parts, materials, services, specialty services, supervision, and testing to pressure wash, disinfect, clean, and inspect (2) 500,000 gallon concrete water storage tanks located at the Bay Pines VA Health Care System located at 10000 Bay Pines Blvd, Bay Pines, FL 33744. Contractor shall follow all state, local, and federal guidelines, in addition to American Water Works Association (AWWA) Standard C652-11.

D. Submittals

Prior to performing any disinfection procedure, the contractor shall submit his method of disinfection, including the exact type and amount of disinfecting agent to be used with a specific volume of water, the tools and method of application, and the intended amount of chlorine residual. The contractor shall also provide evidence of compliance with Florida Department of Environmental Protection (FDEP), Southwest Florida Water Management District (SWFMD), Occupational Safety and Health Administration (OSHA), National Sanitation Foundation/American National Standards Institute (NSF/ANSI), confined space, control of hazardous energy, and fall protection requirements.

Contractor shall submit documentation of laboratory accreditation, confined space training requirements, chemicals, parts, materials, and shop drawings. Contractor shall provide a detailed work plan and site specific safety plan for review within 14 days of notice to proceed.

E. Inspection Requirements

The contractor shall provide a visual inspection of the tanks, including walls, roof, and base, and a written report verifying the procedure followed, disinfectant type and levels utilized, pictures of inside the tank, pre and post disinfection test results, recommendations for improvements to the overall health of the water tanks, and certification that all disinfection and testing procedures complied with AWWA C652-11 and all state, local, and federal guidelines. The final report shall be submitted to facility no more than 14 calendar days of the completion of the work. Preliminary reports shall be available to establish acceptance of work and test results with AWWA C562-11 and all state, local, and federal guidelines.

Contractor shall complete inspection after completion of repairs and shall document such repairs with before and after pictures. These pictures shall be provided in the final report.

The specific dates shall be requested by the facility.

F. Cleaning & Disinfection

Contractor shall provide all parts, materials, services, specialty services, supervision, and testing to disinfect (2) 500,000 gallon concrete water storage tanks. Contractor shall follow the

disinfection requirements as outlined in the most current version of AWWA C652. The government reserves the right change the scheduling by providing a 15 day notification to the contractor.

G. Testing

The contractor shall be responsible for all pre and post disinfection testing requirements in accordance with AWWA C652-11 and state, local, and federal guidelines. These tests shall confirm the appropriate parameters to confirm that the water quality is appropriate for distribution, including, but not limited to: pH, alkalinity, turbidity, odor, specific conductance, and chlorine residual. Samples shall be representative of the water quality in the tank and shall be sampled separately from the bottom, middle, and top of the tank. Bacteriological tests shall show no coliform and acceptable chlorine residual and PH after cleaning is complete. Should any test result come back out of compliance with the Safe Drinking Water Act or state, local, or federal guidelines regarding potability of water, the contractor shall repeat the disinfection and testing until satisfactory results are obtained at the contractors cost. Sampling shall also include the “Optional Sampling and Testing” listed in section 5.1.1.5 of AWWA C652-11. A minimum of two pre and post disinfection test samples from each tank shall be taken and shall follow aseptic techniques for bacteria sampling. The testing lab shall be certified through the Environmental Laboratory Certification Program and lab approval must be obtained through the contracting officers representative.

H. Materials and Equipment

Contractor shall provide all equipment necessary to complete the disinfection and testing, including equipment, materials, and testing needed to meet OSHA requirements for a safe work site. All materials and equipment shall meet the requirements of the Safe Drinking Water Act, AWWA C652-11, and NSF/ANSI Standards.

I. Coordination

The contractor shall attend a kick off meeting with the safety office, Contracting Officer’s Representative, and other applicable personnel to discuss procedures and OSHA requirements 2 weeks prior to start of work. Valves shall only be opened or closed by VA personnel. Tanks will only be taken out of service and drained or put in service by VA personnel. Tank #2 shall be cleaned first and shall satisfactorily meet all testing requirements prior to being placed back in service and Tank #1 being taken out of service.

J. Methods

Underwater inspection and divers shall not be utilized to complete this scope of work. The contractor will not have access to sanitary drains to drain chlorinated water from the tanks. Disposal of any water will be the responsibility of the contractor.

K. Confined Space

The Bay Pines VA Healthcare System complies with the Occupational Safety and Health Administration (OSHA) confined space requirements as detailed in 29 CFR 1910.146. The above ground water tanks located at the C. W. Bill Young Medical Center have been evaluated and deemed to meet the definition of permit required confined spaces. All confined space entry shall comply with 29 CFR 1910.146. A site-specific Confined Space Entry plan, that specifically addresses entry conditions, air monitoring and rescue services, shall be developed and submitted to the Facility Safety and Emergency Management Service.

Confined space entry permits must be authorized by the Facility Safety and Emergency Management Service. Contractors shall coordinate with their Project Manager to request entry permits. Written request to de-classify a (PRCS) to a (CS) may be documented in writing and submitted to the Facility Safety and Emergency Management Office for consideration and approval.

L. Control of Hazardous Energy

A site- specific plan that describes the isolation procedures that the contractor will use, in collaboration with the Facility Engineering staff to isolate and secure plumbed supply water from entering the AST during periods of servicing and maintenance will be required. All installation, maintenance, and servicing of equipment or machinery shall comply with 29 CFR 1910.147.

M. Fall Protection

The fall protection (FP) threshold height requirement is 6 ft. (1.8 m) for ALL WORK, unless specified differently or the OSHA 29 CFR 1926 requirements are more stringent, to include steel erection activities, systems-engineered activities (prefabricated) metal buildings, residential (wood) construction and scaffolding work.

1. The use of a Safety Monitoring System (SMS) as a fall protection method is prohibited.
2. The use of Controlled Access Zone (CAZ) as a fall protection method is prohibited.
3. A Warning Line System (WLS) may ONLY be used on floors or flat or low-sloped roofs (between 0 - 18.4 degrees or 4:12 slope) and shall be erected around all sides of the work area (See 29 CFR 1926.502(f) for construction of WLS requirements). Working within the WLS does not require FP. No worker shall be allowed in the area between the roof or floor edge and the WLS without FP. FP is required when working outside the WLS.
4. Fall protection while using a ladder will be governed by the OSHA requirements.

N. Other Requirements

The contractor shall provide past performance showing at least (3) successful tank cleaning contracts within the last (5) years with tanks of at least 250,000 gallons.

O. Period of Performance

The Period of performance for CLIN 1 and 2 is 45 Days after Notice to Proceed (ARO).

P. Tour of Duty:

The work will take place during normal business hours of Monday – Friday. 6:00 am – 4:30 pm;
Eastern Standard Time. Government Holidays will not be worked.

Q. Emergency Services

Contractor shall possess the ability and must respond to emergency situations deemed by the COR/CO. This response must have a maximum execution timeline of 8 hours from the point of the initial call by the Government (e.g. answering service is authorized to accept emergency service calls and contact contractor). Emergency response operations will be deemed necessary by a multitude of circumstances. As an example, emergency responses will be required in the case of a natural disaster or in preparation for a natural disaster; an epidemic/pandemic situation; Activation of the Hospital Incident Command System, the COOP plan, National Emergency Response Plan; etc. As part of this requirement the contractor shall report deficiencies that are deemed critical or catastrophic immediately to the Contracting Officer or the Contracting Officers Representative. An emergency repair quote shall be generated and provided to the COR and the Contracting Officer within two days. Prior to starting emergency services work the contractor shall submit a firm fixed priced quote that will contain a cost breakdown to include labor categories, labor hours and material costs (contractor format) to the Contracting Officer for review and approval.

The Contractor shall use reasonable care to avoid damaging existing buildings, equipment, and vegetation on the Government installation. If the Contractor's failure to use reasonable care causes damage to any of this property, the Contractor shall replace or repair the damage at no expense to the Government as the Contracting Officer directs. If the Contractor fails or refuses to make such repair or replacement, the Contractor shall be liable for the cost, which may be deducted from the contract price.

52.246-4 -- Inspection of Services -- Fixed-Price (Aug. 1996)

(a) *Definition:* "Services," as used in this clause, includes services performed, workmanship, and material furnished or utilized in the performance of services.

(b) The Contractor shall provide and maintain an inspection system acceptable to the Government covering the services under this contract. Complete records of all inspection work performed by the Contractor shall be maintained and made available to the Government during contract performance and for as long afterwards as the contract requires.

(c) The Government has the right to inspect and test all services called for by the contract, to the extent practicable at all times and places during the term of the contract. The Government shall perform inspections and tests in a manner that will not unduly delay the work.

(d) If the Government performs inspections or tests on the premises of the Contractor or a subcontractor, the Contractor shall furnish, and shall require subcontractors to furnish, at no increase in contract price, all reasonable facilities and assistance for the safe and convenient performance of these duties.

(e) If any of the services do not conform with contract requirements, the Government may require the Contractor to perform the services again in conformity with contract requirements, at no increase in contract amount. When the defects in services cannot be corrected by reperformance, the Government may --

(1) Require the Contractor to take necessary action to ensure that future performance conforms to contract requirements; and

(2) Reduce the contract price to reflect the reduced value of the services performed.

(f) If the Contractor fails to promptly perform the services again or to take the necessary action to ensure future performance in conformity with contract requirements, the Government may --

(1) By contract or otherwise, perform the services and charge to the Contractor any cost incurred by the Government that is directly related to the performance of such service; or

(2) Terminate the contract for default.

(a) Definition. For the Department of Veterans Affairs, "Service-disabled veteran-owned small business concern":

(1) Means a small business concern:

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans (or eligible surviving spouses);

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans (or eligible surviving spouses) or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran;

(iii) The business meets Federal small business size standards for the applicable North American Industry Classification System (NAICS) code identified in the solicitation document; and

(iv) The business has been verified for ownership and control and is so listed in the Vendor Information Pages database, (<http://www.VetBiz.gov>).

(2) “Service-disabled veteran” means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

(b) *General.* (1) Offers are solicited only from service-disabled veteran-owned small business concerns. Offers received from concerns that are not service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a service-disabled veteran-owned small business concern.

(c) Agreement. A service-disabled veteran owned small business concern agrees that in the performance of the contract, in the case of a contract for:

(1) Services (except construction), at least 50 percent of the cost of personnel for contract performance will be spent for employees of the concern or employees of other eligible service-disabled veteran-owned small business concerns;

(2) Supplies (other than acquisition from a nonmanufacturer of the supplies), at least 50 percent of the cost of manufacturing, excluding the cost of materials, will be performed by the concern or other eligible service-disabled veteran-owned small business concerns;

(3) General construction, at least 15 percent of the cost of the contract performance incurred for personnel will be spent on the concern’s employees or the employees of other eligible service-disabled veteran-owned small business concerns; or

(4) Construction by special trade contractors, at least 25 percent of the cost of the contract performance incurred for personnel will be spent on the concern’s employees or the employees of other eligible service-disabled veteran-owned small business concerns.

(d) A joint venture may be considered a service-disabled veteran owned small business concern if—

A liability is not finally determined if there is a pending administrative or judicial challenge. In the case of a judicial challenge to the liability, the liability is not finally determined until all judicial appeal rights have been exhausted.

(B) *The taxpayer is delinquent in making payment.* A taxpayer is delinquent if the taxpayer has failed to pay the tax liability when full payment was due and required. A taxpayer is not delinquent in cases where enforced collection action is precluded.

In the course of the hearing, the taxpayer is entitled to contest the underlying tax liability because the taxpayer has had no prior opportunity to contest the liability. This is not a delinquent tax because it is not a final tax liability. Should the taxpayer seek tax court review, this will not be a final tax liability until the taxpayer has exercised all judicial appeal rights.

(C) The taxpayer has entered into an installment agreement pursuant to I.R.C. §6159. The taxpayer is making timely payments and is in full compliance with the agreement terms. The taxpayer is not delinquent because the taxpayer is not currently required to make full payment.

(D) The taxpayer has filed for bankruptcy protection. The taxpayer is not delinquent because enforced collection action is stayed under 11 U.S.C. §362 (the Bankruptcy Code).
