

4. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to make a change to the Price/Cost Schedule, reference is made to pages 8 through 10 of the solicitation for the base year and option years. Offerors' shall not provide pricing for access to EBSCO Research Databases for the base year and option years one (1) through four (4) at this time. Pricing for access to EBSCO Research Databases shall be obtained at a later date during the term of the contract. Second, to add an additional requirement on page 6 of 55 under additional requirements. The Contractor shall provide access to EBSCO Research Databases through a modification of the contract. The Contracting Officer shall submit a request to the Contractor to obtain pricing for access to EBSCO Research Databases at any time during the life of the contract to include option years, then forward to the requesting service for review and approval. The Contracting Officer shall then process a contract modification to add this requirement.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
