The specs have some Elevator stuff listed under Spec section 05 metals, however there is no Spec Section for Elevators themselves. So if there is not an elevator in this project then we will just ignore it but if there is suppose to be a pit installed then there are several questions.

Where is the pit to be placed? Who is the Elevator Manufacturer for the Basis of Design? Are you looking for just a pit for future and no elevator? Is there a spec section needed for this work?
