1. **Contracting Activity:** Department of Veterans Affairs, VISN 6, Charles George VA Medical Center. Contracting Office: Network Contracting Office 6. Purchase requests 637-17-3-5997-0050 and 637-7-4-6997-0065.
2. **Nature and/or Description of the Action Being Processed:** This procurement is for an Automatic License Plate Recognition (ALPR) System, Expansion of the Existing Video Surveillance System, Upgrade/Expansion of the existing Access Control System and related equipment, at the Asheville VAMC and two (2) satellite locations. This action is being processed in accordance with FAR 13.5 Simplified Procedures for Certain Commercial Items and specifically FAR 13.501 Special Documentation Requirements, where acquisitions conducted under Simplified Acquisition Procedures are exempt from the requirements of FAR Part 6, but still require a justification using the format of FAR 6.303-2.
3. **Description of Supplies/Services Required to Meet the Agency's Needs:** The Franklin CBOC will receive upgrades to the existing video surveillance system, along with the Rutherfordton CBOC. The main facility, Asheville VAMC, will receive an Automatic License Plate Recognition (ALPR) System, as well as upgrades to the existing Access Control System and Video Surveillance system. The bill of materials for all required equipment is shown in the table at paragraph 5 of this document. The estimated value of this action is \$[REDACTED] for non-severable work.
4. **Statutory Authority Permitting Other than Full and Open Competition:** The authority for applying the Simplified Procedures for Commercial Items of FAR 13.5 is 41 U.S.C. 1901 and is implemented by for restricting competition on this procurement via FAR 13.106-1(b)(2).
5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):** The facility obtained an informal assessment of the facility's existing technology, including an extensive equipment list that would provide the required functionality, while integrating with existing systems. This requirement is being solicited as a "brand name only" procurement, for the specific items shown in the table at Appendix A of this document, to ensure that the extensive list of installed equipment meets facility requirements without later contract modifications and technical problems.
6. **Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** Market research has identified multiple Service-Disabled Veteran Owned Small Business (SDVOSB) sources.
