B.4 SALIENT CHARACTERISTICS

- Must be listed in the Veterans Information Systems and Technology Architecture (VistA) Approved Digital Imaging and Communications in Medicine (DICOM) Modality Interfaces
- Must be able to integrate with the VA VistA system and accept New/Updated Consults/Orders created from Computerized Patient Record System (CPRS) /VistA that contains Patient demographic data, and send these as a DICOM Modality Work-lists to a single/multi DICOM compliant instruments within the eye-clinics network
- Image and Data Management/PACS System must be FDA 510k approved and listed as a Medical Device
- Must provide Post Processing Analysis, Dynamic Review/Manipulation of RAW data functionality for ZEISS HFAII-I series currently in use as well as ZEISS HFA 3
- Must be able to store and access raw instrument data from ZEISS Field Analyzer (HFA II and HFA3), ZEISS Cirrus HD-OCT, ZEISS Visucam Fundus Camera and ZEISS FF450/Visupac Fundus Camera systems
- Must have functionality to enable real-time and dynamic editing/manipulation of all prior Visual Field Test data for all Glaucoma patients and allow for Baseline changes, real-time report generation for any VFI date, display RealEye images and data from the ZEISS HFA II and HFA 3 instruments currently in use
- Must support DICOM standards and Work-List functionality in order to create and send patient demographics to a specific or all instrument's via a DICOM work-list within the eye clinic's network
- Must have Bi-directional DICOM capabilities to send both DICOM Modality Work-lists containing Consult/Order details to instrument's within the eye-clinics network and receive back the diagnostic test results and RAW data for storage within the Image and Data Management System for access
- Must connect to any brand of non-DICOM diagnostic instrument with export capabilities, and convert the diagnostic test results into a DICOM compatible file containing all patient demographical information, UID's, Accession number, Device name and type, laterality and other key pieces of data with the least amount of user interaction. This must be then stored within the Image and Data Management/PACS System and also forwarded to the VA VistA
- Must be able to display ZEISS Field Analyzer Glaucoma Progression Analysis (GPA) and enable the clinician to manipulate data and store baseline changes at the workstation within the Image and Data Management System
- Must be able to present VFI Index, Mean Deviation, Pattern Standard Deviation and Global Indices at a glance summary of all past and present tests
- Must be able to display and allow the clinician to scroll through the various ZEISS Cirrus Macula Cube B-scan slices, within in the Image and Data Management System viewer

- Must be able to display all Cirrus HD-OCT past and present test data from one or more ZEISS Cirrus instruments located in one or more VA clinics. This data must be accessible to enable viewing and manipulation at the workstation
- Must be able to automatically label images and reports coming from the instruments DICOM Header to enable the clinician to sort test data by visit date/s, modality type/s, right eye, left eye or both eyes
- Must be able to tag individual test reports/images as Favorites to enable easy access on future patient visits
- Must be able to display images in pre-formatted clinical display groupings for Glaucoma, Retina and Cataract cases
- Must be able to interface with up to 7 existing diagnostic instruments with future expansion capability.
- Must include the ability to view images on up to 18 floating review stations.

For Visual Field Analyzer:

- Must employ Liquid Lens Technology for the trial lens to decrease set up time and reduce error.
- Must provide Summary measurement of visual field status expressed as a percent of a normal age-adjusted visual field.
- Must allow for the operator to instantly review patient's eye position at any stimulus point.
- Must include progression analysis of past, current and future visual field tests from existing Zeiss HFA II-i and HFV3 visual field machines.
- Must allow for all raw test data from existing Humphrey Visual Fields to be passed and used on the new visual fields.
- Must be fully DICOM conformant and allow uploading data to VISTA imaging.
- Must be able to import all raw data and algorithms of existing Zeiss HFA into the new instrument. Also, must be able to combine MULTIPLE HFA databases from multiple instruments in the clinic into one HFA Database on an image and database server
- Must be able to Create modality work list.
- Must include Swedish Interactive Threshold Algorithm with normative data for SITA Standard and SITA Fast for 30-2, 24-2 and 10-2 threshold visual field test results from healthy subjects, ages 17 to 89 from existing Zeiss HFA II-I machines.
- Must allow Blue-Yellow Perimetry
- Must be able to compare and identify statistically significant visual field loss on individual tests and between multiple tests over time from existing Zeiss HFA II-I machines with future tests corrected for age, test point location and strategy.
- Must include automated patient monitoring to include: Video eye monitor, Heijl-Krakau Blind Spot Method, Gaze Tracking, Head Tracking and Vertex Monitoring. Fixation to be checked with each stimulus presentation.
- Must tracks pupil size and position relative to the trial lens coupled with automatic X, Y movement of the chin rest to correct for patient movements and misalignments."
- Must allow kinetic Testing to emulates manual standard Goldmann perimetry.
- Must allow glaucoma hemifield test and Social Security Disability Test
- Must allow the database to be removed from the instrument such that database raw files can reside on an external server with image and data management capability.
- Must include table, printer, installation and set-up and onsite end user training.

(a) In an effort to achieve socioeconomic small business goals, depending on the evaluation factors included in the solicitation, VA shall evaluate offerors based on their service-disabled veteran-owned or veteran-owned small business status and their proposed use of eligible service-disabled veteran-owned small businesses and veteran-owned small businesses as subcontractors.

(b) Eligible service-disabled veteran-owned offerors will receive full credit, and offerors qualifying as veteran-owned small businesses will receive partial credit for the Service-Disabled Veteran-Owned and Veteran-owned Small Business Status evaluation factor. To receive credit, an offeror must be registered and verified in Vendor Information Pages (VIP) database (<https://www.vip.vetbiz.gov>).

(c) Non-veteran offerors proposing to use service-disabled veteran-owned small businesses or veteran-owned small businesses as subcontractors will receive some consideration under this evaluation factor. Offerors must state in their proposals the names of the SDVOSBs and VOSBs with whom they intend to subcontract and provide a brief description of the proposed subcontracts and the approximate dollar

values of the proposed subcontracts. In addition, the proposed subcontractors must be registered and verified in the VetBiz.gov VIP database (<https://www.vip.vetbiz.gov>).

E.6 52.212-2 EVALUATION—COMMERCIAL ITEMS (OCT 2014)

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

Lowest price technically acceptable.

Technical acceptability shall be established by review of each submitted quoted by the designated technical evaluator/s and verification that any equal to items meet the salient characteristics included in this solicitation. Submissions to this solicitation must show clear, compelling and convincing evidence that all equal to items meet all the salient characteristics.

(b) *Options.* The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

(2) In paragraph (s) of this provision: Any judgment or order entered by any Federal or State court in which the court determined that a labor law violation occurred, or enjoined or restrained a violation of labor law. It includes a judgment or order that is not final or is subject to appeal. To determine whether a particular judgment or order is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

Economically disadvantaged women-owned small business (EDWOSB) concern means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. - (vi) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors);

(2) Department of Labor Occupational Safety and Health Administration (OSHA) for—

- (i) The Occupational Safety and Health Act of 1970; and
- (ii) OSHA-approved State Plans;

(3) Department of Labor Office of Federal Contract Compliance Programs (OFCCP) for—

- (i) Section 503 of the Rehabilitation Act of 1973;
- (ii) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974; and
- (iii) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity);
- (4) National Labor Relations Board (NLRB) for the National Labor Relations Act; and
- (5) Equal Employment Opportunity Commission (EEOC) for—
 - (i) Title VII of the Civil Rights Act of 1964;
 - (ii) The Americans with Disabilities Act of 1990;
 - (iii) The Age Discrimination in Employment Act of 1967; and
 - (iv) Section 6(d) of the Fair Labor Standards Act (Equal Pay Act).

Forced or indentured child labor means all work or service—

- (1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or
- (2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

Highest-level owner means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

- (7) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity).
- (8) Section 503 of the Rehabilitation Act of 1973.
- (9) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974.
- (10) The Family and Medical Leave Act.
- (11) Title VII of the Civil Rights Act of 1964.
- (12) The Americans with Disabilities Act of 1990.
- (13) The Age Discrimination in Employment Act of 1967.
- (14) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors).
- (15) Equivalent State laws as defined in the DOL Guidance. (The only equivalent State laws implemented in the FAR are OSHA-approved State Plans, which can be found at www.osha.gov/dcsp/osp/approved_state_plans.html).

Labor law decision means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of “labor laws”.

Manufactured end product means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the

Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174).
