

**JUSTIFICATION FOR SINGLE SOURCE AWARDS IAW [FAR 13.106-1](#)**  
(OVER MICRO-PURCHASE THRESHOLD(\$3.5K) BUT NOT EXCEEDING THE SAT (\$150K))

IAW [FAR13.104](#), COs must promote competition to the maximum extent practicable to obtain supplies and services from the source whose offer is the most advantageous to the Government, considering the administrative cost of the purchase. When competition is not practicable, IAW [FAR13.106-1\(b\)](#), COs solicit from a single source for purchases not exceeding the simplified acquisition threshold. COs may solicit from one source if the CO determines that the circumstances of the contract action deem only one source reasonably available (e.g., urgency, exclusive licensing agreements, brand-name or industrial mobilization). The upgrade will include software modules and hardware to bring the equipment to the latest version and provide additional functionality as well as peripherals to allow for clinical use of the new functionality. The Freedom allows for better and easier positioning of the patient in the CT Room equipment. The upgrade to the software and peripherals shall bring the equipment to the latest platform. New features with the upgrades include multiple range sizes for cranial positioning for CT Equipment.

**3. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:**

The upgrade is proprietary to CDR Systems as they are the manufacture of the Freedom System. No other vendor's software, hardware, or peripherals are compatible with the existing system. Utilizing another vendor's software would require replacing the entire system and all existing peripherals. CDR Systems, a large business, was contacted and they verified there are no other authorized distributors for the Freedom system and upgrade.

**4. DESCRIPTION OF MARKET RESEARCH CONDUCTED AND RESULTS OR STATEMENT WHY IT WAS NOT CONDUCTED:**

VetBiz was searched under NAICS 339112 which returned 157 results, GSA was searched and Freedom T System in not available on contract. CDR Systems was contacted and they verified that they are the manufacturer and that there are no other authorized distributors for the Freedom T System.
