3. Description of Supplies or Services:

The estimated value of the proposed action is \$ 65,334.77

Trauma implant set (cannulated screws, plates, etc.) by Depuy Synthes that are currently used at this facility and have proven success. These items are on a national standardized contract.

4. Authority:

5. **Rational/explanation to support cited authority:** Only one responsible source is available because Depuy Synthes is the manufacturer of these trauma implants and therefore must be an exact match to the instruments surgeons are already using because they are familiar with these implants and to ensure continuity of care delivered exact replacement is being sought.


This is a purchase against a national standardized contract.

6. **BRAND NAME ONLY:** This buy is estimated to exceed \$25,000 and this documentation will be posted along with the RFQ on e-Buy, as required by FAR 8.405-6(b)(3).

Brand-name is requested because the replacement pieces must match the existing set for the set to be useful and therefore requires it to come from the same manufacturer. Since Depuy Synthes is the only manufacturer of the requested set, they are the only manufacturer capable of providing the supplies requested. If we are unable to purchase the exact set from the manufacturer to replace missing implants, then the set is a loss and a complete new set would be needed and would result in delays to patient care.

7. Note that this determination satisfies the requirements of FAR 8.405-6. The requirement to prepare a written justification IAW FAR 6.303 does not apply to Federal Supply Schedules.
