## **SECTION B - CONTINUATION OF SF 1449 BLOCKS**

### **1.0 BACKGROUND:**

**1.1** A Medical Center's two way radio communication system plays a critical role in the safety and security of both its patients and staff; and maintains compliance with regulatory requirements, standards and recommendations (not limited to: TJC, VHA Capabilities, HSEEP, NIMS, FEMA, NFPA). When its radio communication system fails, the ability to communicate emergent and non-emergent information to internal and external stakeholders ceases to exist, and in turn creates an unsafe, vulnerable and non-compliant environment. The current two way radio communications system at the West Palm Beach Veterans Affairs Medical Center has been in place since the medical center opened, over 20 years ago. Due to the age of this system, it is now obsolete and replacement parts no longer exist. This proposed replacement would completely replace what is installed now with a new, modernized system that will improve the safety and security of the medical center; meet or surpass compliance with any regulatory requirements, standards or recommendations; and create a radio system that is reliable, portable, scalable, resilient, redundant and interoperable with internal and external stakeholders.

**1.2** The West Palm Beach Veterans Affairs Medical Center's current radio system provides communication capabilities for the following four primary users; Police Service, Emergency Management (EM), Facilities Management Services (FMS), and Environmental Management Services (EMS). Under each of the three primary services, the list is broken down even further into sub user services. The following list of identified equipment is what is proposed to be replaced, but not specifically limited to (due to the fact that not each and every single part can be listed here). The current Motorola radio system overview is comprised of the following, based off of past design documentation:

1.2.6 The following additional information has been observed either in past system design documentation or from actual observation:

- The West Palm Beach VAMC's four (4) FCC licensed and assigned UHF frequencies have been narrow-banded.
- Antenna Systems: Currently installed rooftop antenna is a bi-directional antenna located on the roof of the main structure, at an approximate elevation of 225 feet. Other "indoor antenna" are installed in drop ceiling panels with visible black plastic covers; from the basement through the 4<sup>th</sup> floors, that are tied into the combiner/multi-coupler in 10B-300A.

## **2.0 SCOPE:**

# West Palm Beach VAMC Two-way Radio Replacement

**2.1** The West Palm Beach VAMC is looking for proposals on TWO DIFFERENT P25 Phase 2 two-way land mobile radio communication system designs. A proposal may be for BOTH or any ONE of the two proposed radio systems.

- Design (1) shall be a “stand-alone” system that does not require connection to an offsite server, and the entire infrastructure will use the existing UHF trunked radio frequencies. This design shall be interoperable with internal and external stakeholders.
- Design (2) shall connect to the Palm Beach County (Florida) existing 700/800 MHz radio system via a vendor coordinated installation of a non-existent data connection into the medical center.

The Contractor shall provide and install all materials, equipment (complete infrastructure, portable radios, mobile radios, dispatch consoles, antenna system(s), and any other equipment based on system design), training, warranty, and labor necessary to ensure the turn-key operation of a P25 Phase 2 compliant narrowband, digital trunked radio system that will operate in the designed frequency bands; and shall provide a system that has been designed to operate on a 24/7/365 basis that produces the least amount of hardware and software conflicts possible (internally and externally).

**2.2** A site visit is not mandatory; however, it is highly recommended and beneficial to any potential contractor, so that a full understanding of what is currently in place, and what will be required for a complete turn-key system, based off of both design requirements listed above. There are also known weak or “dead zone/spot” RF areas at the West Palm Beach VAMC; and a site visit may develop a better understanding of these issues. Given the requirement to upgrade from an analog to a digital P25 Phase 2 trunked system, the unknown possibility may arise that these weak RF areas may become more difficult to transmit and receive out of due in part to technological differences.

**3.0 REQUIREMENTS:** All requirements must be turn-key and shall operate and function within the entire radio system as a whole, without technological conflict(s) due to hardware or software incompatibility. This turn-key radio system shall utilize encryption—as deemed appropriate—that is FIPS 140-2 certified, per Veterans Affairs regulations and standards. The following requirements are not only limited to what’s listed, but shall be considered as components within a fully functioning, turn-key radio system that’s been; designed, analyzed, developed, and reviewed.

**3.1** Based upon the design proposal being submitted; the contractor shall provide a turn-key radio system that is: a Project 25 (P25) Phase 2 compliant, narrowband, digital trunked radio system that will operate in the existing medical centers UHF frequency bands and/or the Palm Beach County 700/800MHz frequencies.

**3.2** Based upon design being submitted; the contractor shall provide a gateway that has a software application that resides on standard off-the-shelf hardware and can be added to a network through a simple Ethernet connection into an IP-based infrastructure. This gateway shall provide TIA-standardized network-level interoperability and communications between Project 25 systems, regardless of system manufacturer. This gateway shall also provide an interface that enables P25 compliant radios to roam between user systems, and shall prevent identification overlaps by assigning temporary unit and group identifications to roaming users.

**3.3** Based upon design being submitted; the contractor shall provide options for the ability to extend the P25 capabilities of the radio system by incorporating an application server solution that is a Voice over Internet Protocol (VoIP) based Push-to-Talk (PTT) communications system that operates over public and private wireless networks. This solution shall also extend traditional Land Mobile Radio (LMR) services onto the broadband capable third generation (3G) and 4G/LTE cellular networks, to a cellular phone supporting platform including Apple and Android. This extended capability must incorporate full AES end-to-end encryption. A total of 25 client licenses for Apple/iOS and Android devices shall be included.

**3.4** The contractor shall provide one (1) mobile radio configured in a desktop style converted operation, capable of utilizing A/C electrical voltage, which shall be programmed with system designed radio frequencies. This radio shall be a P25 Phase 2 compliant radio capable of clearly broadcasting any received radio transmission through a speaker, and will also have a desktop microphone that the radio operator can use to send radio traffic to other radio system users. This radio configuration will be installed in room BE-111 (Utility Operations Center, also known as the “Energy Center”). There is currently a Motorola Astro console installed at this location, and is fully functional. This mobile radio set-up shall also utilize encryption (FIPS 140-2 certified) per Veterans Affairs regulations and standards. The contractor shall also include any other options—along with the pricing—of any required features that will require the radio to function on the designed radio system, and a justification as to why such option is required.

**3.5** The contractor shall provide two (2) P25 Phase 2 compliant computer aided dispatch consoles—one located in Police Dispatch Operations, room BA-201; and the other in the Hospital Incident Command Center, room 3B-260. Both dispatch consoles shall be configured with a high definition monitor, speaker(s) that will produce clear and legible audio of all radio traffic, a desktop microphone, a “mouse” that allows navigation within the operating system, and a single pedal foot switch. Both dispatch consoles shall have a seamless capability to communicate/interoperate with external community agencies and stakeholders. Both dispatch consoles shall utilize encryption (FIPS 140-2 certification) per Veterans Affairs regulations and standards. The contractor shall also include any other options—along with the pricing—of any required features that will require the radio to function on the designed radio system, and a justification as to why such option is required.

**3.6** The contractor shall provide two (2) different types of P25 compliant Phase 2 portable radios. Single band radios that will be utilized by FMS, Safety and EMS employees; and multi-band radios that will be utilized by Police Service and Emergency Management.

ALL portable radios shall be/have: P25 Phase 2 compliant, encryption (FIPS 140-2 certification) per Veterans Affairs regulations and standards, have two (2) lithium ion batteries (main and a spare) with at least a 10 hour battery life, a single bay charger, have an Ingress Protection (IP) rating of AT LEAST IP66, the capability of attaching a “belt clip” and shall include one with each radio, and the contractor shall also include any other options—along with the pricing—of any required features that will require the radio to function on the designed radio system, and a justification as to why such option is required. The radio frequency band and any of its specifications (additional option items to comply and function on the designed radio system being proposed) shall be dependent on which radio system design (1 or 2) as explained in the Scope, and the service/department the radio will be used in.

**3.6.1** The following is a breakdown of portable radio requirements and quantities:

- The contractor shall provide a quantity of 132 single band (utilizing the WPB VA supplied UHF trunked frequencies, or the Palm Beach County (PBC) 700/800 MHz radio system frequency), P25 Phase 2 compliant portable radios. Fifteen (15) of these single band radios shall be installed in emergency call boxes located throughout the outdoor medical center grounds areas. These Emergency call boxes currently have Motorola XTS 2500 MOD 1’s installed in them that are integrated into the current medical center radio system. When a person opens the door on the call box, it initiates an emergency call and an audible alert is heard at the Police operations dispatch console. The dispatcher is then able to communicate with the person at the call box through the dispatch console.
- The contractor shall provide a quantity of 28 multi-band radios that shall be/have: the capability of supporting VHF (listed as an option), and UHF and 700/800MHz bands (as a requirement); WiFi, Bluetooth; front and top LCD displays; full keypad; provide standardized interoperability and communications roaming between Project 25 systems—regardless of system manufacturer—with surrounding community agencies and external stakeholders
- The contractor shall provide one (1) P25 Trunked, portable radio that transmits and receives over the 800 MHz “MEDCOM” frequency band. The primary function of this portable radio will be used in the Emergency Department, and must allow access to the Palm Beach County, FL “MEDCOM” radio system and all of the assigned, required talk groups on the “MEDCOM” system. The contractor shall provide one (1) additional spare Li-Ion battery that provides at least a 10 hour talk time. This portable radio shall also include a single bay battery charger designed to charge its included (and spare) battery. This radio and its programming shall adhere to any and all policies, regulations, rules, governances, etc.; that has been put in place by both the State of Florida and Palm Beach County government.
- The contractor shall provide a replacement to the Motorola 3000 Deskset that is installed and permanently affixed to a wall, in the Emergency Department. This Deskset operates on the “MEDCOM” system here in Palm Beach County, and allows incoming ambulances and fire rescue personnel to alert the hospital with the medical status of an incoming patient.

**3.6.2** Portable Radio Accessories- the contractor shall provide the following radio accessories:

- Six bay battery chargers: these 6-bay chargers shall be capable of charging the battery chemistry on the proposed portable radios (single and multi-band), to include spare batteries.
  1. For Single Band Radios: Quantity of fourteen (14).
  2. For Multi-Band Radios: Quantity of two (3)
- Wall Mount Kit for 6-Bay Battery Chargers:
  1. For Single Band Radios: Quantity of fourteen (14)
  2. For Multi-Band Radios: Quantity of three (3)
- Lapel Microphones:
  1. For Single Band Radios: Quantity of five (5) with a design consisting of a Speaker Microphone, Coiled Cord; with Rubber PTT Button, Emergency Button, 2-Position Volume Control, and Earphone Jack.
  2. For Multi-Band Radios: Quantity of twenty four (24) with a design consisting of a Speaker Microphone, Coiled Cord; with Rubber PTT Button, Emergency Button, 2-Position Volume Control, and Earphone Jack.
- Discreet Microphones (Police Use):
  1. Quantity of ten (10) consisting of a design that is a Covert Bluetooth, Earpiece/Microphone/PTT.
- Radio Carriers:
  1. Police Belts: Quantity of twenty six (26) Case, Leather, Premium, Belt Loop, D-Swivel, for Police Belt Use.
  2. Emergency Department Single Band Portable Radio: Quantity of one (1) Leather Case with Shoulder Strap.
  3. Emergency Management Multi-band Portable Radios: Quantity of two (2), Leather Case with Shoulder Strap.

**3.7** The contractor shall provide a means of communication between the West Palm Beach VA Medical Center and the Palm Beach County radio communication primary and secondary master sites.

**3.7.1** A data communication connection line/circuit (i.e. a fiber optic connection) that will have to be coordinated through a vendor. This data connection circuit will need to be brought from the Palm Beach County radio communication demarcation point to a demarcation point within the West Palm Beach VA medical center (coordinated with local medical center Office of Information and Technology personnel). A data communication line will then need to be installed from the medical centers demarcation point to the “repeater room” located on the 10<sup>th</sup> floor of the medical center. This data communication circuit is necessary to allow connection with the Palm Beach County master sites (design #2). No such data line currently exists between the Palm Beach County radio communication sites and the West Palm Beach medical center that could be used with this radio system design.

**3.8** The contractor shall provide any necessary or required spare parts (as deemed) for the installed radio system, and these spare parts must be on hand with either the qualified service and repair vendor or preferably stored at the West Palm Beach VAMC in a supplied lockable cabinet in our repeater radio room (Room 10B-300A).

## **4.0 SPECIFIC TASKS:**

# **West Palm Beach VAMC Two-way Radio Replacement**

**4.1** The contractor shall provide all equipment, materials and labor necessary to replace the existing Motorola SmartZone Trunked radio system to a complete turn-key P25 Phase 2 compliant system for the West Palm Beach Veterans Affairs Medical Center. The contractor shall provide all design drawings, shop drawings, and submittals as necessary to ensure that the scope of work is fully addressed within the best interest of the West Palm Beach VAMC.

**4.2** Contractor must upon completion of the installation and optimization process of West Palm Beach VAMC's infrastructure; provide administrator and user training, tailored to meet West Palm Beach VAMC's needs. The training sessions will be conducted by an experienced System Technologist, who will work closely with the West Palm Beach VAMC administrator(s) to ensure that all desired operational functions and features are covered in depth, and understood by all operators.

**4.3** Contractor shall provide configuration support and system maintenance in addition to network security as well as periodic software update and security enhancements for the West Palm Beach VAMC sites. All work shall be performed in full accordance with applicable local and federal regulations. All equipment and installation shall conform to the recommendations of the National Fire Protection Association (NFPA), including the National Electrical Code (NEC) and other applicable City/State/Federal statutes, regulations, and codes. No departures from specification requirements will be permitted without written approval. The Supplier shall use good safety practices while working. All hardware should be installed in such a manner to minimize damage and maximize patient and employee safety. All equipment and procedures shall conform to Occupational Safety and Health Administration (OSHA), National Emergency Management Association (NEMA), and American National Standards Institute (ANSI) Standards and conform to the Standard Building Code and the Standard Mechanical Code, and any other applicable City/State/Federal statutes, regulations, and codes.

**4.4** The contractor shall provide all labor and materials necessary for any site work including, but not limited to: electrical conduit with pull strings, back boxes, raceways, core drilling, concrete patching, and painting. Minimum of ¾" conduit shall be approved to be used for installation. All new cabling and wiring shall be pulled in conduit or cable tray. All barriers and firewalls will be sealed once breached.

## **4.5 System Infrastructure Design:**

**4.5.1** Design solution shall meet all specification/capabilities required

**4.5.2** System installation project plans must be designed and approved prior to installation (either in conjunction with the West Palm Beach VAMC design team and/or the liaison from Palm Beach County).

**4.5.3** A final design review and approval must occur before project start (with all parties).

**4.5.4** All software required shall be applicable to the system being installed and include all licensing and manuals. (All licenses must be included in cost, and reviewed by all parties for system design and approval).

## **5.0 WARRANTY/SERVICE CONTRACT:**

**5.1** The Contractor shall provide one-year full parts and labor warranty, with technical support available 24 hours per day, seven days per week.

**5.2** The contractor shall provide (through a manufacturer authorized and certified vendor) the ability to respond within two (2) hours to any and all required service calls here at the West Palm Beach VAMC.

**5.2** The contractor shall provide any additional years of service and maintenance contracts as options.

## **6.0 CONTRACTOR QUALIFICATIONS/CERTIFICATIONS:**

**6.1** Contractor shall provide qualified personnel to install communication system equipment, and possess and maintain required certifications to perform such work.

**6.2** Contractor shall have experience installing conduit, wiring, and terminations in support of manufacturer system requirements.

**6.3** Contractor shall have experience sealing wall penetrations, preventing the spread of fire, by using Hilti products.

**6.4** Contractor shall have experience in setting up requested equipment and certifying system operations and testing prior to government acceptance.

**6.5** Contractor shall have experience in facilitating approved manufacturer training for system operators.

**6.6** Contractor—and his/her employees—shall attend any required West Palm Beach VAMC training prior to the start of any work; and at least have (to include, but not limited to) the “10 Hour OSHA Training Course” completed and show proof of completion.

## **7.0 GOVERNMENT RESPONSIBILITIES:** The Government shall provide the following:

**7.1** Provide the building infrastructure upon which the system should be installed

**7.2** Required HVAC is in place in the existing “Repeater Room” (10B-300A), and will support the installed equipment

**7.3** The adequate space and furniture for proposed equipment in the “Repeater Room” (10B-300A), as well as Police Dispatch Operations (BA-201) and the Hospital Incident Command Center (3B-260)

**7.4** Sufficient space for equipment on rooftops

**7.5** Grounding at all RF site locations that meet standards

**7.6** Provide site access and escorts through work areas as needed.

**7.7** Provide access to both primary and back-up electrical power.

**7.8** The four (4) necessary (existing) licensed UHF frequency pairs required for repeater operation.

**7.9** Provide a demarcation point in the instance a vendor design requires a data connection (this will be the only thing the government can provide).

## **8.0 CONTRACTOR RESPONSIBILITIES:** The Contractor shall be responsible for the following:

**8.1** Contractor shall provide manufacturer certified and qualified personnel to install the proposed radio communication system and its equipment.

**8.2** Contractor shall be required to install any conduit, wiring, and terminations.

**8.3** Contractor shall be responsible to seal any penetrations through the walls using Hilti 2 hour rated fire stop products.

**8.4** Contractor shall attend a Kick Off meeting and Project Design meeting at the West Palm Beach VAMC in order to ensure that the radio system design and associated documentation match facility requirements. Depending on which design—1 or 2—all parties (West Palm Beach VAMC and/or Palm Beach County liaison(s)) will be in attendance.

**8.5** Contractor shall be responsible for all system/software testing after installation and prior to acceptance.

**8.6** The Contractor shall maintain the personnel, organization, and administrative control necessary to ensure that the work delivered meets the contract specifications and requirements with all internal and external stakeholders.

**8.7** Coordinate with the Palm Beach County radio communications team, and with a data communication vendor; and design, coordinate, create, install, a complete and reliable data communications circuit capable of tying together the Palm Beach County radio communications system with the West Palm Beach radio communications site equipment. This data circuit shall depend on the type of design being submitted by the vendor.

**9.0 TRAINING:** The contractor shall provide training as follows:

**9.1** Upon completion of the installation and optimization process of the new radio system at the West Palm Beach VAMC, training will immediately commence. The following areas of training shall be covered in a “train-the-trainer” style environment:

**9.1.1** System Administrator Training

**9.1.2** User Radio Training

**9.1.3** Dispatch Console Training

**9.2** Any recommended or additional training shall be listed as an option, and include pricing and justification.

**9.3** All training sessions shall ensure that the West Palm Beach VAMC appointed administrators and users are trained in all desired operational functions, and that features are covered in depth and understood by the students. All training sessions shall be conducted by an experienced systems technologist(s).

**10.0 SECURITY:**

**10.1** All vendors are required to obtain a contractor Personal Identification Verification (PIV) access card prior to entering facilities. Security clearance is not required. Certain sets of documents may be required (fingerprints, social security, State/Federal identification) and work will not commence until all of the requirements have been satisfied.

**11.0 CONTRACTING OFFICER REPRESENTATIVE (COR):** The Contracting Officer Representative shall be the technical point of contact for all work related requirements.

**11.1** The COR does not have authorization to change, alter, or remove any requirements stated in the performance work statement. The Contracting Officer is the only government authorized person to change the performance work statement or any resultant contract.

**12.0 PLACE OF PERFORMANCE:** Installation of radio communication equipment shall occur at the West Palm Beach VAMC, 7305 N. Military Trail West Palm Beach, FL 33410 and/or the designated Palm Beach County radio communications site(s).

**13.0 WORK HOURS:** The work shall be performed during normal working hours (8:00am – 4:30pm) Monday thru Friday, excluding federally approved holidays. However, the Contractor must be willing to work off-hours in selected areas if needed to accommodate the hospital's and/or Palm Beach County radio communications team functions.

**14.0 DELIVERY:** The government cannot accept deliveries on behalf of the contractor. You may however, coordinate with the Warehouse supervisor, Mrs. Lowre Mongo, [Lowre.Mongo@va.gov](mailto:Lowre.Mongo@va.gov), a time for your company representative to be at the receiving dock to accept deliveries.

**15.0 CONTRACTOR PERSONNEL AND MANAGEMENT:** Contractors, contractor personnel, subcontractors, and subcontractor personnel shall be subject to the same Federal laws, regulations, standards, and VA Directives and Handbooks as VA and VA personnel regarding information and information system security.

A. Access to VA information and VA information systems.

1. A contractor / subcontractor shall request logical (technical) or physical access to VA information and VA information systems for their employees, subcontractors, and affiliates only to the extent necessary to perform the services specified in the contract, agreement, or task order.
2. All contractors, subcontractors, and third-party servicers and associates working with VA information are subject to the same investigative requirements as those of VA appointees or employees who have access to the same types of information. The level and process of background security investigations for contractors must be in accordance with VA Directive and Handbook 0710, *Personnel Suitability and Security Program*. The Office for Operations, Security, and Preparedness is responsible for these policies and procedures.
3. Contract personnel who require access to national security programs must have a valid security clearance. National Industrial Security Program (NISP) was established by Executive Order 12829 to ensure that cleared U.S. defense industry contract personnel safeguard the classified information in their possession while performing work on contracts, programs, bids, or research and development efforts. The Department of Veterans Affairs does not have a Memorandum of Agreement with Defense Security Service (DSS). Verification of a Security Clearance must be processed through the Special Security Officer located in the Planning and National Security Service within the Office of Operations, Security, and Preparedness.

4. Custom software development and outsourced operations must be located in the U.S. to the maximum extent practical. If such services are proposed to be performed abroad and are not disallowed by other VA policy or mandates, the contractor/subcontractor must state where all non-U.S. services are provided and detail a security plan, deemed to be acceptable by VA, specifically to address mitigation of the resulting problems of communication, control, data protection, and so forth. Location within the U.S. may be an evaluation factor.
5. The contractor or subcontractor must notify the Contracting Officer immediately when an employee working on a VA system or with access to VA information is reassigned or leaves the contractor or subcontractor's employ. The Contracting Officer must also be notified immediately by the contractor or subcontractor prior to an unfriendly termination.
6. All contractor employees and subcontractor employees requiring access to VA information and VA information systems shall complete the following before being granted access to VA information and its systems.
  - a. Sign and acknowledge (either manually or electronically) understanding of and responsibilities for compliance with the *Contractor Rules of Behavior*, relating to access to VA information and information systems;
  - b. Successfully complete the *VA Cyber Security Awareness and Rules of Behavior* training and annually complete required security training.
  - c. Successfully complete the appropriate VA privacy training and annually complete required privacy training.
  - d. Successfully complete any additional cyber security or privacy training, as required for VA personnel with equivalent information system access to be defined by the VA program official and provided to the contracting officer for inclusion in the solicitation document – e.g., any role-based information security training required in accordance with NIST Special Publication 800-16, Information Technology Security Training Requirements.
7. Shall provide to the contracting officer and/or the COR a copy of the training certificates and certification of signing the Contractor Rules of Behavior for each applicable employee within one week of the initiation of the contract and annually thereafter, as required.
8. Failure to complete the mandatory annual training and sign the Rules of Behavior annually, within the timeframe required, is grounds for suspension or termination of all physical or electronic access privileges and removal from work on the contract until such time as the training and documents are complete.

## **SECTION C - CONTRACT CLAUSES**

### **C.1 52.203-99 PROHIBITION ON CONTRACTING WITH ENTITIES THAT REQUIRE CERTAIN INTERNAL CONFIDENTIALITY AGREEMENTS (DEVIATION) (FEB 2015)**

(a) The Contractor shall not require employees or contractors seeking to report fraud, waste, or abuse to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(b) The contractor shall notify employees that the prohibitions and restrictions of any internal confidentiality agreements covered by this clause are no longer in effect.

(c) The prohibition in paragraph (a) of this clause does not contravene requirements applicable to Standard Form 312, Form 4414, or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(d)(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Resolution Appropriations Act, 2015 (Pub. L. 113-235), use of funds appropriated (or otherwise made available) under that or any other Act may be prohibited, if the Government determines that the Contractor is not in compliance with the provisions of this clause.

(2) The Government may seek any available remedies in the event the contractor fails to comply with the provisions of this clause.

### **C.2 52.204-9 PERSONAL IDENTITY VERIFICATION OF CONTRACTOR PERSONNEL (JAN 2011)**

(a) The Contractor shall comply with agency personal identity verification procedures identified in the contract that implement Homeland Security Presidential Directive-12 (HSPD-12), Office of Management and Budget (OMB) guidance M-05-24, and Federal Information Processing Standards Publication (FIPS PUB) Number 201.

(b) The Contractor shall account for all forms of Government-provided identification issued to the Contractor employees in connection with performance under this contract. The Contractor shall return such identification to the issuing agency at the earliest of any of the following, unless otherwise determined by the Government:

It shall be the responsibility of the prime Contractor to return such identification to the issuing agency in accordance with the terms set forth in paragraph (b) of this section, unless otherwise approved in writing by the Contracting Officer.

Requests for changes shall be provided at <https://cage.dla.mil>. Change requests to the CAGE master file are accepted from the entity identified by the code.

(d) Contractors located outside the United States and its outlying areas that are not registered in SAM shall contact the appropriate National Codification Bureau (points of contact available at <http://www.nato.int/structur/AC/135/main/links/contacts.htm>) or NSPA at <https://eportal.nspa.nato.int/AC135Public/scage/CageList.aspx> to request CAGE changes.

#### **1. PURPOSE**

This Quality Assurance Surveillance Plan (QASP) provides a systematic method to evaluate performance for the stated contract. This QASP explains the following:

- What will be monitored.
- How monitoring will take place.
- Who will conduct the monitoring.
- How monitoring efforts and results will be documented.

This QASP does not detail how the contractor accomplishes the work. Rather, the QASP is created with the premise that the contractor is responsible for management and quality control actions to meet the terms of the contract. It is the Government's responsibility to be objective, fair, and consistent in evaluating performance.

This QASP is a "living document" and the Government may review and revise it on a regular basis. However, the Government shall coordinate changes with the contractor. Copies of the original QASP and revisions shall be provided to the contractor and Government officials implementing surveillance activities.

## **2. GOVERNMENT ROLES AND RESPONSIBILITIES**

The following personnel shall oversee and coordinate surveillance activities.

a. Contracting Officer (CO) - The CO shall ensure performance of all necessary actions for effective contracting, ensure compliance with the contract terms, and shall safeguard the interests of the United States in the contractual relationship. The CO shall also assure that the contractor receives impartial, fair, and equitable treatment under this contract. The CO is ultimately responsible for the final determination of the adequacy of the contractor's performance.

b. Contracting Officer's Technical Representative (COTR) - The COTR is responsible for technical administration of the contract and shall assure proper Government surveillance of the contractor's performance. The COTR shall keep a quality assurance file. The COTR is not empowered to make any contractual commitments or to authorize any contractual changes on the Government's behalf.

Performance standards define desired services. The Government performs surveillance to determine if the contractor exceeds, meets or does not meet these standards.

The Performance Requirements are listed below in Section 5. The Government shall use these standards to determine contractor performance and shall compare contractor performance to the Acceptable Quality Level (AQL). Compare contractor performance to the Acceptable Quality Level (AQL).

## **7. RATINGS**

The contractor is expected to meet the acceptable quality level at all time and will receive full annual inspections of facilities and services at the 100% level. The contractor will be rated on a scale of as follows:

1. Exceptional Quality
2. Meets Standard – There may be recommendations for process improvement recommended. Areas needing f/u or improvement will be provided by Contracting Officer Technical Representative
3. Needs Improvement – Areas requiring f/u and improvement will be provided by the Contracting Officer Technical Representative.
4. Unacceptable – Results in formal investigation and written plan of improvement.

If the agency is unable to comply with acceptable standards, the following will occur:

1. The contractor will receive written notice of a fact-finding investigation of all breaches of patient safety, and will be given 72 hours to respond to written safety recommendations. Refusal will result in termination of the contract.
2. The contractor will receive written documentation of any investigation with regarding patient satisfaction, basic services, and quality care and will comply with recommendations for performance improvement within 7 days.
3. The contractor will provide evidence of improvement processes within 7 days.

## **8. DOCUMENTING PERFORMANCE**

### **a. ACCEPTABLE PERFORMANCE**

The Government shall document positive performance. Any report may become a part of the supporting documentation for any contractual action.



## b. UNACCEPTABLE PERFORMANCE

When unacceptable performance occurs, the COTR shall inform the contractor. This will normally be in writing unless circumstances necessitate verbal communication. In any case the COTR shall document the discussion and place it in the COTR file.

When the COTR determines formal written communication is required, the COTR shall prepare a Contract Discrepancy Report (CDR), and present it to the contractor's program manager.

The contractor shall acknowledge receipt of the CDR in writing. The CDR will specify if the contractor is required to prepare a corrective action plan to document how the contractor shall correct the unacceptable performance and avoid a recurrence. The CDR will also state how long after receipt the contractor has to present this corrective action plan to the COTR. The Government shall review the contractor's corrective action plan to determine acceptability.

Any CDRs may become a part of the supporting documentation for any contractual action deemed necessary by the CO.

## 9. FREQUENCY OF MEASUREMENT

### a. Frequency of Measurement.

During contract performance, the COTR will periodically analyze whether the negotiated frequency of surveillance is appropriate for the work being performed.

### b. Frequency of Performance Assessment Meetings.

The COTR shall meet with the contractor **QUARTERLY** to assess performance and shall provide a written assessment.

## SECTION E - SOLICITATION PROVISIONS

### E.1 52.203-98 PROHIBITION ON CONTRACTING WITH ENTITIES THAT REQUIRE CERTAIN INTERNAL CONFIDENTIALITY AGREEMENTS—REPRESENTATION (DEVIATION) (FEB 2015)

(a) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Resolution Appropriations Act, 2015 (Pub. L. 113-235), Government agencies are not permitted to use funds appropriated (or otherwise made available) under that or any other Act for contracts with an entity that requires employees or subcontractors of such entity seeking to report fraud, waste, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or contractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(b) The prohibition in paragraph (a) of this provision does not contravene requirements applicable to Standard Form 312, Form 4414, or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(c) *Representation.* By submission of its offer, the Offeror represents that it does not require employees or subcontractors of such entity seeking to report fraud, waste, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

### E.2 52.204-16 COMMERCIAL AND GOVERNMENT ENTITY CODE REPORTING (JUL 2016)

(a) *Definition.* As used in this provision—

*Commercial and Government Entity (CAGE) code* means—

(1) An identifier assigned to entities located in the United States or its outlying areas by the Defense Logistics Agency (DLA) Commercial and Government Entity (CAGE) Branch to identify a commercial or government entity; or

(2) An identifier assigned by a member of the North Atlantic Treaty Organization (NATO) or by the NATO Support and Procurement Agency (NSPA) to entities located outside the United States and its outlying areas that the DLA Commercial and Government Entity (CAGE) Branch records and maintains in the CAGE master file. This type of code is known as a NATO CAGE (NCAGE) code.

(b) The Offeror shall enter its CAGE code in its offer with its name and address or otherwise include it prominently in its proposal. The CAGE code entered must be for that name and address. Enter “CAGE” before the number. The CAGE code is required prior to award.

(c) CAGE codes may be obtained via—

SAM registrants located outside the United States and its outlying areas shall obtain a NCAGE code prior to registration in SAM (see paragraph (c)(3) of this provision).

(2) The DLA Commercial and Government Entity (CAGE) Branch. If registration in SAM is not required for the subject procurement, and the offeror does not otherwise register in SAM, an offeror located in the United States or its outlying areas may request that a CAGE code be assigned by submitting a request at <https://cage.dla.mil>.

(3) The appropriate country codification bureau. Entities located outside the United States and its outlying areas may obtain an NCAGE code by contacting the Codification Bureau in the foreign entity's country if that country is a member of NATO or a sponsored nation. NCAGE codes may be obtained from the NSPA at <https://eportal.nspa.nato.int/AC135Public/scage/CageList.aspx> if the foreign entity's country is not a member of NATO or a sponsored nation. Points of contact for codification bureaus, as well as additional information on obtaining NCAGE codes, are available at <http://www.nato.int/structur/AC/135/main/links/contacts.htm>.

(d) Additional guidance for establishing and maintaining CAGE codes is available at <https://cage.dla.mil>.

(e) When a CAGE Code is required for the immediate owner and/or the highest-level owner by 52.204-17 or 52.212-3(p), the Offeror shall obtain the respective CAGE Code from that entity to supply the CAGE Code to the Government.

(f) Do not delay submission of the offer pending receipt of a CAGE code.

### **E.3 52.209-5 REPRESENTATION BY CORPORATIONS REGARDING AN UNPAID TAX LIABILITY OR A FELONY CONVICTION UNDER ANY FEDERAL LAW (DEVIATION)(MAR 2012)**

(a) In accordance with Division H, sections 8124 and 8125 of P.L. 112-74 and sections 738 and 739 of P.L. 112-55 none of the funds made available by either Act may be used to enter into a contract with any corporation that—

(1) Has an unpaid federal tax liability, unless the agency has considered suspension or debarment of the corporation and the Suspension and Debarment Official has made a determination that this action is not necessary to protect the interests of the Government.

(2) Has a felony criminal violation under any Federal or State law within the preceding 24 months, unless the agency has considered suspension or debarment of the corporation and Suspension and

Debarment Official has made a determination that this action is not necessary to protect the interests of the Government.

(b) The Offeror represents that—

(1) The offeror does ☐ does not ☐ have any unpaid Federal tax liability that has been assessed and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability.

(2) The offeror, its officers or agents acting on its behalf have ☐ have not ☐ been convicted of a felony criminal violation under a Federal or State law within the preceding 24 months.

#### **E.4 52.212-1 INSTRUCTIONS TO OFFERORS—COMMERCIAL ITEMS (JAN 2017)**

(a) *North American Industry Classification System (NAICS) code and small business size standard.* The NAICS code and small business size standard for this acquisition appear in Block 10 of the solicitation cover sheet (SF 1449). However, the small business size standard for a concern which submits an offer in its own name, but which proposes to furnish an item which it did not itself manufacture, is 500 employees.

(b) *Submission of offers.* Submit signed and dated offers to the office specified in this solicitation at or before the exact time specified in this solicitation. Offers may be submitted on the SF 1449, letterhead stationery, or as otherwise specified in the solicitation. As a minimum, offers must show—

- (1) The solicitation number;
- (2) The time specified in the solicitation for receipt of offers;
- (3) The name, address, and telephone number of the offeror;
- (4) A technical description of the items being offered in sufficient detail to evaluate compliance with the requirements in the solicitation. This may include product literature, or other documents, if necessary;
- (5) Terms of any express warranty;
- (6) Price and any discount terms;
- (7) "Remit to" address, if different than mailing address;
- (8) A completed copy of the representations and certifications at FAR 52.212-3 (see FAR 52.212-3(b) for those representations and certifications that the offeror shall complete electronically);
- (9) Acknowledgment of Solicitation Amendments;
- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and

(11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) *Period for acceptance of offers.* The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

(d) *Product samples.* When required by the solicitation, product samples shall be submitted at or prior to the time specified for receipt of offers. Unless otherwise specified in this solicitation, these samples shall be submitted at no expense to the Government, and returned at the sender's request and expense, unless they are destroyed during preaward testing.

(e) *Multiple offers.* Offerors are encouraged to submit multiple offers presenting alternative terms and conditions, including alternative line items (provided that the alternative line items are consistent with subpart 4.10 of the Federal Acquisition Regulation), or alternative commercial items for satisfying the requirements of this solicitation. Each offer submitted will be evaluated separately.

(f) Late submissions, modifications, revisions, and withdrawals of offers.

(1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and—

(A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or

(B) There is acceptable evidence to establish that it was received at the Government installation designated for receipt of offers and was under the Government's control prior to the time set for receipt of offers; or

(C) If this solicitation is a request for proposals, it was the only proposal received.

(ii) However, a late modification of an otherwise successful offer, that makes its terms more favorable to the Government, will be considered at any time it is received and may be accepted.

(3) Acceptable evidence to establish the time of receipt at the Government installation includes the time/date stamp of that installation on the offer wrapper, other documentary evidence of receipt maintained by the installation, or oral testimony or statements of Government personnel.

(4) If an emergency or unanticipated event interrupts normal Government processes so that offers cannot be received at the Government office designated for receipt of offers by the exact time specified in

the solicitation, and urgent Government requirements preclude amendment of the solicitation or other notice of an extension of the closing date, the time specified for receipt of offers will be deemed to be extended to the same time of day specified in the solicitation on the first work day on which normal Government processes resume.

(5) Offers may be withdrawn by written notice received at any time before the exact time set for receipt of offers. Oral offers in response to oral solicitations may be withdrawn orally. If the solicitation authorizes facsimile offers, offers may be withdrawn via facsimile received at any time before the exact time set for receipt of offers, subject to the conditions specified in the solicitation concerning facsimile offers. An offer may be withdrawn in person by an offeror or its authorized representative if, before the exact time set for receipt of offers, the identity of the person requesting withdrawal is established and the person signs a receipt for the offer.

(g) *Contract award (not applicable to Invitation for Bids)*. The Government intends to evaluate offers and award a contract without discussions with offerors. Therefore, the offeror's initial offer should contain the offeror's best terms from a price and technical standpoint. However, the Government reserves the right to conduct discussions if later determined by the Contracting Officer to be necessary. The Government may reject any or all offers if such action is in the public interest; accept other than the lowest offer; and waive informalities and minor irregularities in offers received.

(h) *Multiple awards*. The Government may accept any item or group of items of an offer, unless the offeror qualifies the offer by specific limitations. Unless otherwise provided in the Schedule, offers may not be submitted for quantities less than those specified. The Government reserves the right to make an award on any item for a quantity less than the quantity offered, at the unit prices offered, unless the offeror specifies otherwise in the offer.

The Offeror shall enter, in the block with its name and address on the cover page of its offer, the annotation “Unique Entity Identifier” followed by the unique entity identifier that identifies the Offeror’s name and address. (5) For acquisitions of commercial items, the make and model of the item to be delivered by the successful offeror.

(6) Reasonable responses to relevant questions posed by the debriefed offeror as to whether source-selection procedures set forth in the solicitation, applicable regulations, and other applicable authorities were followed by the agency.

## **E.5 52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS— COMMERCIAL ITEMS (JAN 2017)**

The Offeror shall complete only paragraph (b) of this provision if the Offeror has completed the annual representations and certification electronically via the System for Award Management (SAM) Web site located at <https://www.sam.gov/portal>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (u) of this provision.

(a) *Definitions.* As used in this provision—

*Administrative merits determination* means certain notices or findings of labor law violations issued by an enforcement agency following an investigation. An administrative merits determination may be final or be subject to appeal or further review. To determine whether a particular notice or finding is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

*Arbitral award or decision* means an arbitrator or arbitral panel determination that a labor law violation occurred, or that enjoined or restrained a violation of labor law. It includes an award or decision that is not final or is subject to being confirmed, modified, or vacated by a court, and includes an award or decision resulting from private or confidential proceedings. To determine whether a particular award or decision is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

*Civil judgment means—*

(1) In paragraph (h) of this provision: A judgment or finding of a civil offense by any court of competent jurisdiction.

(2) In paragraph (s) of this provision: Any judgment or order entered by any Federal or State court in which the court determined that a labor law violation occurred, or enjoined or restrained a violation of labor law. It includes a judgment or order that is not final or is subject to appeal. To determine whether a particular judgment or order is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

*DOL Guidance* means the Department of Labor (DOL) Guidance entitled: “Guidance for Executive Order 13673, ‘Fair Pay and Safe Workplaces’ “. The DOL Guidance, dated August 25, 2016, can be obtained from [www.dol.gov/fairpayandsafeworkplaces](http://www.dol.gov/fairpayandsafeworkplaces).

*Economically disadvantaged women-owned small business (EDWOSB) concern* means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

*Enforcement agency* means any agency granted authority to enforce the Federal labor laws. It includes the enforcement components of DOL (Wage and Hour Division, Office of Federal Contract Compliance Programs, and Occupational Safety and Health Administration), the Equal Employment Opportunity Commission, the Occupational Safety and Health Review Commission, and the National Labor Relations Board. It also means a State agency designated to administer an OSHA-approved State Plan, but only to the extent that the State agency is acting in its capacity as administrator of such plan. It does not include other Federal agencies which, in their capacity as contracting agencies, conduct investigations of potential labor law violations. The enforcement agencies associated with each labor law under E.O. 13673 are—

- (i) The Fair Labor Standards Act;

- (iv) 41 U.S.C. chapter 67, formerly known as the Service Contract Act;
- (v) The Family and Medical Leave Act; and
- (vi) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors);

(2) Department of Labor Occupational Safety and Health Administration (OSHA) for—

- (i) The Occupational Safety and Health Act of 1970; and
- (ii) OSHA-approved State Plans;

(3) Department of Labor Office of Federal Contract Compliance Programs (OFCCP) for—

- (i) Section 503 of the Rehabilitation Act of 1973;
- (ii) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974; and
- (iii) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity);

(4) National Labor Relations Board (NLRB) for the National Labor Relations Act; and

(5) Equal Employment Opportunity Commission (EEOC) for—

- (i) Title VII of the Civil Rights Act of 1964;
- (ii) The Americans with Disabilities Act of 1990;

- (9) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974.
- (10) The Family and Medical Leave Act.
- (11) Title VII of the Civil Rights Act of 1964.
- (12) The Americans with Disabilities Act of 1990.
- (13) The Age Discrimination in Employment Act of 1967.
- (14) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors).

(15) Equivalent State laws as defined in the DOL Guidance. (The only equivalent State laws implemented in the FAR are OSHA-approved State Plans, which can be found at [www.osha.gov/dcsp/osp/approved\\_state\\_plans.html](http://www.osha.gov/dcsp/osp/approved_state_plans.html)).

*Labor law decision* means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of “labor laws”.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Restricted business operations* means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

*Service-disabled veteran-owned small business concern*—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and
