2. This is a competitive solicitation; 100% set-aside for Service Disabled Veteran Owned Small Business (SDVOSB). Offeror must be verified SDVOSB at the time of offer submission due date. The North American Industry Classification System (NAICS) code for this acquisition is 541620 – Environmental Consulting Services and the small business size standard is \$15 million.
