The OEM is the only vendor that has access to the software/equipment that operates this system. The OEM does not train or distribute manufactured equipment or software by third party vendors to conduct installation of updated software, replacement parts, or preventative maintenance services on their equipment.

(6) DESCRIBE THE MARKET RESEARCH CONDUCTED AMONG SCHEDULE HOLDERS AND THE RESULTS OR A STATEMENT OF THE REASON MARKET RESEARCH WAS NOT CONDUCTED:

A market survey was conducted and it was found that only one vendor can provide these services as these services are proprietary in nature. Only the original equipment manufacturer (OEM) trained technician has the capability to provide these services. OEM does not train third party vendors to conduct installation & maintenance services on their equipment.
