Firm fixed price BPA call for Carto Catheters and related supplies from Biosense Webster off their BPA VA119-16-A-0066 for the Electrophysiology Lab at the Minneapolis VA Health Care System.

**(3) (a) A DESCRIPTION OF THE SUPPLIES OR SERVICES REQUIRED TO MEET THE AGENCY'S NEED:**

Catheters and Supplies for use with the Carto Mapping System; which provides mapping capability of certain nerve pathways in the heart. These catheters and supplies are used during ablation procedures to locate and terminate abnormal rhythms that can be detrimental to the patient.

The Minneapolis VA Health Care System’s Electrophysiology lab currently utilizes a Carto 3D mapping system manufactured by Biosense Webster Inc. The Minneapolis VA requires additional catheters (Pentaray & Soundstar) for utilization with the system. The new catheters need to be compatible with the existing ablation equipment. No other manufacture’s catheters are compatible with the Carto system. The Strategic Acquisition Center awarded a multiple award BPA to Biosense Webster, St. Jude Medical Inc and Boston Scientific. Neither St. Jude Medical Inc nor Boston Scientific can provide compatible catheters.

No other manufacture’s catheters are compatible with the Carto system, and these items are available from Biosense Webster on BPA VA119-16-A-0066.

**(6) DESCRIBE THE MARKET RESEARCH CONDUCTED AMONG SCHEDULE HOLDERS AND THE RESULTS OR A STATEMENT OF THE REASON MARKET RESEARCH WAS NOT CONDUCTED:**

VetBiz was searched under NAICS code 339112 which produced 215 results. A search with the keyword “biosense” produced zero results. The Strategic Acquisition Center awarded a multiple award BPA to Biosense Webster, St. Jude Medical Inc and Boston Scientific. Neither St. Jude Medical Inc not Boston Scientific can provide compatible catheters. Biosense Webster has verified that 2 of the items are not available through their BPA. These items have been requested to be added to the BPA but have not yet been added. These 2 items are only available through the open market directly from Biosense Webster, no other vendors are authorized to distribute them.




