

JUSTIFICATION FOR SINGLE SOURCE AWARDS IAW [VAAR 819.7007](#)
(OVER MICRO-PURCHASE THRESHOLD(\$3.5K) BUT NOT EXCEEDING THE SAT (\$150K))

819.7007 Sole source awards to service-disabled Veteran-owned small business concerns.

(a) A contracting officer may award contracts to SDVOSB concerns on a sole source basis provided:

- (1) The anticipated award price of the contract (including options) will not exceed \$5 million;
- (2) The requirement is synopsized in accordance with FAR part 5;
- (3) The SDVOSB concern has been determined to be a responsible contractor with respect to performance; and
- (4) Award can be made at a fair and reasonable price.

(b) The contracting officer's determination whether to make a sole source award is a business decision wholly within the discretion of the contracting officer. A determination that only one SDVOSB concern is available to meet the requirement is not required.

(c) When conducting a SDVOSB sole source acquisition, the contracting officer shall ensure businesses are registered and verified as eligible in the VIP database prior to making an award.

2. BRIEF DESCRIPTION OF SUPPLIES OR SERVICES REQUIRED AND THE INTENDED USE:

This is a requirement for one (1) Double Wall Exam, Single Wall Control Suite w/thick panel construction to include installation as well as any user manuals.

This requirement is for One (1) Audiology Sound Suite to include installation, maintenance, service and part manuals. Solicitation number VA240C-17-Q-0039, was released on GSA Advantage on 7/20/2017 with a due date of 7/28/2017. No quotes were received to fulfill this requirement. A new solicitation was created and released on FBO on 8/11/2017 with a due date of 8/25/2017. The solicitation was then extended until 9/1/2017. The solicitation closed with no quotes. The contracting officer reached out to an SDVOSB who confirmed they have the capabilities to fulfill the requirement in its entirety.

4. DESCRIPTION OF MARKET RESEARCH CONDUCTED AND RESULTS OR STATEMENT WHY IT WAS NOT CONDUCTED:

Market research was conducted to determine if there were any Service Disabled Veteran Owned Small Business (SDVOSB) concerns capable of providing the required supplies. A SDVOSB was identified and in accordance with Veterans Affairs Acquisition Regulation (VAAR) 819.7007 Sole source awards to service-disabled Veteran-owned small business concerns, the Contracting Officer has chosen to acquire the required supplies on a sole source bases from a SDVOSB concern.
