**1. Background**

- 1.1. The Cardio-Pulmonary Service at the Veterans Health Care System of the Ozarks (VHSO) performs arterial blood gas testing on both inpatient and outpatients utilizing an FDA approved blood gas analyzer, and backup analyzer.

**2. Purpose**

- 2.1. The overall purpose is to provide two Arterial Blood Gas (ABG)/Co-oximetry (Co-Ox) analyzers, all consumables necessary for operation and on-site service for the Veterans Health Care System of the Ozarks (VHSO) in the Cardio-Pulmonary Clinic, room 1259-21 and in the Cardio-Pulmonary Testing room, room 126-01, 1100 N. College Ave., Fayetteville, AR 72703.

**3. Scope**

- 3.1. The Contractor shall provide, transport, install, validate and train staff on all listed equipment. All products must meet all salient characteristics defined in this section.
- 3.2. All equipment and installation must meet manufacturers and VA specifications.
- 3.3. The Contractor shall furnish all supplies, equipment, facilities and services required for delivery, verification of operation and installation of the equipment to include staff training.
- 3.4. The Contractor is responsible for any missing parts and components not included in order to carry out the installation.

**3.5. Salient Characteristic**

- 3.5.1. Arterial Blood Gas Analyzer with Co-Oximetry, Quantity = 2
  - 3.5.1.1. FDA approved to perform ABG/Co-Ox on various sample types.
  - 3.5.1.2. Bio-safe, cartridge based blood gas system with reagents and waste 100% confined to the cartridge.
  - 3.5.1.3. Bench top, not to exceed 100 lbs.
  - 3.5.1.4. Dimension not to exceed 20" W x 20" D x 20" H.
  - 3.5.1.5. Built in cartridge based auto-QC that meets all regulatory standards. QC must be sampled through the same port as patient samples (No IQCP required).
  - 3.5.1.6. Automatic calibration for blood gases at specified intervals compliant with regulatory agencies.
  - 3.5.1.7. Capability to analyze and temperature correct the following parameters – pH, pCO<sub>2</sub>, pO<sub>2</sub>, HCO<sub>3</sub>, sO<sub>2</sub>, Base Excess, Hemoglobin (tHb) and Carboxyhemoglobin (COHb).
  - 3.5.1.8. Ability to calibrate hemoglobin.
  - 3.5.1.9. Clot detection and automatic clearance capability.
  - 3.5.1.10. Automatic cleaning of probe.
  - 3.5.1.11. Onboard keyboard and integrated barcode reader for the ability to input, or download, patient name, O<sub>2</sub> appliance, FIO<sub>2</sub> and/or O<sub>2</sub> LPM, SSN, Accession # and sample type.
  - 3.5.1.12. Sample types: Arterial, venous, mixed venous, capillary & proficiency tests, at a minimum.
  - 3.5.1.13. Minimal operator performed maintenance.
  - 3.5.1.14. Onboard reagent management system with barcode reader.

- 3.5.1.15. Bidirectional connection to VistA (LIS) via an HL7 interface such as Data Innovations and Radiance.
- 3.5.1.16. Operating system must be Windows 7 or above.
- 3.5.1.17. Ability to lockout operators based on specific criteria.
- 3.5.1.18. Ability to lockout testing in the event of failed QC.
- 3.5.1.19. Ability to do STAT testing.
- 3.5.1.20. Software upgrades at no additional charge.
- 3.5.1.21. Warranty for the entire agreement period.
- 3.5.1.22. Linearity kits, 2 per year, per analyzer.
- 3.5.1.23. Manual quality control material as necessary for troubleshooting and lot number changes.
- 3.5.1.24. Maintenance and service: Full service must be available on a 24/7/365 basis. Telephone technical support must be available 24 hours daily and on-site service provided, not to exceed 24 hours following determination that site service is required, for each device.
- 3.5.1.25. Vendor will assist with correlation studies and provide all set up materials required for all testing required for initial setup at no charge, for each device.
- 3.5.1.26. Analyzers will remain the property of the vendor.
- 3.5.2. All materials necessary to validate operation of the analyzers to include controls, calibrators and reagents for completion of validation of the analyzers.
- 3.5.3. Connection to existing VistA interface manager system (Data Innovations and Radiance).
  - 3.5.3.1. Connection to system to include successful ordering, accessioning and resulting in VistA of all tests reportable (directly measured and calculated) with proper normal ranges and units of measure.
  - 3.5.3.2. Connection should allow bidirectional interface with VistA.
- 3.5.4. On-site training of at least 3 super users shall be provided with documentation of satisfactory completion of the training provided to the COR or designee.
- 3.5.5. Analyzers must be fully installed, validated and ready to perform patient testing on, or before, 10/1/2017.
- 3.6. Delivery and Installation**
  - 3.6.1. Delivery**
    - 3.6.1.1. Contractor shall deliver all equipment to the Veterans Health Care System of the Ozarks (VHSO) Cardio-Pulmonary Department, 1100 N. College Ave., Fayetteville, AR 72703 by 10/01/2017
  - 3.6.2. Installation**
    - 3.6.2.1. Install all equipment according to manufacturer's specifications maintaining Federal, and Local safety standards.
    - 3.6.2.2. Installation must be completed by 9/15/2017. All work shall be completed between 8:00 a.m. and 4:30 p.m. Monday – Friday. With the exception on Federal Holidays.

**4. Term of Agreement:**

- 4.1. The award will be for a lease agreement for 60 months starting 10/1/2017 and ending on 9/30/2022 and shall be effective for the term of the Contract including additional extensions. The Contracting Officer is the only official authorized to make changes to the contract.

**5. Type of Contract:** Lease agreement.

**6. COR Authority:**

- 6.1. In no event is the COR empowered to change any of the terms and conditions of the contract. All changes, to any section of this contract, shall be made only by the Contracting Officer pursuant to a properly executed modification. The types of actions within the purview of the COR's authority are to ensure that the Contractor performs the technical requirements of the contract, and to notify the Contracting Officer of any deficiencies observed. A Letter of Designation shall be issued to the COR and a copy shall be sent to the Contractor at the time of contract kickoff meeting or post-award conference setting forth in full the responsibilities and limitations of the COR.

**7. Changes to Requirement**

- 7.1. Any changes to this solicitation shall be approved through written correspondence from the Contracting Officer.
- 7.2. The Contracting Officer will be the sole authorized official to release verbally or in writing, any data, the draft deliverables, the final deliverables, or any other written or printed materials pertaining to this task order. There shall be no information released by the Contractor. Any request for information relating to this contract presented to the Contractor shall be submitted to the Contracting Officer for response.

**8. Quality Control**

- 8.1. After contract award, the Contractor shall implement and follow the Quality Assurance and Surveillance Plan (QASP) that it submitted as part of its proposal, and accepted by the Government. The solution-based PMP using the Quality Control Plan or QASP with performance goals and acceptable quality levels is necessary to ensure quality for this project. The Contractor shall address any issues meeting established Government performance goals as needed. The Contractor will provide full access of its internal QASP for the COR to monitor performance.
- 8.2. As stated in the Quality Control Plan or QASP, the Government shall evaluate the Contractor's performance under this agreement. For those tasks listed in the Quality Control Plan or QASP, the COR or evaluators shall follow the methods of surveillance specified in this agreement. The Government shall record all surveillance observations. When an observation indicates defective performance, the COR shall forward the observation to the Contractor manager or alternate(s), who shall initial the observation. The initialing of the observation does not necessarily constitute concurrence with the observation, only acknowledgment that he or she has been made aware of the defective performance. Government surveillance of tasks not listed in the Quality Control Plan/QASP or by methods other than those listed in the Quality Control Plan/QASP may occur during the performance period of this agreement. Such surveillance shall be done according to standard inspection procedures or other agreement provisions. Any action taken by the contracting officer as a result of surveillance shall be in accordance with the terms of this agreement.

## SECTION E - SOLICITATION PROVISIONS

### E.1 52.212-2 EVALUATION—COMMERCIAL ITEMS (OCT 2014)

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

Technical and past performance, when combined, are .

(b) *Options.* The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

(End of Provision)

### E.2 52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS—COMMERCIAL ITEMS (JAN 2017)

The Offeror shall complete only paragraph (b) of this provision if the Offeror has completed the annual representations and certification electronically via the System for Award Management (SAM) Web site located at <https://www.sam.gov/portal>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (u) of this provision.

(a) *Definitions.* As used in this provision—

*Administrative merits determination* means certain notices or findings of labor law violations issued by an enforcement agency following an investigation. An administrative merits determination may be final or be subject to appeal or further review. To determine whether a particular notice or finding is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

*Arbitral award or decision* means an arbitrator or arbitral panel determination that a labor law violation occurred, or that enjoined or restrained a violation of labor law. It includes an award or decision that is not final or is subject to being confirmed, modified, or vacated by a court, and includes an award or

decision resulting from private or confidential proceedings. To determine whether a particular award or decision is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

*Civil judgment means—*

(1) In paragraph (h) of this provision: A judgment or finding of a civil offense by any court of competent jurisdiction.

(2) In paragraph (s) of this provision: Any judgment or order entered by any Federal or State court in which the court determined that a labor law violation occurred, or enjoined or restrained a violation of labor law. It includes a judgment or order that is not final or is subject to appeal. To determine whether a particular judgment or order is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

*DOL Guidance* means the Department of Labor (DOL) Guidance entitled: “Guidance for Executive Order 13673, ‘Fair Pay and Safe Workplaces’ “. The DOL Guidance, dated August 25, 2016, can be obtained from [www.dol.gov/fairpayandsafeworkplaces](http://www.dol.gov/fairpayandsafeworkplaces).

*Economically disadvantaged women-owned small business (EDWOSB) concern* means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

*Enforcement agency* means any agency granted authority to enforce the Federal labor laws. It includes the enforcement components of DOL (Wage and Hour Division, Office of Federal Contract Compliance Programs, and Occupational Safety and Health Administration), the Equal Employment Opportunity Commission, the Occupational Safety and Health Review Commission, and the National Labor Relations Board. It also means a State agency designated to administer an OSHA-approved State Plan, but only to the extent that the State agency is acting in its capacity as administrator of such plan. It does not include other Federal agencies which, in their capacity as contracting agencies, conduct investigations of potential labor law violations. The enforcement agencies associated with each labor law under E.O. 13673 are—

(1) Department of Labor Wage and Hour Division (WHD) for—

- (i) The Fair Labor Standards Act;
- (ii) The Migrant and Seasonal Agricultural Worker Protection Act;
- (iii) 40 U.S.C. chapter 31, subchapter IV, formerly known as the Davis-Bacon Act;
- (iv) 41 U.S.C. chapter 67, formerly known as the Service Contract Act;
- (v) The Family and Medical Leave Act; and
- (vi) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors);

(2) Department of Labor Occupational Safety and Health Administration (OSHA) for—

- (i) The Occupational Safety and Health Act of 1970; and
- (ii) OSHA-approved State Plans;

(3) Department of Labor Office of Federal Contract Compliance Programs (OFCCP) for—

(i) Section 503 of the Rehabilitation Act of 1973;

(ii) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974; and

(iii) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity);

(4) National Labor Relations Board (NLRB) for the National Labor Relations Act; and

(5) Equal Employment Opportunity Commission (EEOC) for—

(i) Title VII of the Civil Rights Act of 1964;

(ii) The Americans with Disabilities Act of 1990;

(iii) The Age Discrimination in Employment Act of 1967; and

(iv) Section 6(d) of the Fair Labor Standards Act (Equal Pay Act).

*Forced or indentured child labor* means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

*Highest-level owner* means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

*Immediate owner* means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

*Inverted domestic corporation* means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

*Labor compliance agreement* means an agreement entered into between a contractor or subcontractor and an enforcement agency to address appropriate remedial measures, compliance assistance, steps to resolve issues to increase compliance with the labor laws, or other related matters.

*Labor laws* means the following labor laws and E.O.s:

(1) The Fair Labor Standards Act.

(2) The Occupational Safety and Health Act (OSHA) of 1970.
