B.2 SALIENT CHARACTERISTICS

Functional/Performance/Specifications

General Equipment Name: Surgical Power Tool Upgrade

“Brand Name or Equal To” System 8 or RemB, Manufactured by Stryker Corporation

General

- Must be compatible with the existing Stryker Core (consolidated operating room equipment) Console. (The powered instrument driver and central operating system for powered integration).
- The Power Tool System must be a smart device capable of connecting to the online data module, Smart Equipment Management (SEM)
- Must be compatible with existing Stryker battery chargers.
- Must be compatible with existing Stryker Power Tool Attachments.
- Must have batteries that can live on the shelf for 30 days without losing power.
- Tools must be capable of being actively washed and hand-pieces temporarily submerged during cleaning, prior to sterilization.
- Hand tools must feature an oscillating tip saw with reduced noise and vibration features.
- Must have a cordless driver capable of drilling, cutting and reaming during sports medicine and orthopedic trauma procedures.
- Must have Power Ream Technology for increased torque during challenging reaming procedures.
- Must have enhanced hand piece control for precise surgical processes.
- Must have threaded and fluted pins.

Performance

- The rotary hand piece must offer 157 in/lbs. of torque.
- The sagittal saw must offer 12,000 cpm in fast mode, and 10,000 cpm in standard mode.
- The saw must have superior chip clearance to reduce heat from friction thereby protecting bone tissue.
- The reciprocating saw must have two cut speeds: 14,000 cpm in fast mode, and up to 11,000 cpm in standard mode.
- The hand pieces must not weigh more than 2.5 lbs.
- The lithium ion batteries must allow for up to 30 days on the shelf.
- The sagittal saw must offer 12,000 cpm in fast mode, and 10,000 cpm in standard mode to reduce heat from friction and protect patient bone tissue.)
- Must have a dedicated wire driving hand piece in the universal driver.
- The micro drill must have a maximum of 50,000 rpm.
- Must be able to load blades and burs without additional tools.
- Must have a removable hand switch to allow the same hand piece to be used for multiple functions.
- Must have the following range of micro electric powered hand pieces:
 - Universal Driver
 - Dedicated Wire Driver
 - Sagittal Saw
 - Oscillating Saw
 - Reciprocating Saw

- Microdrill, equipped with a touch screen interface
- The sagittal saw must have a rotating, indexing head, for maximum blade positions to provide ease of use when cutting.
- The cordless driver must not weigh more than 1.3 lbs, to maximize maneuverability.
- The cordless driver must run at 1,500 rpm.
- The SABO saw must not weigh more than 1.4 lbs, to maximize maneuverability.
- The SABO saw must be capable of cuts at 25,000 cpm.
- The lithium ion batteries must be capable of up to 30 days on the shelf.

Efficiency

- The rotary hand pieces must include an integrated drill/ream switch.
- Must have a low battery indicator light. This characteristic will alert the operating room staff when battery energy runs low and allow them to proactively change the battery without interrupting surgery.
- Must have a battery charger that monitors hand piece performance.
- Must have sterilization case inserts that are automated washer compatible
- Must have a sealed container option to eliminate the need for blue wrap.
- Batteries must have a 30-day shelf life after charging.
- Must have dedicated hand pieces for each component including the sagittal saw, rotary drill, reciprocating saw, and precision saw. Dedicated hand pieces correlate to less time changing attachments back and forth between procedures.

Safety

- The lithium ion batteries must come equipped with Active Cell Protection (ACP) to remove voltage when the battery is not on a hand piece or charger. This ACP technology will allow the battery to continuously monitor itself to ensure safe, efficient operation.
- The hand pieces must be fully submersible, preventing liquid penetration from normal use.

Warranty and Delivery

- Warranty - Must have a minimum 12-month manufacturer's warranty.
- Delivery Requirements:

SECTION C - CONTRACT CLAUSES

(iii) The business meets Federal small business size standards for the applicable North American Industry Classification System (NAICS) code identified in the solicitation document;

(iv) The business has been verified for ownership and control pursuant to 38 CFR 74 and is so listed in the Vendor Information Pages database, (<https://www.vip.vetbiz.gov>); and

(v) The business will comply with subcontracting limitations in 13 CFR 125.6, as applicable

(2) “Service-disabled veteran” means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

(b) *General.*

(1) Offers are solicited only from verified service-disabled veteran-owned small business concerns. Offers received from concerns that are not verified service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified service-disabled veteran-owned small business concern.

(c) *Representation.* By submission of its offer, the Offeror represents that it does not require employees or subcontractors of such entity seeking to report fraud, waste, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(a)(1) The Offeror certifies, to the best of its knowledge and belief, that—

(iv) The taxpayer has filed for bankruptcy protection. The taxpayer is not delinquent because enforced collection action is stayed under 11 U.S.C. 362 (the Bankruptcy Code).

A liability is not finally determined if there is a pending administrative or judicial challenge.
