The solicitation number is **VA257-17-Q-1326** and is issued as a Request for Quotation (RFQ). The solicitation document and incorporated provisions and clauses are those in effect through the Federal Acquisition Regulations (FAR). The associated North American Industrial Classification System (NAICS) code for this procurement is **561320** with a small business size standard of \$27.5M. The PSC is **Q519: Medical, Psychiatry**. The Government contemplates an award of a Firm Fixed Priced Indefinite Delivery Indefinite Quantity (IDIQ) contract resulting from this solicitation. All responsible sources who qualify under item number 1 below may submit a quote.

1. Only Small Businesses, SDVOSBs, and VOSBs will be considered for award. Only SDVOSBs/VOSB listed as **verified** in the VIP database ([www.vip.vetbiz.gov](http://www.vip.vetbiz.gov)) when an offer is submitted and at the time of contract award will be qualify as an SDVOSB/VOSB. Small Businesses that are not verified in VetBiz will be considered a Small Business. Please beware that First preference shall be given to offerors that are either **verified** SDVOSB or VOSB.
