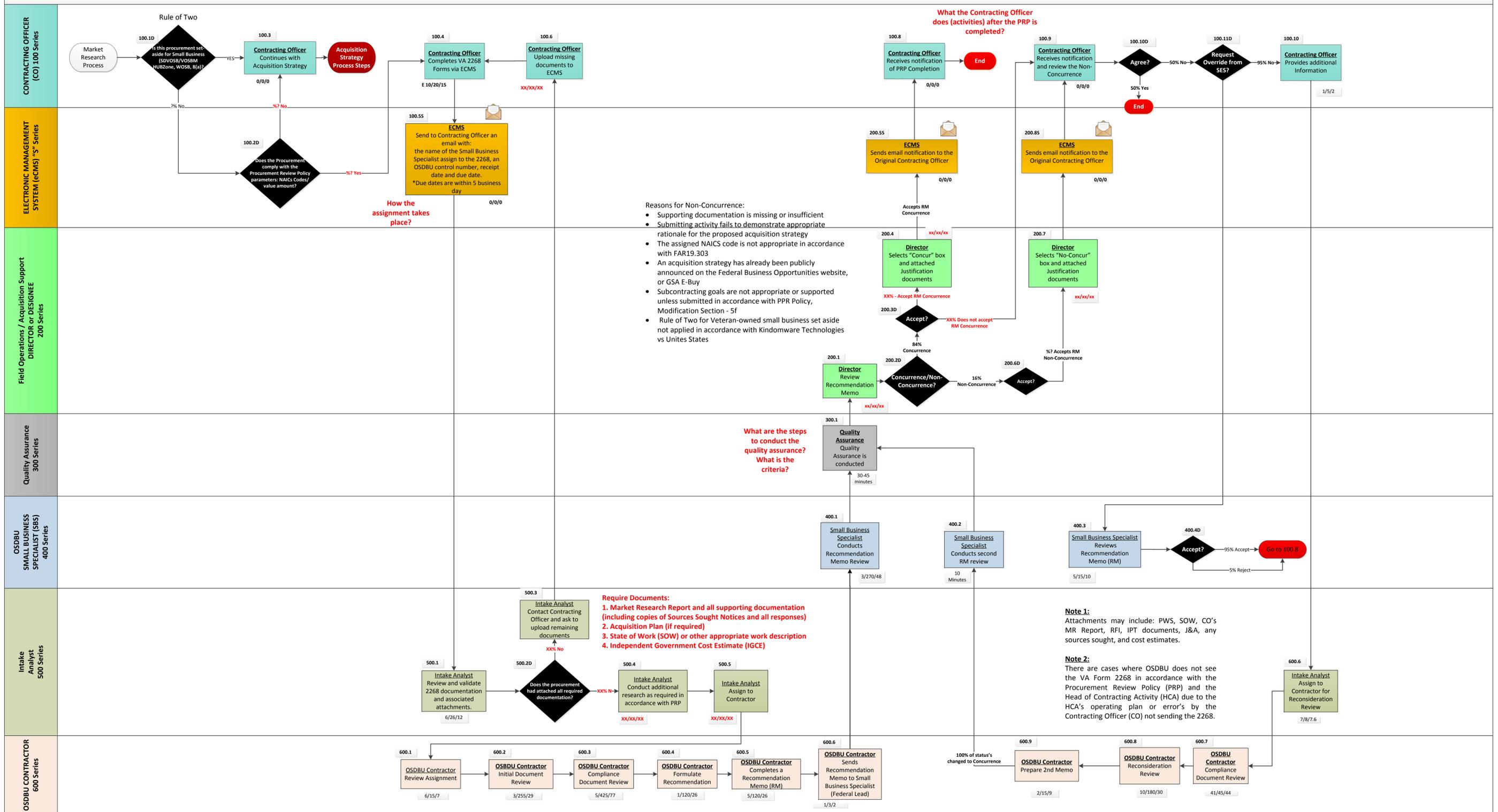

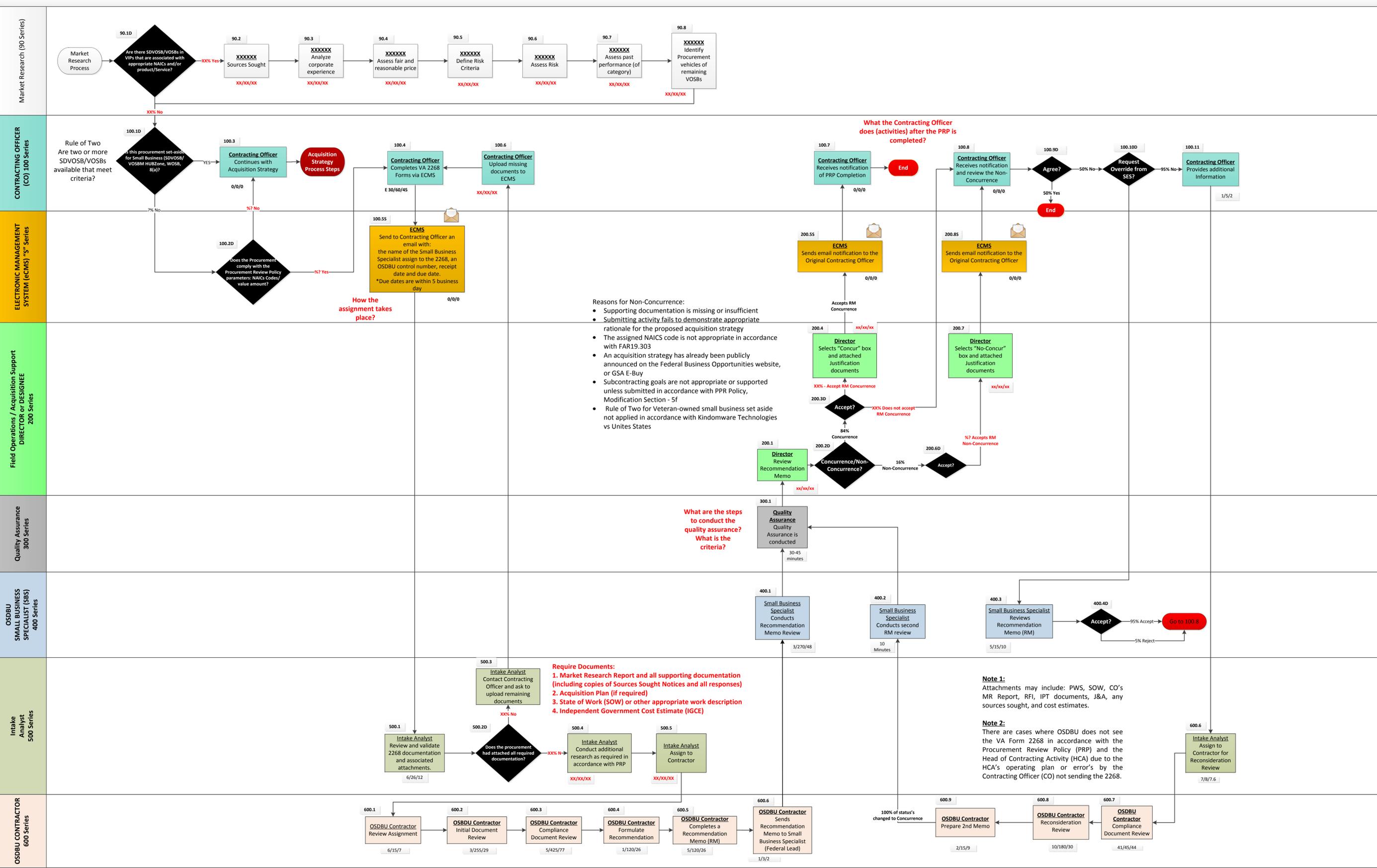
Under what conditions does a 2268 need to be escalated to a SBS for processing?

- Incomplete package (incomplete market research template for Rule of Two inquiry)
- Inadequate market research (what is needed besides the appropriate market research template and the acquisition plan?)
- Failure to follow defined process (if the process is electronically streamlined, this should be a rare event)

2268 Portfolio Manager roles/duties/considerations:

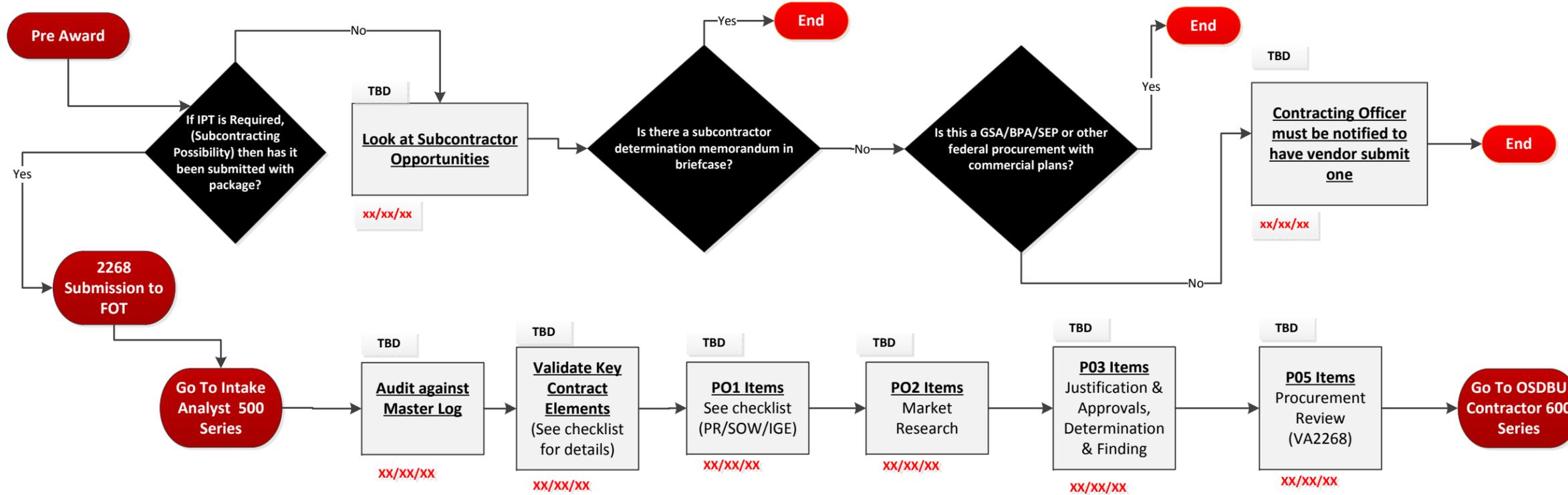
- By what system would the Portfolio Manager know that a 2268 was ready for processing/distribution? Email/VIP/eCMS?
- Receive 2268 form (market research) and acquisition plan as a 'package' - create a unique control number
- Could the Portfolio Manager do an initial vetting to make sure that the package is complete prior to disseminating for processing?
- Timings?

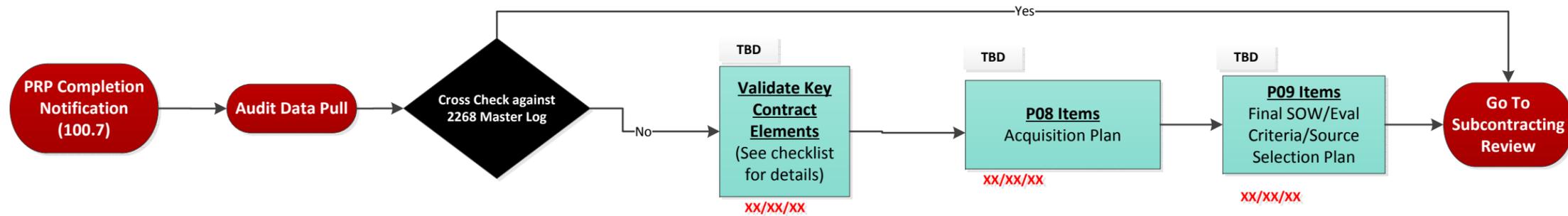


OSDBU AST/FOT – 2268 Pre/Post Review Steps
