Confederate Mound is a 1.6-acre Confederate Burial Plot located within Oak Wood Cemetery established in 1866. The 1.6-acre plot contains 6,229 remains of confederates who died in Camp Douglas Prison. Also buried at the mound are twelve

union soldiers who served as guards at Camp Douglas. The contractor is to plan, coordinate, organize, manage, and perform the specified work to achieve and maintain grounds at the quality required for a national shrine. The contractor shall furnish all labor, supervision, professional expertise, equipment and supplies for:

- A- Mowing**
- B- Headstone and Monument Trimming**
- C- Monument Sidewalk Edging**
- D- Leaf and Debris Removal**
- E- Headstone/Monument Cleaning**
- F- Flagpole and Monument Maintenance**
- G- Pre-Emergent Crabgrass Control**
- H- Fertilizer and Broadleaf Herbicide Applications**
- I- Over-Seeding**

All equipment, supplies and activities shall be maintained, operated and performed in accordance with all applicable Federal, State, County, Village, and Township laws, ordinances and regulations including, but not limited to OSHA standards. The contractor will demonstrate the utmost care preventing any damage to turf, landscaping, monuments, infrastructure, headstones, etc., by the Contractor shall be repaired or replaced at Contractor's expense, as directed by the COR.

(a) This service contract at Confederate Mound at Oak Wood Cemetery, hereafter referred to as "Historical Burial Plot" requires a contractor with past professional experience in grounds and conservators monument maintenance.

A. Mowing: April – October (CLIN 0001)

The contractor shall mow the entire 1.6 acres of Confederate Mound Burial Plot at Oak Wood Cemetery.

The contractor shall begin mowing and trimming turf in the spring (April) as conditions allow and continue through the entire growing season, with the final mowing to occur as seasonal grass-growth stops in the fall in October (as directed by the COR). The first seasonal mowing should occur as early spring green up is apparent and will essentially remove the brown leaf tissue remnants from winter dormancy and prepare the turf grass for the resumption of active spring growth.

Contractor shall clean all mowing and trimming equipment before unloading at the cemetery. This will minimize the possibilities of weed contaminates to cemetery turf from outside mowing areas.

Turf areas consist of different blends and mixtures of fescues, Kentucky bluegrass, perennial ryegrass's. The contractor shall meet the proper maintenance requirements for these cool-season grasses. Subsequent mowing's of the turf grass areas will occur at a mowing height of 3 inches. At no time, will more than one and a half inches (1.5) of new growth be removed at any single mowing. All mower blades will be sharpened prior to operation and all mowers shall be kept in top maintenance condition. If any mowing event results in clumps of grass clippings lying on the turf grass or clipping stuck to the marker/headstone, the Contractor will immediately remove or disperse those clippings

so that the clumps are no longer visible. Any clipping deposited on sidewalks, roadways, headstones or markers, or other non-turf grass areas will be removed the same day as the mowing event that produced them. The required operation frequency will be determined by the COR and the Contractor will be compensated on a (per) completed operation cost basis.

Contractor shall demonstrate competency of identifying existing and predictable hazards in the surrounding areas and take prompt corrective measures to eliminate them. The Contractor will remove and replace all floral or commemorative items, etc. to their proper place while performing mowing services.

Contractor shall be familiar with different mowing patterns, mowing speeds, sharpness of mower blades, mowers maintenance conditions, map reading, familiarity of irrigation popup heads & watering conditions, change of turf conditions, and recognize newly placed sod. Changing direction and patterns reduces turf wear providing a cleaner cut and prevents grass clippings from being deposited on mulch beds, planters, tree rings, monuments, and sidewalks. All clippings resulting from the mowing operation will be kept on mowed turf grass areas only.

Do not mow new sod, new seed, and grass matted areas with riding mowers until they have become established turf as deemed by the COR. When grass in these areas gets tall enough to need mowing it shall be carefully mowed with a push mower at 3.0 inches until sod is established well enough to support riding mowers without damage to the grass or soil surface.

B. Headstone and Monument Trimming: April – October (CLIN 0002)

Trimming will be accomplished beginning in April to October with hand held devices using nylon string that will cut the grass at the same 3-inch height as the mowed areas. Trimming will be accomplished in the same frequency as the mowed areas demonstrating a disciplined evolution. Trimming will occur around all individual upright headstones, trees, bushes, signs, concrete pads as well as at all other locations of grass area edges that cannot be maintained at 3" height through use of mowing equipment.

The contractor will utilize stick trimmers to cleanly trim around 13 headstones, 4 ordinance rifles (cannons) & concrete pads, pyramid stack of cast-iron cannon balls and interpretive signs.

All clippings resulting from the trimming/stick edging operation will be kept on mowed turf grass areas only. Any clipping deposited on sidewalks, roadways, headstones, or other non-turf grass areas will be removed the same day as the trimming event that produced them. The required operation frequency will be determined by the COR and the Contractor will be compensated on a (per) completed operation cost basis.

C. Monument Sidewalk Edging (Nylon String): April – October (CLIN 0003)

Monument sidewalks shall be edged beginning in April to October and weeds eradicated from sidewalks as needed. The required operation frequency will be determined by the COR and the Contractor will be compensated on a (per) completed operation cost basis. The Contractor will maintain a vegetation free edge along all sidewalks throughout the cemetery. This operation should be conducted to maintain the manicured appearance desired.

D. Leaf and Debris Removal: April – October (CLIN 0004)

The Contractor shall provide a weekly leaf and debris removal services beginning in April to October. This service will consist of the removal of any/all twigs, large branches, trash, leaves, and excess grass throughout the entire 1.6-acre burial plot. Additional policing shall be performed after each storm; and all debris resulting from such storms shall be removed from the property. This service shall be ongoing during the weeks of the turf growing season and leaf falling season. A sweep of the entire cemetery must be completed to constitute a single (1) leaf and debris pick up. This will be performed by use of backpack blowers, leaf vacuum machines and hand raking until the season has past. Equipment and vehicles weighing over 5,000 lbs. will not be permitted on the turf unless approved by the COR. The Contractor shall obtain authorization from the COR prior to proceeding with this work. The required operation frequency will be determined by the COR and the Contractor will be compensated on a (per) completed operation cost basis.

E. Headstone/Monument Cleaning: April – October (CLIN 0005)

The Contractor shall clean the flagpole base and stand frame, 13 marble headstones, 4 ordinance rifles (cannons) & concrete pads, pyramid stack of cast-iron cannon balls, 4 cast-iron cannonballs (one at each corner of monument steps), edges only of 16 large bronze panels, mortar joints from monument base up to the pedestals 4 bronze relief panels, interpretive signs and concrete sidewalks of objectionable accumulations of bird droppings, mud, tire marks, insects, weeds, and grass stains monthly from April-October. Cleaning shall be performed by using clean water with an approved mild cleaning agent and a stiff bristle brush (wire brush is prohibited). The contractor will use all OSHA approved safety devices and abide by all safety protocols protecting government property when mounting and dismounting the monument for cleaning. The Contractor shall obtain authorization from the COR prior to proceeding with this work. The required operation frequency will be determined by the COR and the Contractor will be compensated on a (per) completed operation cost basis.

F. Flagpole and Monument Maintenance: May (CLIN 0006)

The Contractor shall keep the flagpole, ordinance rifles (cannons), pyramid stack of cast-iron cannon balls and 4 cast-iron cannonballs (one at each corner of monument steps), interpretive signs in a presentable condition by touch-up painting once a year in the month of May prior to Memorial Day. *Treatments shall meet guidelines for the Treatment of Historic Properties.*

The Contractor shall obtain authorization from the COR prior to proceeding with this work. The contractor shall produce inspection and illustrated reports containing before and after condition illustrations, documentation of all treatments, produce a maintenance plan for caring for the historic structures. Contractor shall **not** perform any major repairs to government property without written consent.

On Memorial Day (Last Monday in May) the American Flag of the United States shall be lowered at half-staff from 8:00am until noon, then raised to full staff until closing of the cemetery by the contractor. Abraham Lincoln National Cemetery will provide and replace all halyards for the flagpole and all American Flags as they become weathered, torn or faded.

G. Pre-Emergent Crabgrass Control: (CLIN 0007)

Pre-Emergent Herbicide (April or May)

The entire turf area (approximately 1.6 Acres) of the Burial Plot shall be uniformly treated with pre-emergence herbicide once a year. One application shall be in April/ May prior to crabgrass germination and when soil temperature reaches 55 degrees Fahrenheit (13 degrees Celsius), or as directed by the COR. Work shall be coordinated and scheduled with COR and will be determined at the COR's discretion.

The active ingredient and rate of the herbicide at each application shall be either: dithiopyr at 0.25-pound active ingredient per acre (e.g., "Dimension"), or prodiamine at 0.5 lab active ingredient per acre (e.g., "Barricade"). If prodiamine is used, only a granular formulation may be applied to prevent headstone staining.

If fertilizer is used as a carrier for the herbicide for the early application, it shall contain no iron and the nitrogen rate should not be above 0.5 pounds per 1,000 square feet.

If a granular product is used, any deposited on impervious surfaces (walks/pavement) shall be removed or blown onto the turf immediately following application.

H. Fertilizer and Broadleaf Herbicide Application: (CLIN 0008)

Fertilizations (May and October)

Fertilizer shall be uniformly applied to all turf areas (approximately 1.6 acres). Fertilizer Application shall be done twice per year and coincide with the Broad Leaf Herbicide Application.

- May
- October

Rate shall be 1.0 pound of nitrogen per 1,000 square feet at each application. Fertilizer shall be applied with a properly adjusted and calibrated spreader. Overlap of spread pattern from adjacent passes shall be adequate to ensure uniform application. Streaks appearing in turf any time during the year as a result of non-uniform application are not acceptable. Fertilizer deposited impervious surfaces (walks/pavement) shall be removed or blown onto the turf immediately following application.

If weather conditions warrant, such as severe drought or extended wet conditions, applications can be delayed until conditions are suitable, with concurrence of the COR, but may not be made to frozen soil.

The fertilizer shall have the following properties:

- The nitrogen (N) content shall be 15% or more.
- 50% or more of the nitrogen in the fertilizer shall be in a slow or controlled-release form (e.g., sulfur coated, polymer coated, urea-form, isobutylidene diurea, etc.).
- It shall contain no phosphorous (P)
- It shall contain no iron (to prevent headstone staining).

Post-Emergence Broadleaf Weed Control (May & October) (CLIN 0008)

Post-Emergence Broadleaf Weed Control shall be uniformly applied to all turf areas (approximately 1.6 acres). Broad Leaf Herbicide Application shall be done twice per year and coincide with the fertilization application.

- May
- October

Herbicides for broadleaf weed control shall be sprayed by a licensed commercial applicator when weeds are actively growing and weather is conducive to effective weed control. Product label directions are the law and must be followed. Rate of each product shall be that recommended on the product label to control broadleaf weeds present in the cemetery, including common turf weeds such as dandelion, white cover, plantains, knotweeds, and black medic. The COR may require evidence at the time of application that an adequate rate is being mixed/applied, such as seeing the amount of

product (emptied containers) used for treatment. Contractor shall post signs at each section indicating a spray operation is ongoing or recently completed, and any restrictions as indicated by the herbicide label.

Broad Leaf Herbicide Application shall be done twice per year and coincide with the fertilization application.

Weather and field conditions must be favorable for herbicide efficacy, as well as for minimal risk of damage such as herbicide injury to off-target plants, or of equipment making ruts. Work to be performed during the hours of 8:00 a.m. and 4:00 p.m., Monday through Friday, unless arranged otherwise with the COR. No work will be performed on Federal Government Holidays. Work dates and locations are to be coordinated with the COR in advance of work being performed to accommodate burials or other activities. To schedule an application the contractor must coordinate the date and time with the COR. The government reserves the right to reschedule an application at no additional cost if 24 or more hours' prior notice is given.

The herbicide product(s) shall be effective at controlling broadleaf weeds, and shall result in a spray mixture containing three or more active ingredients.

The herbicide product(s) applied shall be in a spray mixture of three or more active ingredients from the following list:

2, 4-D
Carfentrazone
Clopyralid
Dicamba
Diclorprop
Fluroxypyr
MCPA
Mecoprop (MCPP)
Pyraflufen
Quinclorac
Sulfentrazone
Triclopyr

(Some examples of individual products meeting these criteria include "Battleship III," "Cool Power," "Millennium Ultra," "Momentum FX2," "Onetime," "PowerZone," "Speed Zone," "Trimec," "Triamine II," "Tri-Power," "Triplet.")

Contractor shall provide SDS documents prior to or at time of application. Equipment, herbicides, or other supplies shall not be stored on site. Any re-treatment needed as a result of the Contractor's failure to follow manufacturer's instructions shall be done at the Contractor's expense.

I. Over-Seeding: September (CLIN 0009)

Work consists of seeding areas of the Burial Plot where turf has been disturbed or has died. The entire turf area of the Burial Plot will be assessed before determining the number of square feet required to over-seed annually. Over seeding shall be determined in number of square feet (0-70,000 square feet)

MATERIALS:

1. All materials shall conform to those specified below, unless otherwise approved in writing by the Contracting Officer.
2. Specified materials shall be applied in amounts and methods stipulated herein.
3. Delivery tickets, indicating date, weight, analysis, and vendor's name, etc., shall be submitted to the Cemetery Director or COR.
4. Grass seed shall be a mixture of Kentucky bluegrass (60 %) and Perennial Ryegrass (40%). Kentucky bluegrass and Perennial Ryegrass will each be a blend of 2 or more cultivars.
5. Only top quality, turf-type cultivars of grass seed that are adapted in IL and surrounding areas and as certified by the State Agronomy Testing Laboratory will be accepted. Any substitution of seed type, weight or application must be specifically approved, in writing, by the contracting officer. Weed seeds and inert matter not to exceed 0.25% of total (all percentages by weight). Seed shall be free of any noxious weeds. The Contractor shall be responsible for obtaining the required seed in sufficient time for application. The specified seed may require special ordering.

PROCEDURES FOR OVER-SEEDING TURF:

1. Over-seeding of established turf shall occur in early September or as directed by the COR.
2. Seed shall be spread at the rate of 6 lbs. per 1,000 square feet (225 lbs. per acre. Seed shall be uniformly distributed by a hand broadcast spreader or other approved method by the COR.
3. Work shall be coordinated and scheduled with COR and shall be determined at the COR's discretion

2. GENERAL INFO:

a. Job Foreman: A job foreman shall be provided whenever work is being performed to ensure employees are adequately supervised and proper conduct is maintained.

Period of Performance: The period of performance of the base contract is from October 1, 2017 through the date of award through September 30, 2018 plus (4), one-year options, if exercised.

Work Hours: All work shall be performed between the normal business hours (8:00 a.m. to 4:30 p.m.), Monday through Friday.

Pre-bid Site Visit: Bidders are highly encouraged to make a pre-bid site visit. Such visits must be pre-scheduled and arranged by contacting the Abraham Lincoln National Cemetery office.

b. The National Cemetery Administration honors veterans with a final resting place and lasting memorials that commemorate their service to our Nation. National Cemeteries are national shrines. The standards of work, appearance, and procedures performed by the contractor at this cemetery shall reflect this nation's concern for those interred there. Due to the sensitive mission of the cemetery, contractor personnel must exercise and exhibit absolute decorum, composure, and stability at all times.

c. The Contractor is responsible to ensure that all work shall be done in a manner that safeguards all NCA visitors, employees, and public. The Contractor shall provide an English-speaking crew leader ensuring clear communication between the cemetery COR and contractors leadership, ensuring contractors employees are adequately supervised and proper conduct is maintained.

- d. Be required to be fully clothed at all times, to include upper garment with company name and logo to cover body from the waist to the neck and long pants or slacks.
- e. The Contractor/personnel shall not engage in loud or boisterous behavior, angry outbursts or use profane or abusive language at any time on Government property.

3. CONSEQUENCES OF CONTRACTOR'S FAILURE TO PERFORM REQUIRED SERVICES:

- a. In the case of unperformed work, the Government:
 - i. May, at its option, afford the contractor an opportunity to perform the unperformed work, at no additional cost to the Government. This performance must take place within a reasonable period subject to the discretion of the COR, but in no event longer than the next workday.
 - ii. May, at its option, perform the services by Government personnel or other means.
- b. In the case of unsatisfactory work that was not resolved, the Government:
 - i. Will deduct from the contractor's invoice all amounts associated with such unsatisfactory work at the prices contained in the Schedule or provided by other provisions of the contract; unless the contractor is afforded an opportunity to re-perform the work as outlined in the next paragraph, and satisfactorily completes the work;
 - ii. May, at its option, afford the contractor the opportunity to re-perform the unsatisfactory work, at no additional cost to the Government, within a reasonable period, subject to the discretion of the COR, but in no event longer than the next workday;
 - iii. May, at its option, perform the services by Government personnel or other means.

4. Contract Discrepancy Report (CDR)

- a. For serious contract performance deficiencies, or when less formal communications fail to resolve minor performance deficiencies, the COR will issue a Contract Discrepancy Report (CDR) to the Contractor. The criticality of the offense(s) will govern whether to issue the CDR immediately or at the end of the monthly invoicing period.
 - i. The CDR will require the Contractor to respond in writing why the performance was unacceptable, what corrective actions have been/will be taken to fix the discrepancy, and how avoidance of a recurring problem will be prevented in the future.
 - ii. If the Contractor does not achieve satisfactory performance by correcting the discrepancy identified in the CDR by the end of the next period or agreed suspense date, the Contracting Officer may consider further actions, to include a determination on whether continued performance by the contractor is feasible.
 - iii. The contractor shall be held to the full performance of the contract. The COR will not approve the payment of invoices for items which were not completed in compliance with the specifications outlined in this Statement of Work.

- iv. When a CDR is issued for a service, the Contracting Officer and/or the COR may exercise any contractual remedy available for non-performance, in accordance with FAR 52.212-4, "Inspection and Acceptance".
- v. The COR will consult the Contracting Officer prior to submission of CDRs and include the Contracting Officer on all correspondence pertaining to the CDR until the discrepancy is resolved
- vi. If the Government created any of the discrepancies, these will not be counted against the Contractor's performance. When the Government has caused the Contractor to perform in an unsatisfactory manner, the COR will forward a written notice to the responsible organizational element requesting corrective action be taken.
- vii. The CO will be the final arbitrator on all contract issues. Any disputes involving payment must be resolved by the CO.

5. STANDARDS OF EMPLOYEE CONDUCT

- a. Contractor personnel shall be required to adhere to the following standards of dress and conduct, as briefly mentioned here, while performing work in the National Cemetery. These standards and regulations are enforceable under Title 38, U.S.C., Part I, Chapter 9, Section 5901.
- b. Clothing shall be presentable and suitable to the work while maintaining proper appearance and decorum indicative for a National Shrine. Uniform shirts and hats are preferred. Clothing shall be clean and cleanliness and personal hygiene are imperative. T-shirts and/or tank tops as outer garments are prohibited. Protective/safety clothing and shoes shall meet or exceed OSHA and state requirements.
- c. Behavior and language must be appropriate, reverent, and respectful at all times.
- d. Eating and drinking (except water) is prohibited in the work areas and within sight of a committal shelter during a service.
- e. Use of intoxicating beverages, any tobacco products, and illegal drugs on the Cemetery premises is strictly prohibited.
- f. Contractor personnel shall not lean, sit, or stand on or against headstones or monuments. No tools, equipment or other items shall be placed or leaned on headstones or monuments.

6. OPERATIONS DURING CEMETERY FUNCTIONS

Contractor personnel shall not operate motorized equipment or conduct other commercial activities within a designated area during interment services. The COR will identify the designated area. The COR or his/her representative will furnish the Contractor with a schedule of all interments and/or ceremonies no later than the close of business of the day prior to the scheduled interment, and a minimum of three (3) days before any ceremonial events.

7. CONTRACTOR'S RESPONSIBILITIES AND INSURANCE REQUIREMENTS

The Contractor shall obtain all necessary licenses and/or permits required to perform this work. The Contractor shall take all precautions necessary to protect persons and property from injury or damage during the performance of this contract. The Contractor shall be responsible for any injury to himself, his employees, or others, as well as for any damage to personal or public property that occurs during the performance of this contract that is caused by his or her employees' fault or negligence. Further, it is agreed that any negligence of the Government, its officers, agents, servants, and employees, will not be the responsibility of the Contractor hereunder with the regard to any claims, loss, damage, injury, and liability resulting there-from. The Contractor shall maintain workmen's compensation, personal liability, automobile liability, and property damage insurance, as prescribed by the laws of the state of Kentucky, and in accordance with FAR 5.2282-5(c). Evidence of coverage is required before commencing work under this contract (copy of Certificate of Insurance), and it may not be changed or cancelled without thirty calendar days' prior written notice to the Contracting Officer.

8. Damage to Government Property

The Contractor shall be responsible for repair or replacement of any contractor damaged cemetery structure, to include: turf, curb, road pavement, headstones or markers, valve boxes, grid monument control markers, trees, plant beds, etc., which are chipped, marred, damaged and/or ruined at the fault of the Contractor and shall bear all costs associated with replacement and reinstallation. Any such damage shall be brought to the immediate attention of the appointed Contracting Officer's Representative (COR) prior to repair/replacement/installation.

a. The Contractor shall be responsible for cleaning cemetery structures, headstones, monuments, and roadways that are soiled or stained as a result of Contractor's performance. The Contractor shall wash-down with water all soiled or stained structures, headstones, and monuments at the end of each workday. Roadways shall be cleaned with a street sweeper each day, as needed, to keep the existing roads free from dirt and mud resulting from Contractor operations. No hazardous chemicals shall be used at any time on Government property. The Contractor shall bear all costs associated with washing and cleaning. Any such washing/cleaning shall be brought to the immediate attention of the COR prior to washing/cleaning.

b. At the end of each day the Contractor shall remove all debris from the burial plot site resulting from the work. The Contractor shall ensure at all times that rubbish and trash generated by the Contractor is kept clear of vehicular and pedestrian traffic throughout the site. The Government will not provide receptacle(s) for disposal of debris related to this contract. The Contractor will be permitted to place his trash receptacle dumpsters in the COR approved "Contractor Staging Area".

c. Adequate warning devices, barricades, guards, flagmen or other necessary precautions shall be provided by the Contractor at work site to eliminate hazards and for the protection, safety, and warning of all public visitors, pedestrians, cemetery employees, and vehicular traffic within the area.

d. The Government may undertake or award other contracts for additional work at or near the site of work for this contract. The Contractor shall fully cooperate with any other contractors and with Government employees and shall carefully adapt scheduling and performance of work, and needing any direction, it will be provided by the COR(s). The

Contractor shall be responsible for reporting to the COR(s) any problems or questions that may arise with any other personnel on site during the period of performance of this contract. The Contractor shall not take it upon him or herself to resolve any problems or issues with other on-site contractors or employees, but rather shall leave it to the COR(s) to resolve the issue.

e. The Contractor (including his or her employees, subcontractors, consultants or the like) shall not operate trucks, tractors, and other heavy equipment on any turf area except as provided in this contract to perform work or as authorized by the COR. The Contractor shall be responsible for repairing turf damage caused by the Contractor 's equipment and staff at no additional cost to the Government.

9. SAFETY

Matters related to safety, and any actions of the Contractor, shall meet all safety requirements of the COR, Safety Officer, Department of Veterans Affairs, OSHA, and the State. It is incumbent upon the Contractor to be familiar with these requirements. "Safety" shall also include the Contractor having a safety representative who maintains regular and routine contact with the Safety Officer at Camp Nelson National Cemetery.

10. PROTECTION OF EXISTING VEGETATION, STRUCTURES, EQUIPMENT, UTILITIES, AND IMPROVEMENTS

a. The Contractor shall preserve and protect all structures, equipment, and vegetation (such as trees, shrubs, and grass) on or adjacent to the work site. If any limbs or branches of trees are broken during contract performance, or by the careless operation of equipment, or by workmen, the Contractor shall trim those limbs or branches with a clean cut and remove and properly dispose of from the site as defined herein.

b. The Contractor shall protect from damage all existing improvements and utilities at or near the work site and on adjacent property of a third party, the locations of which are made known to or should be known by the Contractor. The Contractor shall immediately notify the COR of any such occurrence and repair any damage to those facilities, including those that are the property of a third party, resulting from failure to comply with the requirements of this contract or failure to exercise reasonable care in performing the work. If the Contractor fails or refuses to repair the damage promptly, the Contracting Officer may have the necessary work performed and charge the cost to the Contractor.

11. RESTORATION

a. Upon completion of contract, deliver work complete and undamaged. Existing cemetery features (lawns, paving, roads, walks, etc.) disturbed or removed as a result of performing required new work, will be patched, repaired, reinstalled, or replaced with new work, and refinished and left in as good condition as existed before commencing work. All restoration work shall be accomplished without undue delay.

b. The Contractor shall be responsible for restoration and the Contractor shall bear all costs associated with restoration. Any such restoration to service and repair as a result of damage caused by Contractor's workmen/subcontractors to existing cemetery infrastructure shall be brought to the immediate attention of the appointed Contracting Officer's Representative (COR) prior to restoration.

12. DISPOSAL OF WASTE

The Contractor shall not dispose of any waste materials at any location on the cemetery premises. All waste materials shall be removed from cemetery property and disposed of in full accordance with local and state requirements.

END OF STATEMENT OF WORK

SECTION C - CONTRACT CLAUSES

C.1 Dignity Clause

Every action by contractor personnel at a National Cemetery must be performed with the special care, reverence, dignity, and respect that acknowledge the cemetery as the final resting place that commemorates the service and sacrifice those service members, Veterans, and their families made for our Nation. Critically important is the awareness, required of the contractor employees, of the remains buried in the grounds where the work is performed. The utmost care must be given to these remains and the headstones and flat grave markers that mark those gravesites and memorialize the service of individuals.

C.2 52.212-4 CONTRACT TERMS AND CONDITIONS—COMMERCIAL ITEMS (JAN 2017)

(a) *Inspection/Acceptance.* The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

- (1) Within a reasonable time after the defect was discovered or should have been discovered; and
- (2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) *Assignment.* The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) *Changes.* Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) *Disputes.* This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) *Definitions.* The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) Invoice.

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—

- (i) Name and address of the Contractor;
- (ii) Invoice date and number;
- (iii) Contract number, line item number and, if applicable, the order number;
- (iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;
- (v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;
- (vi) Terms of any discount for prompt payment offered;
- (vii) Name and address of official to whom payment is to be sent;
- (viii) Name, title, and phone number of person to notify in event of defective invoice; and
- (ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.
- (x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer—Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) *Patent indemnity.* The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.—

(1) *Items accepted.* Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) *Prompt payment.* The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) *Electronic Funds Transfer (EFT).* If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) *Discount.* In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) *Overpayments.* If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) *Interest.*

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) *Final decisions.* The Contracting Officer will issue a final decision as required by 33.211 if—

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) *Risk of loss.* Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) *Taxes.* The contract price includes all applicable Federal, State, and local taxes and duties.

(l) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of

termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) *Title.* Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) *Limitation of liability.* Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) *Other compliances.* The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) *Compliance with laws unique to Government contracts.* The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) *Order of precedence.* Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

- (1) The schedule of supplies/services.
- (2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause;
- (3) The clause at 52.212-5.
- (4) Addenda to this solicitation or contract, including any license agreements for computer software.
- (5) Solicitation provisions if this is a solicitation.
- (6) Other paragraphs of this clause.

(7) The Standard Form 1449.

(8) Other documents, exhibits, and attachments

(9) The specification.

(t) *System for Award Management (SAM)*.

(1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the SAM database; (B) comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

(3) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the SAM record to reflect an assignee for the purpose of assignment of claims (see Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(4) Offerors and Contractors may obtain information on registration and annual confirmation requirements via SAM accessed through <https://www.acquisition.gov>.

(u) *Unauthorized Obligations*.

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an “I agree” click box or other comparable mechanism (e.g., “click-wrap” or “browse-wrap” agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

(v) *Incorporation by reference.* The Contractor’s representations and certifications, including those completed electronically via the System for Award Management (SAM), are incorporated by reference into the contract.

(2) “Service-disabled veteran” means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

(b) *General.*

(1) Offers are solicited only from verified service-disabled veteran-owned small business concerns. Offers received from concerns that are not verified service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified service-disabled veteran-owned small business concern.

SECTION E - SOLICITATION PROVISIONS

E.1 52.212-1 INSTRUCTIONS TO OFFERORS—COMMERCIAL ITEMS (JAN 2017)

(a) *North American Industry Classification System (NAICS) code and small business size standard.* The NAICS code and small business size standard for this acquisition appear in Block 10 of the solicitation cover sheet (SF 1449). However, the small business size standard for a concern which submits an offer in its own name, but which proposes to furnish an item which it did not itself manufacture, is 500 employees.

(b) *Submission of offers.* Submit signed and dated offers to the office specified in this solicitation at or before the exact time specified in this solicitation. Offers may be submitted on the SF 1449, letterhead stationery, or as otherwise specified in the solicitation. As a minimum, offers must show—

- (1) The solicitation number;
- (2) The time specified in the solicitation for receipt of offers;
- (3) The name, address, and telephone number of the offeror;
- (4) A technical description of the items being offered in sufficient detail to evaluate compliance with the requirements in the solicitation. This may include product literature, or other documents, if necessary;
- (5) Terms of any express warranty;
- (6) Price and any discount terms;
- (7) "Remit to" address, if different than mailing address;
- (8) A completed copy of the representations and certifications at FAR 52.212-3 (see FAR 52.212-3(b) for those representations and certifications that the offeror shall complete electronically);
- (9) Acknowledgment of Solicitation Amendments;
- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
- (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) *Period for acceptance of offers.* The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

(d) *Product samples.* When required by the solicitation, product samples shall be submitted at or prior to the time specified for receipt of offers. Unless otherwise specified in this solicitation, these samples shall be submitted at no expense to the Government, and returned at the sender's request and expense, unless they are destroyed during preaward testing.

(e) *Multiple offers.* Offerors are encouraged to submit multiple offers presenting alternative terms and conditions, including alternative line items (provided that the alternative line items are consistent with subpart 4.10 of the Federal Acquisition Regulation), or alternative commercial items for satisfying the requirements of this solicitation. Each offer submitted will be evaluated separately.

(f) Late submissions, modifications, revisions, and withdrawals of offers.

(1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and—

(A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or

(A) The following information for each disclosed labor law decision in the System for Award Management (SAM) at www.sam.gov, unless the information is already current, accurate, and complete

in SAM. This information will be publicly available in the Federal Awardee Performance and Integrity Information System (FAPIS):

(1) The labor law violated.

(2) The case number, inspection number, charge number, docket number, or other unique identification number.

(3) The date rendered.

(4) The name of the court, arbitrator(s), agency, board, or commission that rendered the determination or decision;

(B) The administrative merits determination, arbitral award or decision, or civil judgment document, to the Contracting Officer, if the Contracting Officer requires it;

(C) In SAM, such additional information as the Offeror deems necessary to demonstrate its responsibility, including mitigating factors and remedial measures such as offeror actions taken to address the violations, labor compliance agreements, and other steps taken to achieve compliance with labor laws. Offerors may provide explanatory text and upload documents. This information will not be made public unless the contractor determines that it wants the information to be made public; and

(D) The information in paragraphs (s)(3)(i)(A) and (s)(3)(i)(C) of this provision to the Contracting Officer, if the Offeror meets an exception to SAM registration (see FAR 4.1102(a)).

(ii)(A) The Contracting Officer will consider all information provided under (s)(3)(i) of this provision as part of making a responsibility determination.

(B) A representation that any labor law decision(s) were rendered against the Offeror will not necessarily result in withholding of an award under this solicitation. Failure of the Offeror to furnish a representation or provide such additional information as requested by the Contracting Officer may render the Offeror nonresponsible.

(C) The representation in paragraph (s)(2) of this provision is a material representation of fact upon which reliance was placed when making award. If it is later determined that the Offeror knowingly rendered an erroneous representation, in addition to other remedies available to the Government, the Contracting Officer may terminate the contract resulting from this solicitation in accordance with the procedures set forth in FAR 12.403.

(4) The Offeror shall provide immediate written notice to the Contracting Officer if at any time prior to contract award the Offeror learns that its representation at paragraph (s)(2) of this provision is no longer accurate.

(5) The representation in paragraph (s)(2) of this provision will be public information in the Federal Awardee Performance and Integrity Information System (FAPIS).

Note to paragraph (s): By a court order issued on October 24, 2016, this paragraph (s) is enjoined indefinitely as of the date of the order. The enjoined paragraph will become effective immediately if the court terminates the injunction. At that time, DoD, GSA, and NASA will publish a document in the **Federal Register** advising the public of the termination of the injunction.

(t) *Public Disclosure of Greenhouse Gas Emissions and Reduction Goals.* Applies in all solicitations that require offerors to register in SAM (52.212-1(k)).

(1) This representation shall be completed if the Offeror received \$7.5 million or more in contract awards in the prior Federal fiscal year. The representation is optional if the Offeror received less than \$7.5 million in Federal contract awards in the prior Federal fiscal year.

(2) Representation. [Offeror to check applicable block(s) in paragraph (t)(2)(i) and (ii)]. (i) The Offeror (itself or through its immediate owner or highest-level owner) [] does, [] does not publicly disclose greenhouse gas emissions, i.e., makes available on a publicly accessible Web site the results of a greenhouse gas inventory, performed in accordance with an accounting standard with publicly available and consistently applied criteria, such as the Greenhouse Gas Protocol Corporate Standard.

(ii) The Offeror (itself or through its immediate owner or highest-level owner) [] does, [] does not publicly disclose a quantitative greenhouse gas emissions reduction goal, i.e., make available on a publicly accessible Web site a target to reduce absolute emissions or emissions intensity by a specific quantity or percentage.

(iii) A publicly accessible Web site includes the Offeror's own Web site or a recognized, third-party greenhouse gas emissions reporting program.

(3) If the Offeror checked "does" in paragraphs (t)(2)(i) or (t)(2)(ii) of this provision, respectively, the Offeror shall provide the publicly accessible Web site(s) where greenhouse gas emissions and/or reduction goals are reported:_____.

(u)(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235) and its successor provisions in subsequent appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(2) The prohibition in paragraph (u)(1) of this provision does not contravene requirements applicable to Standard Form 312 (Classified Information Nondisclosure Agreement), Form 4414 (Sensitive Compartmented Information Nondisclosure Agreement), or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(3) Representation. By submission of its offer, the Offeror represents that it will not require its employees or subcontractors to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting waste, fraud, or abuse related to the performance of a Government contract to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information (e.g., agency Office of the Inspector General).
