It is necessary for the OEM (Original equipment Manufacturer) to provide the defibrillators due to the fact that purchasing the defibrillator as a second party purchaser raises the price, making it unfair and unreasonable with other vendors. Purchasing other defibrillators would require re-training of the doctors, nurses and firemen along with put the patient at risk of not getting a fair chance at being brought back to life, should a life-threatening occurrence happen. These defibrillators have a higher voltage output than the average defibrillator and have a better success rate when comparing converting rates. The item is available thru an FSS contract from large business.

price reduction when the order exceeds the Simplified Acquisition Threshold (SAT). In this instance, the Contracting Officer requested a price reduction and it was 10%.

(6) ANY OTHER FACTS SUPPORTING THE JUSTIFICATION:

Although the Contracting Officer received confirmation from the Government Accounts Representative of Physio Controls that they are the manufacturer of the required item and have small business distributors, a sources sought notice was posted to FBO for Two-Weeks June 5, 2017-June 15, 2017, to verify that there were some. Calls were made to SBA small business dynamics & VIP (Veterans Information Pages) vendors. In fact, any small business distributors. The communication received was positive responses from 6 SDVOSB's & 1 NO BID response from 1 SDVOSB. An RFQ solicitation was placed in FBO on July 6, 2017-July 17, 2017 and resulted in 1 quote for an equal product and 6 quotes that were unfair and unreasonably high. Additionally, a budgetary quote was requested and provided by Physio Controls on 06/10/2017. The quote that was the lowest was a comparable product quote and end user stated that the product offered was not technically acceptable because of the wattage output. (End user remarks attached).






On July 20, 2017 a source sought was posted in GSA E-buy to seek available SDVOSB & VOSB vendors that could supply defibrillators. There was one response, so CO requested a quote from the vendor that resulted in the price being unfair and unreasonable.

It is imperative for the OEM Original equipment manufacturer) to provide the defibrillators as it is the best way to ensure a fair and reasonable price, not going to a second party entity. This would be advantageous to the Government.
