JUSTIFICATION FOR OTHER THAN FULL AND OPEN COMPETITION

- 1. Contracting Activity: Department of Veterans Affairs (VA)

- 2. <u>Description of Action</u>: The proposed action is for a firm-fixed-price contract with Horizon Communications to continue local exchange carrier (LEC) telecommunication voice and data services.
- 3. <u>Description of Supplies or Services</u>: The proposed action is for LEC telecommunications services at VA facilities located in Cillicotthe Ohio. These LEC services include telephones/business lines, primary rate interfaces, direct inward dialing and features such as caller identification, voicemail, call forwarding, hunting/rollover to include standard regulated tariff fees. The period of performance is a 12 month base period with four 12 month option periods. The total estimated value of this proposed acquisition, inclusive of all options is \$
- 4. <u>Statutory Authority</u>: The statutory authority permitting other than full and open competition is 41 U.S.C.3304(a)(1) as implemented by the Federal Acquisition Regulation (FAR) 6.302-1 entitled, "Only One Responsible Source and No Other Supplies or Services Will Satisfy Agency Requirements."
- 5. Rationale Supporting Use of Authority Cited Above: The proposed source for this action is Horizon Communications, 68 East Main Street, Ohio, 45601. Based on market research, as described in section 8 of this justification, it has been determined that only Horizon is capable of providing the aforementioned LEC telecommunication voice and data services until the vendors of recently awarded task orders/contracts are able to to install, test, and turn up new circuits for use by VA. Due to the type of services that are currently installed, no other vendor can install, test and turn up new services prior to October 1, 2017. Any other vendor would require approximately 60-90 days to provide the aforementioned LEC telecommunication and data services. Specifically any other source would have to conduct site visits at the required locations and conduct extensive reviews of the specific site to gain the knowledge required to begin the process of creating an environment that is needed to provide the aforementioned services to VA. In addition, a new vendor would have to conduct testing to ensure the service is fully compliant with VA's current environment before it can be implemented. Loss of existing services would result in disruptions of serice of communciations systems and medical systems, the inability to share resources within the Veterans Integrated Service Network, increased maintenance time, increased system blockages, and reduced computer access to patient record databases.

Due to the type of telecommunication voice and data services, to introduce another vendor to install, test and provide new services during the current transitions would

provide for an unacceptable high level of rish in regards to performance and schedule. Furthermore, interoperability of the systems, testing and release synchronization would be difficult to achieve and manage. VA local IT departments lack the personnel support to complete multiple transitions. Specifically, any other source would have to conduct site visits at the required locations and conduct extensive reviews of the specific site to gain the knowledge required to begin the process of creating an environment that is needed to provide the aforementioned services to VA. In addition, a new vendor would have to conduct testing to ensure the service is fully compliant with VA's current environment before it can be implemented. The current LEC telecommunication voice and data services with Horizon will have to be maintained until the current transitions are fully completed.

- 6. Efforts to Obtain Competition: Market research was conducted, details of which are in section 8 of this justification. This effort did not yield any other vendors that can provide the services that can meet the Government's requirements. In accordance with FAR 5.201, the proposed action will be synopsized on the Federal Business Opportunities (FBO) Page. Any proposals that are received shall be evaluated.
- 7. <u>Actions to Increase Competition</u>: VA will continue to conduct market research to determine if competition at this location is viable among other LEC services providers.
- 8. Market Research: Market Research was done in August 2017 by posting a presolicitation notice on FBO in order to obtain information. The Presolicitation Notice was posted on August 9, 2017 seeking sources that could provide coverage and services for the location listed in the Performance Work Statement (PWS) with no interruption to services. The Presolicitation Notice closed on August 18, 2017 with no responses received. Based on this market research it was determined that only Horizon has the ability to provide the aforementioned LEC telecommunication services.
- 9. Other Facts: None.

- 10. <u>Technical and Requirements Certification</u>: I certify that the supporting data under my cognizance, which are included in this justification, are accurate and complete to the best of my knowledge and belief.
- 11. <u>Fair and Reasonable Cost Determination</u>: I hereby determine that the anticipated price to the Government for this contract action will be fair and reasonable based on price analysis via a comparison of the proposal against the Independent Government Cost Estimate and past historical prices paid for the same and/or similar services.
