(2) NATURE AND/OR DESCRIPTION OF ACTION BEING APPROVED:

A Temporary Help Service Task Order to provide uninterrupted Pharmacist services from October 1, 2017 – March 31, 2018 to VA Puget Sound Health Care System (VAPSHCS), Seattle, WA and VAPSHCS American Lake Division, Lakewood, WA. The current GSA Task Order, V797P-733A VA260-12-F-0576, expires on September 30, 2017.

(3) (a) A DESCRIPTION OF THE SUPPLIES OR SERVICES REQUIRED TO MEET THE AGENCY'S NEED:

The VA has a need for a six (6) month follow on Task Order to Career Staff Unlimited, LLC to allow uninterrupted Pharmacist services from October 1, 2017 – March 31, 2018 for VAPSHCS Seattle, WA and VAPSHCS American Lake Division, Lakewood, WA. The requirement is for an estimated 5,400 hours.

(b) ESTIMATED DOLLAR VALUE: \$423,792.00

(c) PERIOD OF PERFORMANCE: October 1, 2017 – March 31, 2018

(4) IDENTIFICATION OF THE JUSTIFICATION RATIONALE (SEE FAR 8.405-6), AND IF APPLICABLE, A DEMONSTRATION OF THE PROPOSED CONTRACTOR'S UNIQUE QUALIFICATIONS TO PROVIDE THE REQUIRED SUPPLY OR SERVICE.

Career Staff Unlimited, LLC is the incumbent contractor under expiring Task Order V797P-7336A VA260-12-F-0576. Career Staff Unlimited's pharmacists already have VETPRO Credentialing and Privileging, Personal Identity Verification (PIV) Cards, and complete background investigations. Any other contractor's employees would also need to undergo all these inquiries, but there is not enough time between now and 10/1/2017 for a newly awarded contractor's employees to begin and complete this process. Only Career Staff Unlimited's current employees can furnish pharmacist services on 10/1/2017 because they are currently cleared to work at VAPSHCS Seattle and American Lake locations.

☒ The new work is a logical follow-on to an original Federal Supply Schedule order provided that the original order was placed in accordance with the applicable Federal Supply Schedule ordering procedures. The original order must not have been previously issued under sole source or limited source procedures.

The previous acquisition, VA260-12-Q-0329, was open to all vendors with Federal Supply Schedules (FSS) for Temporary Help Services providing Pharmacists. Eighteen companies responded. Career Staff Unlimited LLC was awarded a contract under Federal Supply Schedule (FSS) V797P-7336A. Task Order V797P-7336A VA260-12-F-0576 awarded on March 2, 2012 effective April 1, 2012 for a base year plus four (4) Option Years (April 1, 2012 – March 31, 2017). V797P-7336A VA260-12-F-0576 P00009, FAR 52.217-8, exercised a six (6) month extension awarded on March 8, 2017 period of performance April 1, 2017 – September 30, 2017. The original order was NOT issued under sole source or limited source procedures.

☒ An urgent and compelling need exists, and following the ordering procedures would result in unacceptable delays.

A new solicitation with a contract award starting on October 1, 2017 will not allow enough time to screen, select, and train new Pharmacists in VAPSHCS procedures, process new Personal Identity Verification (PIV) Cards, and complete background investigations. Selecting a new contractor company for services October 1, 2017 would result in the potential new Pharmacists not being able to access the VA Veterans Pharmacy records beginning on day 1 of new contract; therefore, prescriptions would need to be processed by commercial pharmacies at additional cost to the government and inconvenience and delays to the veteran. The VA would be paying for pharmacists that could not fulfil prescriptions.

(5) DESCRIBE WHY YOU BELIEVE THE ORDER REPRESENTS THE BEST VALUE CONSISTENT WITH FAR 8.4 TO AID THE CONTRACTING OFFICER IN MAKING THIS BEST VALUE DETERMINATION:

Market research reveals the anticipated cost for a Bridge Task Order with Career Staff Unlimited, LLC is fair and reasonable, and that market research provides the basis for this determination. The anticipated price for Career Staff Unlimited, LLC pharmacists is per hour. Market research utilizing eBay reveals Pharmacists cost a high of \$109.23 and a low of \$67.00 per hour. Career Staff Unlimited LLC is within the market price.

(7) ANY OTHER FACTS SUPPORTING THE JUSTIFICATION:

VAPSHCS Human Resources has had a difficult time recruiting and retaining Civil Service pharmacists.

Pharmacy clinical workload is increasing in both volume and complexity. Programs such as CHOICE, anticoagulation and other pharmacy specialty clinics, Hepatitis C patient monitoring and the increasing numbers of manufacturers' drug shortages and VA contract changes with the resulting drug conversions make it critical to maintain adequate pharmacy coverage.

(8) A STATEMENT OF THE ACTIONS, IF ANY, THE AGENCY MAY TAKE TO REMOVE OR OVERCOME ANY BARRIERS THAT LED TO THE RESTRICTED CONSIDERATION BEFORE ANY SUBSEQUENT ACQUISITION FOR THE SUPPLIES OR SERVICES IS MADE:

A Contract Specialist is processing the new follow-on long-term solicitation. Market Research already reveals that a single Task Order can be made to a Service Disabled Veteran Owned Small Business (SDVOSB)/Veteran Owned Small Business (VOSB). The intended contract period is a base year, plus four (4) one-year options (firm fixed price).

A six (6) month bridge Task Order with Career Staff Unlimited LLC will allow uninterrupted Pharmacist services from October 1, 2017 – March 31, 2018 for VA Puget Sound Health Care System (VAPSHCS) Seattle, WA and VA Puget Sound Health Care System (VAPSHCS) – American Lake Division, Lakewood, WA while the new acquisition continues through the solicitation process. The additional time will also result in the potential new contractor's pharmacists having time for completing VETPRO Credentialing and Privileging, Personal Identity Verification (PIV) Cards, and background investigations.
