GENERAL REQUIREMENTS:

The Department of Veterans Affairs (VA), Veterans Integrated Service Network (VISN) 23, has a requirement for leased multifunction devices. For the previous 10+ years VISN23 has been leasing multifunction devices (network print, network scan, copy, fax, etc) on a cost per print basis to satisfy its printing and device requirements. Overall, this requirement is for the leasing of approximately 715 devices across 8 medical centers and several outpatient clinics and miscellaneous VA offices (Vet Centers, etc).

The purpose of this synopsis is to gain knowledge of potential qualified sources and their size classification to satisfy the above-mentioned requirement.
