(2) NATURE AND/OR DESCRIPTION OF ACTION BEING APPROVED:

This is a limited source justification for the procurement of the Censis Technologies Electronic Instrument Tracking & Management renewal software license. This software provides hospitals visibility into equipment usage, location and where equipment is in the sterilization queue. This software renewal is an end-to-end Surgical Instrument Tracking System used in all of the hospitals within VISN 8 (Veterans Integrated Service Network).

(3) (a) A DESCRIPTION OF THE SUPPLIES OR SERVICES REQUIRED TO MEET THE AGENCY'S NEED:

The software is utilized throughout VISN 08 including Bay Pines VAHCS; Lee County Healthcare Center; Miami VAHCS; Orlando; Lake Baldwin, Orlando, Viera Medical Center. The renewal software license will be used for tracking medical instruments through the sterilization process. The process is to ensure that these instruments have been sterilized and are available for use during surgical procedures. Renewal software includes the following features:

- Schedule and Measure Instrument Level Maintenance
- Automated Count Sheets
- Electronic Sterilizer Interface
- Recall at Instrument Level
- Complete Suite of Reporting Tools
- Professional Implementation
- Track at the Instrument Level

(4) IDENTIFICATION OF THE JUSTIFICATION RATIONALE (SEE FAR 8.405-6), AND IF APPLICABLE, A DEMONSTRATION OF THE PROPOSED CONTRACTOR'S UNIQUE QUALIFICATIONS TO PROVIDE THE REQUIRED SUPPLY OR SERVICE.

Specific characteristics of the material or service that limit the availability to a sole source (unique features, function of the item, etc.). Describe in detail why only this suggested source can furnish the requirements to the exclusion of other sources.

This is a new procurement for Sterilization Processing Service (SPS) that already owns the equipment from Censitrac System. Replacing the software would cause a duplication of cost, basically to compete this requirement you would need to replace the equipment and the software. The equipment was purchased by the Technology Acquisition Center (TAC) in 2013 for \$1 million to replace this equipment the cost would be \$1.5 million to \$2 million for something similar plus the implementation and calibrating of a new system would be an additional \$500,000. This requirement is for renewal licenses, which combines labeling, scanning technology, and application software to create a tracking system for critical reusable medical equipment (RME). Censis Technologies Inc. is the only vendor that can perform upgrades and maintenance to the renewal licensed software. The Censis Technologies Inc. software and Censitrac System equipment has been used as a standard for all surgical instruments throughout SPS in VISN 08 since it was awarded by the TAC. This vendor is the only company that

possesses the qualified service engineers with the technical expertise for this specialized technical support and is the only vendor that has the production and distribution rights for the software and all upgrades. This is proprietary software. The manufacture does not have any authorized distributors per letter, dated February 13, 2017.

The current software was developed by Censis Technologies, Inc. and the request is for annual renewal software licenses. The software is proprietary to Censis Technologies, Inc., therefore, no other vendor can provide the software license keys needed for renewal of the subscription for this software. The Censis Technologies Inc. software can only be utilized on Censis Technologies equipment. No other software can be utilized with the system.

Far 8.404 (d) GSA has already determined the prices of supplies and fixed-price services, and rates for services offered at hourly rates, under schedule contracts to be fair and reasonable. Therefore, ordering activities are not required to make a separate determination of fair and

reasonable pricing, except for a price evaluation as required by 8.405-2. In addition to FAR 8.405-4, a price reduction will be requested.

(6) DESCRIBE THE MARKET RESEARCH CONDUCTED AMONG SCHEDULE HOLDERS AND THE RESULTS OR A STATEMENT OF THE REASON MARKET RESEARCH WAS NOT CONDUCTED:

Market research was conducted using eCMS, GSA Advantage, Internet, SEWP, NAC Tool and FPDS with the intention to find the source and the procurement method previously used. Several contracts were found within eCMS, VA248-16-F-0016, having a value of \$38,238.04, and VA248-13-F-3709 having a dollar value of \$31,738.04. The contracts that were searched were all awarded to Censis Technologies, Inc. who is the sole manufacture and distributor of the renewal software.

Barriers to competition will be overcome when the RTLS brand name software is no longer available from the manufacture or the government owned equipment. Censis, becomes obsolete. The VA could invest in its own open source software compatible with this equipment. This investment may not be effective since technology changes too rapidly,
