

JUSTIFICATION FOR OTHER THAN FULL AND OPEN COMPETITION FAR 6.303-2


1. Contracting Activity: Department of Veterans Affairs
Strategic Acquisition Center

2. Description of Action: The proposed firm-fixed priced ("FFP") sole source action will be a follow-on contract with an anticipated twelve (12) month base period for internet legal research data subscription services to the VA Office of General Counsel ("OGC") and a professional government contracts conference "Government Contracts Year-In-Review" to be held on February 2018. The incumbent is Thomson-Reuters d/b/a as Westlaw®, 1333 H Street NW, Washington, DC 20005.
3. Description of Supplies or Services: Renewal of OGC subscription services from Westlaw®, which is a collection of unique legal databases and database services required by the OGC and a uniquely sponsored government contracts conference likewise conducted by Westlaw® to be held in Washington, DC.
4. Statutory Authority: The statutory authority permitting other than full and open competition is 41 U.S.C.3304(a)(1), *et seq.* as amended, as implemented by the Federal Acquisition Regulation (FAR) Subpart 6.302-1 entitled, "Only One Responsible Source and No Other Supplies or Services Will Satisfy Agency Requirements."
5. Rationale Supporting Use of Authority Cited Above: Thomson-Reuters Westlaw® has no peer equivalent but does have one competitor for comparable yet also unique legal database services known as Lexis-Nexis®. However, Westlaw® is unique relative to its extensive database selections, search functions and presentation of legal image pages to include the Nash & Cibinic Report®, The Government Contractor®, and The Government Contractor Plus® which the OGC requires and no other source provides. Moreover, publications that are exclusive to Westlaw® include: West Am Jur 2nd, Corpus Juris Secundum, Sutherland Statutes and Statutory Construction, and McCarthy on Trademark all of which are proprietary.
6. Efforts to Obtain Competition: The publications are proprietary to Westlaw® and have no peer equivalents to the uniquely held content, retrieval and/or presentation features.
7. Actions to Increase Competition: The Government will continue to conduct market research to ascertain if there are changes in the market place that would enable future actions to be competed.
8. Market Research: Exhaustive research was conducted on FedBizOps ("FBO"), and other internet searches and it appears that the only competitor, Lexis-Nexis®, fails to offer the services and conferences required by the OGC. Moreover, all governmental purchases of WestLaw® are by sole source purchases because there is no peer equivalent or available services which meet the current VA need.
