

## DEPARTMENT OF VETERANS AFFAIRS

### Justification and Approval (J&A) For Other Than Full and Open Competition (>\$150K)

Acquisition Plan Action ID: VA259-18-AP-0418

1. **Contracting Activity:** Department of Veterans Affairs, Network Contracting Office 19 (NCO19) in support of the VA Eastern Colorado Healthcare Center.
2. **Nature and/or Description of the Action Being Processed:** This procurement is for an emergency sole source Community Nursing Home (CNH) in the city of Commerce City, Colorado. The current agreement ends on October 31, 2017 and there are currently 16 veterans in the nursing home. This is a short-term purchase order to allow time for the long-term Blanket Purchase Agreement to be awarded, this will be awarded as a Firm-fixed price Purchase Order.

**FAR13.5 Simplified Procedures for Certain Commercial Items:** This procurement is for a CNH in Commerce City, Colorado in accordance with FAR 13.5 Simplified Procedures for Certain Commercial Items and specifically FAR 13.501 Special Documentation Requirements, where acquisitions conducted under Simplified Acquisition Procedures are exempt from the requirements of FAR Part 6, but still require a justification using the format of FAR 6.303-2.

3. **Description of Supplies/Services Required to Meet the Agency's Needs:** A CNH in Commerce City, Colorado that provides the long-term care needs of veterans through a CNH Program that is certified as a Center for Medicare and Medicaid Services (CMS) and licensed by the state of Colorado. The care provided needs to meet the medical, nursing and psychosocial needs of the veterans to include provider visits at least once a month, acceptance of Veterans Affairs (VA) referrals in a timely fashion, laboratory and x-ray availability, and meals at no additional charge. The Woodridge Terrace Nursing & Rehabilitation is currently providing services for sixteen (16) veterans who live in Commerce City, CO. This requirement is estimated to start November 1, 2017 and will run for five (5) months. The estimated value of the five (5) months Purchase Order is \$492,048.00.

**FAR13.5 Simplified Procedures for Certain Commercial Items:** The authority for applying the Simplified Procedures for Commercial Items of FAR 13.5 is 41 U.S.C. 1901 and is implemented by restricting competition on this procurement via FAR 13.106-1(b)(2).

5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):** The Medicare website

(medicare.gov) was utilized to find all available, certified nursing homes in the Commerce City, Colorado area. Seventy-two (72) nursing homes were found with the mandatory certifications. A search of the SBA.gov dynamic search found that Woodridge Terrace Nursing and Rehabilitation is the only Small Business nursing home in Commerce City, CO.

- 6. Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** This is an emergency requirement and offers were not solicited. The Small Business Administration (SBA) website and the VA's Vendor Information Pages (VetBiz) were used to find further competition. VetBiz did not produce any results but the SBA website returned that Woodridge Terrace Nursing and Rehabilitation is the only small business in Commerce City, CO. A search of the Medicare Nursing Home Compare website found 72 care centers within 25 miles of Commerce City, CO. There are currently 16 patients residing at the Wood Ridge Terrace Nursing and Rehabilitation. The patients are unable to move the patients to a new facility by November 1, 2017. The Woodridge Terrace Nursing and Rehabilitation is the only firm capable of providing the services described in Section III above without the Veteran's Health Administration experiencing unacceptable delays in fulfilling its requirements. The current agreement is with Woodridge Terrace Nursing and Rehabilitation and expires on October 31, 2017.
- 7. Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:** Each nursing home is issued their own Medicaid rate by the State Government on the State's letterhead; this is called the base rate. Medicaid base rates may differ from State to State, because States have developed different regulatory frameworks for Medicaid. The VA Geriatrics and Extended Care Offices determine the maximum add-on percentages that can be negotiated for each Medicaid category and is issued annually. The Contracting Officer then negotiates the nursing home add on percentage rates for each contract utilizing the maximum rate. The sum of the Medicaid base rate and the add-on percentage is the Medicaid per diem rate. The discount/add-on percentage will remain the same for the life of the Agreement. The contractor proposed prices will also be compared to historical pricing from other nursing homes in the county and in the state of Colorado to determine fair and reasonableness. The pricing from previous contracts of a similar nature will also be utilized to determine price fair and reasonable by the Contracting Officer.
- 8. Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:** Limited Market Research was conducted in accordance with FAR Part 10 to ensure competition is sought to the maximum extent practicable. The Medicare website (medicare.gov) was utilized to find all available, certified nursing homes in the Commerce City, Colorado area. A search of the Small Business Administration website utilizing the NAICS code 623110 (Nursing Care Facilities (Skilled Nursing Facilities)) for Commerce City returned one (1) vendor, Woodridge Terrace Nursing and Rehabilitation. A search through VetBiz failed to produce any results for Commerce City, CO. As a result; it was determined that Woodridge Terrace Nursing and Rehabilitation is the only firm capable of providing the CNH services in short notice. The Woodridge Terrace Nursing and Rehabilitation current agreement (VA259-12-A-0035) ends on October 31, 2017, the Government current has sixteen (16) patients in this Nursing Home which cannot be moved before October 31, 2017.
- 9. Any Other Facts Supporting the Use of Other than Full and Open Competition:** This is a interim Agreement for five (5) months, an RFQ will be posted on FBO for Full and Open, the request is being processed. There are currently sixteen (16) patients in the nursing home.
- 10. Listing of Sources that Expressed, in Writing, an Interest in the Acquisition:** No one has expressed written interest in this Acquisition.

**11. A Statement of the Actions, if any, the Agency May Take to Remove or Overcome any Barriers to Competition before Making subsequent acquisitions for the supplies or services required:**

While there are currently only three facilities capable of providing the mental health specialty care required for the patients, the contracting office will continue to seek new sources in the future.
