Ventilators shall be rented on a monthly schedule that includes delivery, installation, training, servicing and maintenance, and recovery of in-home ventilators within a 300 mile (round-trip) radius from the Sioux Falls VAMC. B.2 DESCRIPTION OF REQUIREMENT AND SPECIFICATIONS

INVASIVE AND NON-INVASIVE VENTILATOR SPECIFICATIONS

1. **DESCRIPTION:** The Sioux Falls Veterans Affairs Medical Center (VAMC) has the recurring need for the delivery, install, training, servicing and maintaining, and recovery of Philips Respironics Trilogy 100 or other acceptable and approved ventilators for in-home patients. This requires the Contractor to have qualified personnel and acceptable supplies onsite and within the geographic coverage area of South Dakota, North Dakota, Minnesota, Iowa and Nebraska. The geographic area of the Sioux Falls VAMC consists predominately of patients within a 100-mile radius of Sioux Falls, SD. However, orders will require travel and performance outside of this 100-mile radius.

2. **TECHNICAL REQUIREMENTS:** The Contractor shall be a Home Medical Service (HMS) and/or Durable Medical Equipment (DME) provider with trained staff and access and ability to delivery, install, train, service and maintain, and recover in-home patient ventilation. The Contractor shall maintain a Philips Respironics Trilogy 100 (single unit) or other accepted and approved substitution ventilator in working condition at the patient's location. The contractor shall have on staff a Licensed Respiratory Therapist, a 24-hour help and service desk, and process of tracking all orders, deliveries, patient training, service and maintenance calls, and recovery of equipment. All expendable and consumable supplies and parts shall be provided with the ventilators as part of the rental agreement. The Philips Respironics Trilogy 100 ventilator rental shall include an operational heater with all necessary supplies and equipment. Any ventilator substitutions that require or have the option for a heater shall also be provided in the monthly rental of the ventilator. Misuse, negligence or loss of supplies and equipment will be processed as a Claim under this contract.

4. **VENTILATOR SPECIFICATIONS:** The Sioux Falls VAMC clinical staff has determined the Philips Respironics Trilogy 100 to be technically acceptable and provided for patient in-home ventilation based on current individual patient's medical condition. All substitutions require clinical technical evaluation and Contracting Officers approval through processing of a modification to add or modify authorized ventilation products and equipment. Possible brand name substitutions are listed below:

B.3 STATEMENT OF WORK

1. **Facility Accreditation:** The contractor shall be accredited by an agency recognized by the U.S. Government for respiratory therapy services including extensive Home Mechanical Ventilation (HMV) experience, or meet accredited agency standards and maintain that accreditation or standards. If at any time the contractor is denied said agency accreditation or receives conditional accreditation or does not meet the accreditation agencies standards, the VA must receive immediate notification in writing citing the follow-up actions. If the accrediting agencies accreditation or standards cannot be met, the VA reserves the right to terminate the contract.

2. **Non-personal Healthcare Services Contract:** The service portion of this contract is a non-personal health care services contract in which the personnel rendering the services are not subject, either by the contract terms or by the manner of its administration, to the supervision and control usually prevailing in relationship between the Government and its employees. The Government will evaluate the quality of professional and administrative services provided, but retains no control over the medical and professional aspects of the services rendered. The Contractor shall be fully responsible for the actions of its employees and shall indemnify the Government for any liability producing act or omission by the contractor, its employees, and agents occurring during contract performance.

3. **Forms and Reports:** The VA will determine acceptability of contractor forms and reports. If determined unacceptable, the VA will provide the Contractor with appropriate forms and reports for documentation of services provided to VA beneficiaries.

4. **Contractor Schedule:** The Contractor *Licensed Respiratory Therapist (LRT)* and/or authorized delivery staff shall be contacted within 24 hours of receipt of a new order. An appointment for service will be scheduled within 24 hours of request unless otherwise requested by the COR or Beneficiary. If service will be delayed more than 3 working days, the COR shall be contacted immediately with status of order and reason for delay.

5. **Phase-in Requirements:** The Contractor agrees to a maximum sixty (60) day transition period from the date the contract is awarded for the transferring of all services and supplies to VA beneficiaries. The Contractor shall coordinate transition efforts with the incumbent Contractor and VA. (See FAR 52.237-3, Continuity of Services). Transition date of each beneficiary shall be noted and billing period shall commence on that day.

6. **Phase-out Requirements:** The contractor recognizes that the services being provided under this contract are vital and must be continued uninterrupted if the Government elects not to exercise its option to extend the term of this contract or at contract expiration. The contractor shall not remove any equipment from the beneficiary's residence until replacement equipment has been installed. If additional phase-in/phase-out time is required beyond contract expirations in accordance with FAR 52.237-3 the contractor will be paid on a prorated basis at the prices established for the last period of performance.

7. **Insurance Requirements:** The contractor agrees to procure and maintain, Workers Compensation and Employer's Public Liability Insurance in

accordance with the laws of the state in which service is provided.

- a. **Public Liability Insurance:** The Contractor shall comply with all applicable Federal and State laws with regard to liability arising or resulting from injury to or death of an employee in performing the work under this contract, and shall save and hold the Government harmless against any or all loss, cost, damage, claim, expense or liability whatsoever, because of accident or injury to persons or property of others occurring during the performance of this contract. All liability coverage shall be kept current throughout the duration of the contract and current certifications provided to the Contracting Officer.
 - b. Before starting work under this contract, the Contracting Officer shall require the Contractor to furnish a certification from his insurance company that the coverage outlined in paragraphs (a) and (b) has been obtained, and that it may not be changed or canceled without written notice to the Contracting Officer.
8. **Beneficiary Lists:** Beneficiary lists, no matter how developed, shall be treated as CONFIDENTIAL information. Lists and/or names of beneficiaries shall NOT be disclosed or revealed for any use outside the VA, without prior written permission of the VA. The VA database listing may NEVER be utilized for solicitation of any kind. Any correspondence to veterans MUST have prior approval and be signed by the Contractor and the VA.
9. **Release of information:** The Contract employee shall only release medical information obtained during the course of this contract to the VA designated employee or staff involved in the care and treatment of that individual beneficiary. All other requests for release of beneficiary information must be handled by the local VA's Release of Information Department.
10. **Policies & Procedures:** The VA will review the policies, procedures, and plans of the contractor to identify and resolve variances. The VA and the contractor shall collaborate to modify the contractor policies, procedures and plans or use those of the VA.
11. **Telephone Numbers:** The Contractor shall provide each beneficiary covered by this contract with the contractor's name, address and telephone number to include numbers to be used during normal business hours and numbers for emergency requests during non-business hours. Contractor shall have a Toll free contact number for patients.
12. **Payment/Invoicing:** The Contractor shall submit to the Prosthetics COR a

properly completed individual, itemized invoice, in accordance with FAR clause 52.212-4 (g), "Contract Terms and Conditions Commercial Items," for services authorized for each VA beneficiary, no later than the 10th workday of each month after completion of service. The following information shall be contained on all invoices:

- (1) Contractor Name
- (2) VA facility name that services were provided for
- (3) VA beneficiary's name and last four digits of social security number
- (4) Itemized type(s) of services provided
- (5) Serial number of each piece of equipment
- (6) Itemized list of equipment rental cost, labor costs, and travel expenses
- (7) Contract Number

Originals or readable copies of a signed and dated Contractor Invoice or Delivery Ticket shall also accompany each invoice. Each ticket must be signed by the beneficiary or caregiver and, at a minimum, contain the following:

- (a) Time and date contractor was contacted to make delivery
- (b) Time and date of delivery
- (c) Beneficiary's name and address
- (d) Itemized list of all items delivered or services performed
- (e) Name of contractor's staff performing delivery or service
- (f) All instructions given to the beneficiary/caregiver

Specific Equipment Beneficiary Education" (initial setup only)

14. **Contractor Responsibilities:** As prescribed by licensed and privileged VA personnel, the Contractor's Licensed Respiratory Therapist (LRT) or other qualified and approved contractor staff shall perform the following:

(1) Perform home visits by trained and suitable staff for the delivery, installation, training, service and maintenance, and recovery of Contractor owned ventilator equipment.

(2) Ensure a Philips Respironics Trilogy 100 (single unit) or other accepted and approved substitution ventilator is fully operational and at all times with the patient. Equipment for service, maintenance, or repairs will be reported to the Home Respiratory Care Coordinator or Clinical COR and replaced within 24 hours from when the equipment was identified as needing replacement.

(3) Provide documentation of all home visits to Home Respiratory Care Coordinator or Clinical COR within three (3) days of visit.

(4) Provide thorough education to patient and caregiver in proper ventilator usage, ventilator function and operation including control knobs, power sources, adding oxygen, troubleshooting the ventilator and alarms, the remote alarm, checking tidal volume, ventilator tubing change, talking devices, cleaning of tubing and humidifier, back pressure with Jackson trach tube (if applicable), bagging with AMBU bag, and supplies consistent with requirements and per manufacturer recommendations.

(5) Provide continuing education/training in ventilator use as needed.

(6) Assess the home environment for safety and suitability for ventilator use and submit a report in writing to the Home Respiratory Care Coordinator or clinical COR about required changes and recommendations.

(7) Participate in determining and setting up vent tray devices attached to wheelchairs to facilitate safe patient mobility.

(8) The Contractor's therapist and staff shall be competent in the use of the PLY 100, LTV 1150, Resmed Astral, Respironics Trilogy 100, or other ventilators as designated by the VA as oxygen delivery, aerosol equipment, tracheotomies, airway care, and suction machines and cough assist devices.

(9) The Contractor shall provide one period of instruction in an individual setting on the proper use and care of Ventilator equipment and supplies. The Contractor's LRT or staff shall provide instructions to the beneficiary and/or caregiver in the safe and appropriate use of equipment including basic home safety, storage, and handling of the involved equipment, required operator maintenance, electrical safety, whom to call in the event of an emergency, etc. Instructions to the beneficiary/caregiver shall include demonstrating the correct use and observing a return demonstration by the beneficiary/caregiver. Documentation of this demonstration shall be signed by beneficiary/caregiver and sent to the VA within (1) one day of delivery or setup of services. This service shall be available Monday through Friday during the contractor's normal business hours except for National Holidays listed below.

(3) The compensation (wage and fringe benefits) plan for all service employees performing work under the contract are the same as that used for these employees and equivalent employees servicing the same equipment of commercial customers.

(b) Certification by the offeror as to its compliance with respect to the contract also constitutes its certification as to compliance by its subcontractor if it subcontracts out the exempt services. The Contractor agrees to perform, or have performed, work on the contract up to the point at which the total amount paid and payable by the Government under the contract approximates but does not exceed the total amount actually allotted by the Government to the contract.

(c) The Contractor shall notify the Contracting Officer in writing whenever it has reason to believe that the costs it expects to incur under this contract in the next 60 days, when added to all costs previously incurred, will exceed 75 percent of (1) the total amount so far allotted to the contract by the Government or, (2) if this is a cost-sharing contract, the amount then allotted to the contract by the Government plus the Contractor's corresponding share. The notice shall state the estimated amount of additional funds required to continue performance for the period specified in the Schedule.

(d) Sixty days before the end of the period specified in the Schedule, the Contractor shall notify the Contracting Officer in writing of the estimated amount of additional funds, if any, required to continue timely performance under the contract or for any further period specified in the Schedule or otherwise agreed upon, and when the funds will be required.

(e) If, after notification, additional funds are not allotted by the end of the period specified in the Schedule or another agreed-upon date, upon the Contractor's written request the Contracting Officer will terminate this contract on that date in accordance with the provisions of the Termination clause of this contract. If the Contractor estimates that the funds available will allow it to continue to discharge its obligations beyond that date, it may specify a later date in its request, and the Contracting Officer may terminate this contract on that later date.

If this is a cost-sharing contract, the increase shall be allocated in accordance with the formula specified in the Schedule.

(h) No notice, communication, or representation in any form other than that specified in paragraph (f)(2) of this clause, or from any person other than the Contracting Officer, shall affect the amount allotted by the Government to this contract. In the absence of the specified notice, the Government is not obligated to reimburse the Contractor for any costs in excess of the total amount allotted by the Government to this contract, whether incurred during the course of the contract or as a result of termination.

(i) When and to the extent that the amount allotted by the Government to the contract is increased, any costs the Contractor incurs before the increase that are in excess of—

(1) The amount previously allotted by the Government or;

(2) If this is a cost-sharing contract, the amount previously allotted by the Government to the contract plus the Contractor's corresponding share, shall be allowable to the same extent as if incurred afterward, unless the Contracting Officer issues a termination or other notice and directs that the increase is solely to cover termination or other specified expenses.

(j) Change orders shall not be considered an authorization to exceed the amount allotted by the Government specified in the Schedule, unless they contain a statement increasing the amount allotted.

(k) Nothing in this clause shall affect the right of the Government to terminate this contract. If this contract is terminated, the Government and the Contractor shall negotiate an equitable distribution of all property produced or purchased under the contract, based upon the share of costs incurred by each.

(l) If the Government does not allot sufficient funds to allow completion of the work, the Contractor is entitled to a percentage of the fee specified in the Schedule equalling the percentage of completion of the work contemplated by this contract.

(End of Clause)

C.7 52.237-3 CONTINUITY OF SERVICES (JAN 1991)

(a) The Contractor recognizes that the services under this contract are vital to the Government and must be continued without interruption and that, upon contract expiration, a successor, either the Government or another contractor, may continue them. The Contractor agrees to (1) furnish phase-in training and (2) exercise its best efforts and cooperation to effect an orderly and efficient transition to a successor.

(b) The Contractor shall, upon the Contracting Officer's written notice, (1) furnish phase-in, phase-out services for up to 90 days after this contract expires and (2) negotiate in good faith a plan with a successor to determine the nature and extent of phase-in, phase-out services required. The plan shall specify a training program and a date for transferring responsibilities for each division of work described in the plan, and shall be subject to the Contracting Officer's approval. The Contractor shall provide sufficient

experienced personnel during the phase-in, phase-out period to ensure that the services called for by this contract are maintained at the required level of proficiency.

(c) The Contractor shall allow as many personnel as practicable to remain on the job to help the successor maintain the continuity and consistency of the services required by this contract. The Contractor also shall disclose necessary personnel records and allow the successor to conduct on-site interviews with these employees. If selected employees are agreeable to the change, the Contractor shall release them at a mutually agreeable date and negotiate transfer of their earned fringe benefits to the successor.

(d) The Contractor shall be reimbursed for all reasonable phase-in, phase-out costs (i.e., costs incurred within the agreed period after contract expiration that result from phase-in, phase-out operations) and a fee (profit) not to exceed a pro rata portion of the fee (profit) under this contract.

(End of Clause)

C.8 52.246-20 WARRANTY OF SERVICES (MAY 2001)

(a) *Definition.* "Acceptance," as used in this clause, means the act of an authorized representative of the Government by which the Government assumes for itself, or as an agent of another, ownership of existing and identified supplies, or approves specific services, as partial or complete performance of the contract.

(b) Notwithstanding inspection and acceptance by the Government or any provision concerning the conclusiveness thereof, the Contractor warrants that all services performed under this contract will, at the time of acceptance, be free from defects in workmanship and conform to the requirements of this contract. The Contracting Officer shall give written notice of any defect or nonconformance to the Contractor within 24 hours of incident being discovered. This notice shall state either (1) that the Contractor shall correct or reperform any defective or nonconforming services, or (2) that the Government does not require correction or reperformance.

(c) If the Contractor is required to correct or reperform, it shall be at no cost to the Government, and any services corrected or reperformed by the Contractor shall be subject to this clause to the same extent as work initially performed. If the Contractor fails or refuses to correct or reperform, the Contracting Officer may, by contract or otherwise, correct or replace with similar services and charge to the Contractor the cost occasioned to the Government thereby, or make an equitable adjustment in the contract price.

(d) If the Government does not require correction or reperformance, the Contracting Officer shall make an equitable adjustment in the contract price.

SECTION E - SOLICITATION PROVISIONS

- (9) Acknowledgment of Solicitation Amendments;
- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
- (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) *Period for acceptance of offers.* The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

(d) *Product samples.* When required by the solicitation, product samples shall be submitted at or prior to the time specified for receipt of offers. Unless otherwise specified in this solicitation, these samples shall

be submitted at no expense to the Government, and returned at the sender's request and expense, unless they are destroyed during preaward testing.

(e) *Multiple offers.* Offerors are encouraged to submit multiple offers presenting alternative terms and conditions, including alternative line items (provided that the alternative line items are consistent with subpart 4.10 of the Federal Acquisition Regulation), or alternative commercial items for satisfying the requirements of this solicitation. Each offer submitted will be evaluated separately.

(f) Late submissions, modifications, revisions, and withdrawals of offers.

(1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and—

(A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or

(B) There is acceptable evidence to establish that it was received at the Government installation designated for receipt of offers and was under the Government's control prior to the time set for receipt of offers; or

(C) If this solicitation is a request for proposals, it was the only proposal received.

(ii) However, a late modification of an otherwise successful offer, that makes its terms more favorable to the Government, will be considered at any time it is received and may be accepted.

(3) Acceptable evidence to establish the time of receipt at the Government installation includes the time/date stamp of that installation on the offer wrapper, other documentary evidence of receipt maintained by the installation, or oral testimony or statements of Government personnel.

E.3 52.212-2 EVALUATION—COMMERCIAL ITEMS (OCT 2014)

It automatically qualifies as a women-owned small business eligible under the WOSB Program.

- (9) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974.
- (10) The Family and Medical Leave Act.
- (11) Title VII of the Civil Rights Act of 1964.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;
- (4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;
- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

“Sensitive technology”—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—
 - (i) To restrict the free flow of unbiased information in Iran; or
 - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

Service-disabled veteran-owned small business concern—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

Small business concern means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

Small disadvantaged business concern, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

(1) Is at least 51 percent unconditionally and directly owned (as defined at 13 CFR 124.105) by—

(i) One or more socially disadvantaged (as defined at 13 CFR 124.103) and economically disadvantaged (as defined at 13 CFR 124.104) individuals who are citizens of the United States; and

(1) Directly by a parent corporation; or

(2) Through another subsidiary of a parent corporation.

Successor means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

Veteran-owned small business concern means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(2) The management and daily business operations of which are controlled by one or more veterans.

Women-owned business concern means a concern which is at least 51 percent owned by one or more women; or in the case of any publicly owned business, at least 51 percent of its stock is owned by one or more women; and whose management and daily business operations are controlled by one or more women.

Women-owned small business concern means a small business concern—

(1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and

(2) Whose management and daily business operations are controlled by one or more women.

Women-owned small business (WOSB) concern eligible under the WOSB Program (in accordance with 13 CFR part 127), means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.

Note to paragraph (a): By a court order issued on October 24, 2016, the following definitions in this paragraph (a) are enjoined indefinitely as of the date of the order: “Administrative merits determination”, “Arbitral award or decision”, paragraph (2) of “Civil judgment”, “DOL Guidance”, “Enforcement agency”, “Labor compliance agreement”, “Labor laws”, and “Labor law decision”. The enjoined definitions will become effective immediately if the court terminates the injunction. At that time, DoD, GSA, and NASA will publish a document in the **Federal Register** advising the public of the termination of the injunction.
