

JUSTIFICATION FOR SINGLE SOURCE AWARDS IAW [FAR 13.106-1](#)
 (OVER MICRO-PURCHASE THRESHOLD(\$3.5K) BUT NOT EXCEEDING THE SAT (\$150K))

IAW [FAR13.104](#), COs must promote competition to the maximum extent practicable to obtain supplies and services from the source whose offer is the most advantageous to the Government, considering the administrative cost of the purchase. When competition is not practicable, IAW [FAR13.106-1\(b\)](#), COs solicit from a single source for purchases not exceeding the simplified acquisition threshold. COs may solicit from one source if the CO determines that the circumstances of the contract action deem only one source reasonably available (e.g., urgency, exclusive licensing agreements, brand-name or industrial mobilization). 2. BRIEF DESCRIPTION OF SUPPLIES OR SERVICES REQUIRED AND THE INTENDED USE:
 This product, the Guldmann GH2HD Ceiling Lift, is the only product that has: is compatible with our current ceiling lifts and slings. In addition Guldmann offers slings types for purposes such as the amputee, turning, limb, and repositioning slings.

3. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:
 Each ceiling lift company uses proprietary slings and accessories that are not compatible with other ceiling lifts. Introduction of a new ceiling lift model would require purchase of additional slings and would create confusion amongst staff using the equipment. This possible confusion is a patient safety issue as the user may try and use alternative sling not designed for the lift system. It is necessary to match existing standardized products. This componentry can be field modified or adjusted to meet the demands of the work flow or equipment and occupational safety. These changes or adjustments are easy and can be quickly accomplished. The ability to adjust or modify these units expedites maintenance, repairs, easy reconfigurations, moves, changes in components or storage requirements.

4. DESCRIPTION OF MARKET RESEARCH CONDUCTED AND RESULTS OR STATEMENT WHY IT WAS NOT CONDUCTED:
 We investigated the Arjo MaxiSky and Liko Likorail products and found that we could not use the same slings as we currently own on these devices. In addition, Arjo does not offer the specialized slings. Furthermore, investigating pricing revealed Guldmann was the lowest price.
