B.3 STATEMENT OF WORK

A. GENERAL INFORMATION

1. Need: Contractor shall provide the following fuel types on an “as needed” basis: Heating Oil, Propane, Diesel On-Road, Diesel Off-Road, and 87 Octane gasolines to the Coatesville and Lebanon VA Medical Centers. The period of performance is twelve (12) months from contract effective date.

2. **Background:** The contractor shall provide all resources necessary to accomplish the deliverables described in this Statement of Need (SON), except as may otherwise be specified. Contractor shall provide fuel delivery on an “as needed” basis for the Coatesville and Lebanon VA Medical Centers. Fuel delivery may be required within 48 hours, depending on the situation, so contractor must be able to respond when needed. Below is the tank information for each facility:

Coatesville

- Unleaded gasoline tank: double wall steel tanks – 1,000 gallon capacity, above ground
- Diesel Fuel tank: 1,500 gallon capacity, below ground

Lebanon

- All fuel tanks listed are below ground.
- Seven (7) Diesel Fuel tanks ranging in capacity from 1,500 gallons to 13, 000 gallons.
- Two (2) Unleaded Gasoline with a capacity of 1,500 gallons each.

B. GENERAL REQUIREMENTS

1. **DELIVERIES:** The Contracting Officer intends use designated personnel – Contracting Officer Representatives (COR’s) to place calls for deliveries against this contract. Ordering officers will be authorized to place orders against this contract. The Contracting Officer will furnish the Contractor with the names of individuals authorized as CORs for each station, by separate memorandum upon issuance of the contract. COR’s responsible for executing a call for deliveries and administering the delivery and acceptance for deliveries under this contract.

NOTE: COR’s have no authority to modify any term of this basic contract. Any deviation from the terms of the basic contract must be approved in writing by the Contracting Officer responsible for this contract. The Contractor shall accept orders against this contract only from the Contracting Officer and/or authorized COR’s. Fulfilling orders from persons other than the Contracting Officer or COR will be deemed “at risk” performance and will result in delay in payment for deliveries provided under such orders.”

- a. Fuel shall be delivered on both a routine, and an occasional emergency basis, to the following locations:

Coatesville VA Medical Center, 1400 Blackhorse Hill Rd., Coatesville, PA 19320

Lebanon VA Medical Center, 1700 S. Lincoln Hwy, Lebanon, PA 17042

- b. Pricing, shall be quoted as a firm fixed price per gallon, surcharge based on the regional average rack price, using the most current date. Separate pricing shall be provided for deliveries within normal business hours and deliveries outside of normal business hours labeled as “After Hours Delivery/Emergency pricing”.
 - c. Deliveries may be required as frequently as once per day for extended periods depending on availability of fuel supply.
 - d. Routine delivery calls maybe made at any time during the Contractor’s stated normal business hours. Routine deliveries will be made between 8:00 am and 4:00pm, Monday thru Friday. Contractor shall deliver fuel within 48 hours after receiving notification for fuel order from an authorized COR.
 - i. COATESVILLE VMAC: Mark Barnett or William Strong
 - ii. LEBANON VAMC: Raymond Reibsane
 - e. Emergency delivery calls maybe made 24 hours/day, 7days/week; ergo, the contractor must provide a contact for delivery calls outside of their normal operating hours and be able to complete an emergency delivery within 24 hours from date/time of call.
 - f. **LATE DELIVERIES:** Regular deliveries not completed within 48 hours (72 hours if delayed is excused by Contracting Officer or COR at the time of the delivery call.) may be subject to a discount of 10% of the invoice. Emergency deliveries must be made completed within 24 hours without exception.
2. **CONTRACTOR ONSITE RECEIVING TANK:** If the contractor provides an onsite receiving tank, the contractor’s tank shall include a 12 volt electrical powered pump, battery, means for customer to gauge fuel level, adequate hose (approximately 20 feet) and fill nozzle to service construction and fleet equipment.
3. **DELIVERY TRUCKS:** Each delivery truck servicing this site must be equipped with a fuel oil spill kit appropriate for the size of the delivery. The Contractor is responsible for cleaning all spills that occur during delivery process.

4. **TITLE V REQUIREMENTS:** The Contractor shall comply with all applicable local, state and federal requirements and be able to meet all Title V requirements

C. **PERIOD OF PERFORMANCE:** 1 December 2017 – 30 November 2018

D. **WORK HOURS: GOVERNMENT HOLIDAYS**

1. Deliveries will be coordinated with the COR.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the

L. 113-235) and its successor provisions in subsequent appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.
