

**JUSTIFICATION FOR SINGLE SOURCE AWARDS IAW [FAR 13.106-1](#)**  
(OVER MICRO-PURCHASE THRESHOLD(\$3.5K) BUT NOT EXCEEDING THE SAT (\$150K))

IAW [FAR13.104](#), COs must promote competition to the maximum extent practicable to obtain supplies and services from the source whose offer is the most advantageous to the Government, considering the administrative cost of the purchase. When competition is not practicable, IAW [FAR13.106-1\(b\)](#), COs solicit from a single source for purchases not exceeding the simplified acquisition threshold. COs may solicit from one source if the CO determines that the circumstances of the contract action deem only one source reasonably available (e.g., urgency, exclusive licensing agreements, brand-name or industrial mobilization). TIMS DICOM System (TIMS 2000 SP Mobile Cart Package) is manufactured and distributed exclusively by TIMS Medical a division of Foresight Imaging. TIMS is the only solution for this application that records at the native resolution of the modality, providing the highest quality images for accuracy. TIMS is the only device to provide the proprietary software (TDRS) for workflow efficiency and protection of patient information when needing to send, process (edit), and/or transfer for archiving purposes. TIMS is the only solution to maintain the highest quality images while compressing files/data for management within any archiving source (VNR, VISTA, PACS).

The TIMS equipment will be integrating with current equipment. Equipment is guaranteed to be compatible.

**4. DESCRIPTION OF MARKET RESEARCH CONDUCTED AND RESULTS OR STATEMENT WHY IT WAS NOT CONDUCTED:**

VIP search was conducted using the search criteria of NAICS Code: 339112, the search resulted in 246 matches. A second search was conducted using the search criteria of NAICS Code: 339112 and the Keyword: TIMS, the search resulted no vendor matches.

The NMR does not apply to this procurement, as the IGCE is less than \$150,000.00, therefore a set aside will be pursued.
