

1. **Contracting Activity:** Department of Veterans Affairs, VISN 22, 4811 Airport Plaza Drive. Suite 600. Long Beach, Ca. 90815.

2. **Brief Description of Supplies/ Services required and the intended use/Estimated Amount:** The Long Beach VA Medical Center has an Emergent, Unusual, and Compelling need for a one-time purchase to replace the Steam Regulator located in Bldg. 126 of the Medical Center. The Steam Regulator is considered critical hospital equipment that must remain fully functional in the medical center. Initial Market Research returned 1 Small Business that could meet the need of this emergency request in the time required. The estimated amount for this request is \$12,712.00
3. **Unique characteristics that limit availability to only one source, with the reason no other supplies or services can be used:** This is an emergency request to replace the Steam Regulator located in Bldg. 126 at VA Long Beach. The parts required include: 1 (one) 6" Pressure reducing Valve, 2 (two) Pilots Pressure Valves, 1 (one) 2-1/2" Pressure reducing Valve, and 1 (one) Maintenance Diaphragm Kit for the 6" valve. Initial Market Research returned 1 local small business that could provide these items in the time required to mitigate risk of adverse patient care. In accordance with Statutory Authority Permitting Other than Full and Open Competition: Unusual and Compelling Urgency per FAR 6.302-2, this request should be limited to the vendor that can provide these parts in the time required.
4. **Description of market research conducted and results or statement why it was not conducted:** Market Research was conducted under urgent and compelling circumstances and Pacific Mechanical Supply, a small business concern, can meet the need of this emergency request in the time frame required to avoid critical risks at the VA Long Beach Medical Center. Based on the fact that this is an emergency request with an unusual and compelling need it would be in the best interest of the government to procure this emergency one-time buy from Pacific Medical Supply who can meet this critical need in the time required.
5. **Contracting Officer's Certification:** *Purchase is approved in accordance with FAR13.106-1(b). I certify that the foregoing justification is accurate and complete to the best of my knowledge and belief.*
